1. Call to Order/Verify Quorum

• Chair Hill called the meeting to order at 6:30 p.m.

2. Approval of the Previous Meeting Summary

Chair Hill inquired if everyone had the opportunity to read the meeting summary and if there
were any corrections, deletions or additions; there were none. George Banks made a motion
to approve the meeting summary and Jim Aker seconded the motion. The June 2013 meeting
minutes were approved unanimously.

3. Staff Reports

- JSO (Jacksonville Sheriff's Office) not present
 - Mayor's Liaison John Shellhorn
 Mr. Shellhorn introduced himself to the group; he shared his work experience with the group.
 - Duval County Public Schools not present
 - FDOT (Florida Department of Transportation) Jim Green
 Mr. Green informed the group that FDOT has not started any new project and all the current FDOT projects are on schedule.
 - Neighborhoods Department:
 - o **Housing and Community Development Division** Rosemary Wesolowski Ms. Wesolowski informed the group that she is working with Ivan Rodriguez, JTA in regard to getting a JTA bus donated for the use of a SE CPAC Bus Tour. Also, the HOA training has been rescheduled to September. Complete details will be provided in the near future.

o Municipal Code Compliance Division - Robert Crawford

Mr. Crawford stated that we are in the middle of the growing season and this is keeping Code Compliance very busy. Currently, there are 4 officers and one Supervisor in District 3. Even with all the vegetation growth associated with summer, Code Compliance is trying to remain proactive. Code Compliance will conduct a systematic inspection in Windy Hills.

- o Planning & Development Aaron Glick no report, but available for questions.
- Parks & Recreation Not Present
 - 4. Presentations Ashley Smith Juarez, Duval County School District Board member, introduced herself to the group and presented the new Duval County Public Schools' Strategic Plan.

The new Duval County Public Schools' Strategic Plan included updated Vision Statement, Mission Statements and Core Values. They also developed 4 new goals and strategies to achieve those goals:

- 1. Develop Great Educators and Leaders ~To achieve this they plan to provide teachers and students with the tools and resources necessary to meet the demand the Common Core Standards and students' individual needs. Recruit, employ and retain high-quality, diverse teachers, instructional leaders and staff. Provide ongoing professional learning and support to develop all teachers, instructional leaders and staff. To further ensure success in this area they plan bring training to the teachers and focus on professional development. Also, in regard to the Common Core Standards; this is newly adopted in Florida Legislature and will be effective in 2014. This replaces the FCAT and it will allow our educational system to be compared fairly to the educational system in other states.
- 2. Engage Parents, caregivers and Community ~ To achieve this they plan to establish and sustain a culture that is collaborative, transparent, and child-centric. Create a welcoming, respectful, and responsive environment for all stakeholders that leads to open lines of communication. Expand partnerships and ensure alignment between district strategic plan and community, government, non-profit, and business initiatives. Ms. Smith Juarez informed the group that they plan to launch a parent academy (in the fall) to help engage parents, hold community forums/town hall meetings, improve their customer service by adding 904-schools phone line and to collaborate with community agencies to help them in various areas.
- 3. Ensure, Effective, Equitable and Efficient Use of Resources ~ Ensure the use of district funds is transparent, strategic and aligned. Distribute district-wide programs and resources in an equitable manner. Deploy information technology that supports the academic needs of all students, teachers and staff. They have started a budget development process which is new. They have also set a goal to increase the reserve fund to 7%; the state only requires them to have 3% in reserves. They are planning a modification to transportation; they plan to restore Magnet School Transportation and return to bus transportation to 1.5 mile distance instead of the state criteria of 2 miles.
- 4. Develop the Whole Child ~ They plan to facilitate and align effective academic, health and social-emotional services for students based on needs. Address the needs of all students with multiple opportunities for enrichment. Encourage positive behavior, respect towards others and ensure safe environments throughout the school district. Ms. Smith Juarez stated that art, music and physical education will be added back to all schools. They will also establish Deans of Discipline in secondary schools. To further develop the whole child they plan to increase technology access to students (and teachers, have security guards at all elementary schools, strategically expand career & technical education, increase Pre-K offering and offer an anti-bullying hotline (390-CALL).

Chairs report - Chair Hill informed the group that the CPAC is still working with JTA on the bus tour, at this time Mike Goldman from FDOT, Representative from St. Johns Town Center, Driving tour of the Mayo Clinic and Bowden Rail Yard are part of the tour. Additional detail will be provided in the near future.

Elected Officials Reports -

Councilmember Boyer ~ no report

Councilmember Gulliford encouraged the members to stay engaged with City Council.

Subcommittee/Liaison Reports -

LUZ (Land Use and Zoning)/Governmental Affairs- Jim Hill, Subcommittee Chair Mr. Hill stated the LUZ subcommittee discussed a lot of applications; no motions are actions were taken.

Beautification/Parks/Environment - Dick Cardell, Subcommittee Chair

Mr. Cardell stated that he wanted to call our attention the Resident Community News (the free paper in San Marco). There is an article about the meetings they are having about the St. Johns River; in particular to Silver Lake. One of the interesting aspects about the article is that it mentions that there are some people that are talking about giving rivers, plants and trees Citizens right. This is something unique and interesting that we may want to learn more about.

Economic Development - Gloria Stephens, Subcommittee Chair

Ms. Stephens informed the group that it was announced in Jacksonville Business Journal that west coast based Trader Joe's is planning to open a store in the Jacksonville Beach area. Also, it has been documented that trend in new mortgages is shifting from investors to home buyers, this is good for neighborhoods.

Education - George Banks

Mr. Banks stated that School Board Member, Ashley Smith Juarez covered everything. If anyone has any information that would like to hear from the school board, please let George Banks know.

Membership - Kathleen Perera, Subcommittee Chair
