Call to Order

Jim Hill, SE CPAC Chair, called the meeting to order at 6:35 p.m.

Speakers

Wanda Forrest, Long Range Planning Manager, North Florida TPO, provided the group with an overview of the history and background of the North Florida TPO (NFTPO); formerly know as First Coast MPO. NFTPO is an independent regional transportation planning agency for Duval, Nassau, St. Johns and most of Clay counties. Their funding comes from federal grants, state grants, member municipalities and transportation agencies. The goal of the NFTPO is to meet the transportation needs of the region. To meet those needs NFTPO assists with planning, funding and coordination among multiple government agencies, stakeholder groups and the public. Some of the programs / services are: Long Range Transportation Plan (projects to be funded over 20 years), Transportation Improvement Program (provides details for projects up to 5 years), Congestion Management (develop strategies to reduce congestion), Bicycle & Pedestrian Program, Commuter Services Program, Transportation Disadvantaged Program (serving the elderly, physically & economically challenged), Freight Mobility, Intelligent Transportation Systems or ITS (electronic signs, traffic cameras, radio, TV and internet capabilities) and Clean Cities. Furthermore, NFTPO seeks citizen input and provides information through their website, public workshops, newsletters and presentations. The next community meeting will be held on Wednesday, January 28, 2009 from 5:30 -7:30 p.m. at the Regency Square Library. Charles McBurney, State Representative, District 16, updated the group on the severe financial crisis the state of Florida is experiencing. Legislature of the State of Florida convened in Special Session January 5 – 16, 2009 for the sole purpose of considering: legislation making adjustments to fiscal year 2008-2009 appropriations and to prior year appropriations; legislation providing for the redirection of trust fund revenues and balances to the General Revenue Fund; legislation making minor adjustments to existing user fees, not including any fees related to alcoholic beverages, cigarettes, or tobacco products; legislation providing for streamlining and flexibility of educational programs, services, and use of funds; legislation relating to funding the state-required costs under Article V of the Florida Constitution by providing for or making adjustments to fees and fines relating to traffic enforcement and to civil and criminal fees, fines, and penalties; legislation authorizing a pilot program to provide up to \$10 million in small business loans to stimulate investment in Florida's economy; legislation authorizing intergovernmental transfers; and legislation to conform Florida law to such adjustments,

redirections, and authorizations. Committee work will begin in February and at that time the committees will analyze various strategies in effort to make the budget meet all of the state's needs. If you have any questions or concerns, contact Charles at Charles.McBurney@myFloridaHouse.gov.

Jim Green, FDOT: informed the group that the Hart Bridge will be repainted; the project will begin in February. There will be extensive bridge closures to accommodate the painting project throughout the completion in 2011. Complete details of the painting project will be emailed to the group. The Transportation stimulus package that the Federal Government is working on will allow a number of projects to be started and/or completed. It is expected that in the north district of Florida (18 counties) there will be approximately \$300 - 400 million dollars available. All of the projects that will benefit from the stimulus funding will have to be able to start within 120 days, have all permits in place and FDOT own all of the land needed for the project. In Duval County the proposed projects will be SR 9B (new 4 lane road), improvements along Beach Blvd. between Hodges & San Pablo Road and 4 freight rail projects. An update on current roadway projects are: JTB-9A all ramps are open, widening on JTB continues, JTA project at Beach Blvd. and Kernan is almost complete. There will be a couple of big JTA projects: I-95 & JTB and JTB & U.S. 1 (Philips Hwy). For complete details on the JTA projects visit their website www.JTAFLA.com

1) MM-09-02 Minor Modification 09-02 to PUD 1993-1490-E 9971 Baymeadows Road

Applicant seeks to modify landscape standards and parking standards applicable to outparcel developed as Barnett Bank. The existing building will be demolished and rebuilt.

2) PUD 2009-0026 Pablo Bay Auto Care Center PUD

Subject property is currently located in Pablo Bay PUD (1999-757-E). Small Scale Land Use application 2009-25 is currently pending to change the land use designation to (Community General Commercial) CGC. The real estate number is #167069-0700. There is no property address.

Applicant proposes to allow the development of an automated car wash, and oil lube and maintenance facility.

- Rosemary Wesolowski, Housing & Neighborhoods Department: reminded the group of the 2 hour Workshops that are available for all contractors and small construction businesses on City of Jacksonville section 3 and Jacksonville Small Emerging Business (JSEB) employment opportunities. These workshops will be held on January 28th and 29th. Also, there will be an application workshop for those that are interested in participating in The City of Jacksonville's Neighborhood Stabilization Program on January 30th. - Shorty Robbins, Chief of Recreation and Community Programming, presented a copy of the proposed Park Rules changes. Recreation and Community Services worked with JSO to improve the rules that currently exist so the rules can be better enforced by JSO.
