Call to Order/Verify Quorum

Chair Bruce Tyson called the meeting to order at 7:02 p.m.. A quorum was verified by Mary Beth Ridderman, Coordinator, Community Development, Housing and Neighborhoods.

Approval of the Meeting Summary:

Chair Tyson asked for approval of the December summary. A motion was made and seconded to accept the summary. The vote: all in favor.

JSO Report: Lt. Charles Wall introduced Sgt. Bill Nelson. Lt. Wall thanked the CPAC for the opportunity to report and asked for their help in the community because, due to the extreme cold weather, the number of auto thefts is significantly up because residents are leaving their car motors running at homes or at convenience stores and thieves are watching. He stressed the importance of not unattended leaving car motors running. Insurance companies will refuse to pay the claim if the car is stolen. If JSO finds an unattended car running – they will wait and write a citation for the driver. Crime is down across the nation, city and Zone 4. JSO attributes a portion of the decrease to residents who are working to keep their communities safe. In Zone 4, in the past 30 days, calls for service were down but there were increased numbers of robberies to individuals, residential burglaries, with significant increases in auto thefts and auto burglaries. He asked residents to remove or conceal valuables in their cars and keep a permanent record of all identification numbers of valuables such as electronics. Chair Tyson thanked Lt. Wall and Sgt. Nelson for their report.

<u>Introductions and Acknowledgments</u>. Chair Tyson thanked members and guests for attending the meeting. He introduced Alberta Hipps who, in turn, introduced James Wood, the guest speaker.

<u>Guest Speaker</u>: James Wood, CEO of Memorial Hospital, discussed Memorial's proposal for a hospital on Jacksonville's Westside. Three large sites are being considered along Brannan-Field Chaffee Parkway near New World Avenue and on Normandy Boulevard also in the Cecil Field area. The first construction phase would include an 85 bed hospital offering a full range of services, including obstetrical, diagnostic, surgery and emergency services. An adjacent medical office building is also planned. The State Certificate of Need was approved on Dec. 11, 2009 but appeals are expected from other hospitals. At this time, no other hospitals have plans to expand to West Jacksonville. Mr. Woods asked for letters of community support for a hospital in Jacksonville's Westside.
