Call to Order/Verify Quorum

Chair Bruce Tyson called the meeting to order at 7:03 p.m.. A quorum was verified by Mary Beth Ridderman, Coordinator, Community Development, Housing and Neighborhoods.

Approval of the Meeting Summary:

Chair Tyson asked for approval of the November summary. A motion was made and seconded to accept the summary. The vote: all in favor.

JSO Report: Sgt. Feacher reported no murders in Sectors J and L with one murder in Sector K. Robberies increased in Sector K, with no reported increases in J and L. Zone 4 had a decrease in burglaries and vehicle thefts. The largest increase in robberies occurred in Sector K due to a lot of kids violating curfew. He asked residents to call 630-5505 to report juveniles who are out after curfew (Sunday - Thursday 11 p.m.; Friday and Saturday - midnight) and to report juveniles who are seen out of school during school hours. Chair Tyson thanked Sgt. Feacher for his report and expressed the CPAC's appreciation for all JSO officers' hard work in Zone 4. The CPAC followed with a round of applause.

<u>Introductions and Acknowledgments:</u>. Chair Tyson recognized the following guests and thanked them for attending the meeting: Council Member Reginald Brown, Council

Assistant Daphne Colbert, Community Development Division Chief LaCree Carswell and visitor Stephanie Stalvey, owner of Santee Farms/member of N.E. Fl Equestrian Society.

Guest Speaker: City Council Member (CM) Reginald Brown Council Member Brown discussed the problems of juveniles who drop out of school and those who get into trouble during the daytime because of the legal drop out age (16). He asked residents to contact their State Representatives and ask that the legal drop out age be raised to 18 years old. He also asked that residents notify the Duval County School Board that residents want no more out-of-school suspensions and that the State Attorney's Office be contacted to actively pursue parents whose children have dropped out before age 16. CM Brown said he would like to see kids back in school, back on track and into vocational-technical programs. He stressed the importance of calling JSO and the schools if you see juveniles in your neighborhood - or anywhere out of school - during school hours. CM Brown said he was elected to represent District 10, but he supports the entire city. Some of the things he is working on are changing legislation to support Code Enforcement Officers to allow them to inspect vehicles and other items in residents' back yards. He is pushing for beautification at Wilson and Firestone using the tree mitigation fund and he wants it to look like I-295 in Mandarin. He encouraged everyone to participate in the Veterans Day Parade and to help seniors and others access City and State services. CM Brown asked residents to call him at 630-1684 or call his excellent assistant, Daphne Colbert at 630-7231. Chair Tyson thanked Council Member Brown for his visit to the SW CPAC and the group applauded.

<u>Election of Officers:</u> Chair Tyson turned the meeting over the Polly Walker, Nomination Subcommittee Chair and the election was conducted. Chair Tyson and Vice Chair Vernon were unanimously elected to serve another year. Mrs. Walker thanked the officers for their work in 2009 and expressed appreciation for their willingness to serve another year.

<u>Public Comments</u>: Tom Martin commented that a coalition of churches is working to refurbish HabiJax homes near 29th Street in NW Jacksonville. The project is improving the appearance of the entire neighborhood.

Staff Reports and Announcements:

- Mayor's Liaison: LaCree Carswell announced that Wight Greger was absent due to other work requirements. She had no report but said she was available for questions. Chair Tyson said the CPAC was happy to have Ms. Carswell present at the CPAC meeting.
- <u>Council Members' Reports</u>: Council Member Brown was the guest speaker.
- <u>Duval County School Board</u> Vicki Drake reported the DCSB has asked the legislature to increase the drop out age to age 18 but the legislature responded that it would cost too much money. She said a current concern is that the State Attorney's Office does not pursue parents whose children drop out before age 16. The Drop Out Prevention Centers are working well with principals encouraging parents to send kids to the center and they are experiencing good results with the children who do attend.

- <u>Municipal Code Compliance</u> Jorge Garcia reported Zone 4 officers are working on trouble spots created by the real estate market – so many properties are abandoned due to foreclosure proceedings and kids often break into the homes, vandalizing/destroying the inside. The situation is causing blight in some

neighborhoods. He asked that residents call in homes that are abandoned or unsecured. To report concerns or possible code violations, please call 630-CITY (630-2489).
