**(1) Call to Order – 7:04 p.m.**

- Excused were: Mary L. Brown, Ralph J. Malphurs, Sr., and Cindy Rounds.
- Motion and approval of March and April meeting minutes.

**(2) Presentation –**

**Nathan Rezeau, Florida State Parks, Little Talbot Island State Park - “What are you going to do this summer?”** Ralph presented a video presentation on Florida State Parks and a Power Point presentation on parks located within the Jacksonville vicinity. He provided information on the types of parks and activities available and on-line resources to help plan a state parks visit as well as resources for meetings, parties, weddings, etc. such as the Ribault Club. He also disclosed new plans to create a bike/pedestrian trail which will run from Hannah Park at the beach through and to Huguenot Park, continuing on through the Talbot Island State Park system and ending at Amelia Island State Park. Construction will begin in the next month or so.

- **Chairman’s Report** – Cindy Rounds’ history of Lee High School is continued as she was unable to attend the meeting. Carl also recommended everyone make plans to visit the new Equestrian Center. He participated in Scout Blast at the facility and was impressed. The tour will include a stop and activity at the Equestrian Center. A request was made that the bus be wheelchair accessible. Lee Martin gave an update on the state’s plans to address drug paraphernalia sales at local businesses to help curtail the problem. He encouraged everyone to contact his or her legislators on the issue.

- **Economic Development** – Sally Robson reported on the award of the Jacksonville Children’s Commission (JCC) CPAC grants. Grants were awarded to the following organizations: CEW (Children’s Enrichment Workshop – for transportation for students from school to after school workshops), Christ is the Way Community Church, Duval County Council PTA (for vision screening and eye glasses), Family Nurturing Center of Florida, Lake Shore Baptist church Youth Group, Riverside Avenue Christian Church, and Westside Business Leaders Association Charities, Inc.

A meeting is scheduled for May 17<sup>th</sup> with area leaders and businesses to discuss the project. He requests CPAC participation and input on the project.

Lee Martin covered the criteria and asked everyone to bring nominations to the next meeting.

**Consumer Affairs** – Thelma Jackson, Outreach Coordinator, introduced herself and informed the CPAC that she would be periodically presenting information of concern to the CPAC as well as inviting them to contact her regarding their speaker’s bureau and available resources.
