Call to Order/Verify Quorum

Chair Bruce Tyson called the meeting to order at 7:03 p.m. A quorum was verified by Mary Beth Ridderman, Coordinator, Housing and Neighborhoods Department.

Approval of the Meeting Summary:

Chair Tyson asked for approval of the June summary. There was no July meeting. A motion was made and seconded to accept the summary with corrections: scriveners error of meeting dates. The vote: all in favor.

JSO Report: Lt. Spates reported

• The largest numbers of crimes are auto burglaries, primarily because residents leave car doors unlocked and make it easy for thieves. Areas with high number of auto burglaries are Crystal Springs, Purcell Drive, Lamplighter and San Juan near Hugh Edwards Drive. Several burglaries have occurred at General Dollar Stores. A suspect was arrested and admitted to the crimes. Please call 573-3172 for more information.

- A concern was expressed about incidents of armed car jacking on the Westside. Lt. Spates reported no arrests have been made. He suggested residents limit night travel.
- Lt. Spates asked residents to call the Zone 4 office at 573-3165 or 573-3172 with concerns, call 630-0500 for non-emergencies and 911 for emergencies. Chair Tyson thanked Lt. Spates for his report.

<u>Introductions and Acknowledgments:</u>. Chair Tyson welcomed everyone to the meeting and thanked the guests for attending. He acknowledged Alberta Hipps and introduced Council Member John Crescimbeni.

Presentation: Council Member John Crescimbeni presented information about the 2010 budget. For the first time since Consolidation in 1968 a millage increase is needed. A nine percent increase in property tax millage is needed to maintain last year's taxes because last year's valuations slipped. The same rate would result in a 40 million reduction. Alternately, City Council will need to cut 40 million from the budget. Budgets for the city's business units are down from prior years, but overall, the budget is up because budgets of constitutional officers are up. Hot topics are library closure and possible reduction of hours; pensions; naming rights to the stadium, the Jaguars' contract and animal control issues. A lengthy question/ comment and answer session followed the presentation.

Public Comments:

- Kathy Budd reported the Hyde Grove Avenue footbridge is in dangerous condition for joggers, dog walkers or bicyclists. The boards and supporting timbers are rotten. She if frustrated because she has repeatedly reported the condition of this bridge and it was scheduled to be replaced in 2009. She is concerned about children walking to and from school who cross this bridge.
- Gail Harrison announced that her husband, Sam Harrison, is running for Circuit Court Judge. Early voting was today. She has literature available and will be glad to meet with residents.
- Tom Martin said the sidewalks on Argyle Forest Boulevard were no longer ADA accessible but now they are being repaired and he thanked the City.
- Len Burroughs announced a severed pipe was repaired in Murray Hill.
- Alberta Hipps reported the JAA held a good meeting last Monday, The next meeting of the Cecil Field Advisory Committee is November 1 and Hillwood, Cecil Commerce Master Developer, will be the guest speaker. Ms. Hipps thanked the SW CPAC for their support of Hillwood. The proposed West Jacksonville Hospital is scheduled for an administrative hearing in January, 2011. She expressed her appreciation for the CPAC's support of the proposed hospital and for their support on the Internet Café issue.
- Jim Kelly announced the Westside Business Leader's Kick Off of Dollars for Scholars. Tickets are available at no cost to 501c-3 organizations for a 50/50 split of each ticket sold at one dollar per ticket. For more information on tickets, please call Jim Kelly at 742-4903.
- Chuck Mann announced the Friends of the Murray Hill Library now has 850 members. They intend to get back all library hours. A rally is scheduled for Sunday, August 15, 7 p.m. at the Murray Hill Library.

- Adopted a resolution urging the City Council amend bill 2010-353 creating a Victim Assistance Advisory Council Trust Fund to provide that no City funds shall be deposited onto the new trust fund.

- <u>Chair's Report</u> Chair Tyson reported:
 - CPAC chairs met with Mayor John Peyton on July 22. Mayor Peyton expressed his appreciation for the CPACs and CPAC members. He thanked the SW CPAC for their help with the Hillwood project and said the SW CPAC's letter of support helped Hillwood be chosen as the Cecil Commerce Center Master Developer.
 - Old Middleburg Road South is being resurfaced although the Better Jacksonville Plan funded it to be widened. The current width of the road is a safety issue. Old Middleburg Road South is a heavily congested, cut-through road from Argyle, Clay County and other outlying areas. The road has deep ditches with many curves, no sidewalks, no bike lanes and no lighting. Residents must walk or ride bikes in the roadway and motorists are unable to see pedestrians or bicyclists until it is almost too late to avoid hitting them. One area is called "Dead Man's Curve". Repaving instead of widening will only serve to increase speeds, traffic and dangers to pedestrians and bicyclists as well as motorists. He raised the issue of Old

rd Street and Old Middleburg

Road South, which is always congested, but currently the Town Center construction is causing increased congestion and more problems with safety and traffic. Mayor Peyton asked Kerri Stewart to look into the issue.

- During the meeting with the mayor, Chair Tyson also requested CPAC members be provided with identification badges, which will help them when visiting neighborhoods and trying to promote new membership. Mayor Peyton arranged for CPAC members to receive a photo i.d. badge at City Hall. An application packet was provided.
- Volunteers are needed for a welcoming committee to greet members and guests and to help them sign in.

New Business/Old Business -

- Vicki Drake announced the primary election is August 24. She encouraged everyone to get out and vote. Her term ends on November 16, 2010 and she is not seeking re-election.
- Alice Turknett thanked Ms. Drake for her years of service. The CPAC gave a round of applause.

<u>Adjournment -</u> A motion to adjourn was made by Len Burroughs. A second was made by Dewey Walker. The vote: all in favor. Chair Tyson adjourned the meeting at 8:42 p.m.

Developers purchase the homes, renovate them to strict standards including new Energy Star-rated appliances and the homes are sold to qualified homebuyers. Homes are available in the 32206, 32208, 32209, 32244 and 32254 zip codes. Twenty-eight homes have sold so far and there are currently 29 homes remaining to be sold that do not have potential homebuyers. Families and individuals with an adjusted family income of up to 120 percent of the area household median income are eligible to participate. A family of four can earn as much as \$78,000 and qualify for an NSP home with as little as \$500 down and may qualify for purchase assistance.
