Call to Order/Verify Quorum

Chair Bruce Tyson called the meeting to order at 7:05 p.m.. A quorum was verified by Mary Beth Ridderman, Coordinator, Community Development, Housing and Neighborhoods Department.

Approval of the Meeting Summary:

Chair Tyson asked for approval of the January summary. A motion was made and seconded to accept the summary. The vote: all in favor.

JSO Report: Officer Claude Ayoub reported overall, crime is down by 10 percent in Zone 4. Arson, murder is up from none to one and burglaries to vehicles are also up. He asked residents to lock their parked cars and keep valuables out of sight. He reminded everyone to keep a record of property identification numbers because the burglary unit utilizes a database of reported stolen property when they check pawn shops. With proper identification, stolen items are more likely to be returned. Chair Tyson thanked Officer Ayoub for his report and expressed appreciation for JSO's work in Zone 4.

<u>Introductions and Acknowledgments:</u>. Chair Tyson thanked members and guests for attending the meeting and introduced the following guests: Alberta Hipps, Robert Klong, Janelle Robinson, Ambrae Raulerson, Greg Hollea Rachal and Tracy Encarnagon.

<u>Guest Speaker</u>: Chair Tyson introduced Public Defender (PD) Matt Shirk, who presented information about the Public Defender's Office. The office was created in 1963 with Ed Austin appointed as the first Public Defender, followed by Lou Frost and Bill White. The first election was in 2008 with Mr. Shirk the first elected official and the first Republican to hold office. The PD represents indigent persons accused of committing crimes. Last year approximately 72 attorneys served on about 60,000 cases. The average case load is 200 cases or less. Mr. Shirk thanked the CPAC for inviting him and thanked Ms. Ridderman for arranging his visit. He invited residents to tour the Public Defender's Office. Presentation: Chair Tyson introduced Roslyn Mixon-Philips, Mayor's Office and Director of Recreation and Community Services. Ms. Philips introduced Harlan Stallings from the Mayor's Office and Stanford Lugg from the U.S. Census Bureau. Ms. Philips presented information about the 2010 Census. She said the COJ and Census Bureau are working together to have an accurate census. Federal allocations, such as funding for transportation, housing, veteran services and education, are based on census data. The census will be mailed out in February and March - by March 15 every household will have a copy. The census has been simplified, with only 10 questions, mostly on demographics, but it is very important that every person in the home on April 1 is counted. It is most important that residents return the census. If residents fail to return the form, a census worker will visit each home as many as 15 times each, costing approximately \$90 million nationwide for those forms not mailed in. Residents were encouraged to take census posters and literature to share with their neighbors. Ms. Philips thanked the CPAC for the opportunity to speak. Chair Tyson thanked Ms. Philips for the presentation and said the CPAC members are always happy to see her. He thanked Ms. Philips, Mr. Stallings and Mr. Lugg for visiting the CPAC and encouraged CPAC members to fill out and return their census forms.
