## Call to Order/Verify Quorum

Chair Bruce Tyson called the meeting to order at 7 p.m.. A quorum was verified by Mary Beth Ridderman, Coordinator, Community Development, Housing and Neighborhoods.

## **Approval of the Meeting Summary:**

Chair Tyson asked for approval of the February summary. A motion was made and seconded to accept the summary. The vote: all in favor, none opposed.

<u>JSO Report</u>: Sgt. Jackson answered questions from residents: carrying weapons (concealed permit is required), incident in Murray Hill (Sgt. Jackson said he will report next month), status of personal crimes in area of 103<sup>rd</sup> and Old Middleburg Road (fewer incidents reported), burglaries to homes on Old Middleburg Road (Sgt. Jackson said he will follow up), number of burglaries in Springtree (Sgt. Jackson said he will pull crime stats and will follow up with officers). Chair Tyson thanked Sgt. Jackson for his report to the CPAC.

<u>Introductions and Acknowledgments:</u> Chair Tyson introduced Alberta Hipps and thanked her for being present.

**<u>Presentation</u>**: Alberta Hipps and Tom Ingram presented information about Republic

Services, a waste management company interested in providing service at the Trail Ridge Landfill. A question and answer session followed the presentation. Mrs. Hipps thanked the CPAC for the opportunity to present the information and announced she would remain after the meeting to answer any additional questions. The Chair thanked the presenters for their information.

#### **Public Comments**:

- Jim Kelly announced he volunteers with Gleaners Dispatch, a non-profit organization that provides free food to individuals and families in need. He said Mayor John Peyton is scheduled to visit the Ramona Flea Market food distribution site on April 9 at noon. He asked residents to donate canned foods for the soup kitchen. - <u>Planning and Development</u> Andy Hetzel provided a written report to save time during the meeting. He announced Brad Thoburn is now with FDOT and Bill Killingsworth is the interim director. A concern was expressed about planned development and the inadequacy of Old Middleburg Road to handle the existing traffic Mr. Hetzel said he will provide information about the proposed date of road improvements. <u>Jacksonville Journey</u>: Seven child-serving non-profit agencies have been awarded grants totaling \$2,137,500 to expand the TEAM UP after school curriculum to an additional eight elementary schools and seven middle schools in high-risk areas. Collectively, these TEAM UP after school programs will serve an additional 2,850 elementary and middle school children.

Including those funded by The Jacksonville Journey, the Commission's portfolio of after school programs will now include 41 programs operating in school sites, and 23 operating in community-based centers, for a total of 64 after school programs. TEAM UP is free and offered five days a week. The curriculum balances high quality academic instruction by certified teachers with a wide array of enrichment, recreational and cultural activities, including chess, cooking, sewing, dance, athletics, computer programs, leadership activities, dance and music. In addition, the programs promote family literacy efforts and parent involvement activities. The goal is to improve academic achievement, promotion rates and attendance of low-income children at risk of academic failure and poor social/behavioral outcomes. The target population for the programs is students from low-income households (participating in the free and reduced lunch program) and/or academically-challenged students (those scoring below Level 3 on the FCAT).
