Call to Order/Quorum:

Acting Chair Chuck Mann called the meeting to order at 7 p.m.. The Acting Chair recognized Len Burroughs as Parliamentarian. A quorum was verified by Mary Beth Ridderman, Coordinator, Housing and Neighborhoods Department.

Approval of the Meeting Summary:

Acting Chair Mann asked for approval of the August SW CPAC Summary. A motion was made and a second was made to accept the summary. The vote: all in favor. None opposed.

JSO Report: Officer Don Smith reported on a Transient Camp Clean Up Initiative conducted by JSO Zone 4, Sgt. D.E. Smith, Officer W.B. Dees, Officer M.J. Oschner and Correctional Officer R.W. Urban with assistance from Montgomery Correctional Institute inmates. Sqt. Smith mentioned that the inmates maintained positive attitudes although the conditions were hot and filthy. They cleaned up six sites and removed three dump truck loads of debris. Officer Oschner said he plans to talk with Chief Hackney about JSO scheduling regular patrols of the transient camp sites to be sure they don't move back in. He said he plans to obtain brochures to distribute to the transients they contact to provide information about available social services. Mayor's Liaison Wight Greger provided her business card to Officer Oschner and offered to help locate information about COJ services. Member Jean Grimsley expressed her concern about the increased panhandling in Riverside-Avondale - it has become a quality of life issue and creates an unsafe environment for residents. Residents expressed their sincere

appreciation for JSO's work in Zone 4. The number for the Zone 4 Substation is 573-3165. The JSO non-emergency number is 630-0500.

Introductions and Acknowledgments:

• <u>Guest Speaker:</u> Acting Chair Mann introduced Vince Seibold, Environmental Quality Division Chief. Mr. Seibold discussed the Fertilizer and Irrigation Ordinances which were passed in July, 2008 and are now enforceable. At this time, the focus is education and outreach, but repeat offenders will be cited and fined. To report violations, please call 630-CITY. Concerns were expressed by Members Kathy Budd and Jim Ross regarding operating irrigation systems during rainfall and lawn services blowing yard debris into the storm drains – both are violations. Member Jean Grimsley suggested linking mandatory classes to license renewal for lawn and fertilizer services. Other questions were asked and concerns expressed about algae bloom, impact of storms on the water system, effect of bulkheads and using reclaimed water for irrigation. Mr. Seibold provided flyers, which are attached to this summary. Acting Chair Mann commended Mr. Seibold for the informative flyers.

Public Comments:

Acting Chair Chuck Mann introduced Patrick Victor, Principal Engineer for Camp, Dresser and McKee (CDM), Inc. Mr. Victor reported that CDM is the consulting engineer firm on a FEMA and COJ project to update FEMA flood maps. The effort will also update the COJ Stormwater Master Plan, which was last updated in 1992. Newer mapping technology will allow higher quality flood maps. He asked residents to call Marcy Cook at 255-8769 with information about areas that flood. A guest asked about homeowners associations that have applied for the Stormwater Fee Credit. Vince Seibold answered that a new bill will be issued to those that have applied for the credit. Mr. Victor may be reached at 731-7109.

Acting Chair Mann introduced Jennifer Stagg, Coordinator for the COJ Emergency Preparedness Division (EPD). Her division is part of the Jacksonville Fire and Rescue Department. Ms. Stagg stessed that the COJ emergency responders may not be available for up to 72 hours following a disaster and residents need to be prepared to take care of their family members and neighbors. Ms. Stagg presented information about Jacksonville's Citizen Emergency Response Team (CERT). A free course is offered to residents who want to learn how to respond to emergencies following a disaster. The class teaches life-saving skills, disaster preparedness, response to terrorism including bio-terrorism, structural collapse, outdoor search and rescue. The minimum age for a trainnee is 16, with an adult supervisor. There is no upper age limit. Member Jim Ross asked about water purification. Ms. Stagg replied that methods for water purification are taught in the class. CERT brochures were provided. Ms. Stagg may be contacted at 630-7885 or Jstagg@coj.net.

Guest Thomas Martin announced that the water permits for the Collins Road extension from Shindler Road to Old Middleburg Road have been postponed by the St. Johns River Water Management District Board until after their October meeting. He added that he had placed a CARE issue at 630-CITY regarding street flooding but the expected completion date was in October – he felt that is too long. Wight Greger explained that the completion date is pre-set by the system, but it could be completed prior to that date.

Member Charles Kelley introduced guests Olwen Busch and Gary Shook, who are members of the Northeast Florida Equestrian Society (NFES). NFES is in the process of nominating Ms. Busch and Mr. Shook as representatives to the SW CPAC. Mr. Kelley thanked Johnny Carter for his advice and assistance on furthering Mr. Kelley's projects. Mr. Kelley said he has arranged for volunteers to paint an existing pavilion near FCCJ Cecil North/Jacksonville Equestrian Center. Mr. Kelley said Gary Shook volunteered to mow the trails near the pavilion twice this summer. He Mr. Shook will return with his tractor to mow the area around the pavilion after it dries up from the recent rains. Mowing was done at no cost to the COJ.

- Mayor's Liaison: Wight Greger announced she is available for questions or comments. She said she listens closely to residents' concerns, comments and questions. She said she reads the summaries from all six CPACs and follows up on residents' concerns. Her goal is to let residents know the COJ is responsive. Acting Chair Mann said Ms. Greger is doing an outstanding job she doesn't care what size the issue it she followed up to obtain the installation of an additional street light in his neighborhood. The property is owned by Pete Wheeler and he proposes to put boat and r.v. storage at that site. Andy said a new application had been received for a hotel and residential development on sixty acres near Collins and I-295. The hearing is September 25. - FCCJ Cecil North: Paul McNamara reported FCCJ has been approved for an Air Traffic Controller School. A simulator will be operational in the fall of 2008. The school also offers a Commercial Truck Driving Program. They are currently accepting applications for the Fire School, Nursing, IT Management, Supervision/Management and Early Childhood Education. FCCJ is slated to become a state college authorized to issue Bachelors Degrees by the end of 2008 this could result in a name change, but FCCJ plans to retain the identity and logo. The focus will be on adult high school, vocational training, AA/AS Degree Programs, and the Bachelor's Degree Programs. Paul McNamara may be reached at 779-4030.
- Jacksonville Aviation Authority: No representative in attendance. Acting Chair Mann said he would like to have someone from JAA at the meetings at least quarterly. - **FDOT**, Milton Locklear reported parking lanes will be removed from Blanding Boulevard from 103rd Street to Morse Avenue to make way for a bus lane. The street in that area will have curb and gutter from Morse Avenue to Collins Road and the shoulders of the road will be widened. A concern was expressed about parking near the Blanding Flea Market. - Community Safety Subcommittee: Bruce Tyson referred to the list of disaster supplies on Mary Beth Ridderman's report. He advised residents to be prepared, get the items together and store them in a water resistant container. When there is an emergency, Mr. Tyson works at the Emergency Operations Center (EOC) so he is away from home. He said his own family is prepared for emergencies and has an action plan his family will have to proceed without his assistance while he serves other COJ residents.
- Parliamentarian: Opal Burgstiner was excused. Len Burgstiner served as Parliamentarian and reported that using the timer and bell worked very well to keep everyone within time limits.
- ShAdCo Subcommittee: Alice Turknett was excused. Polly Walker announced that the ShAdCo J meetings are at 7 p.m. on the last Thursday of the month and are held at Ortega Methodist Church. Acting Chair Mann and Member Walker thanked Don Ingram for his assistance in securing the ShAdCo J meeting space. Rosanne Vernon was excused. She provided a written report for ShAdCo K: 103 Members attended the ShAdCo K August 4th meeting. The Sept. 8 meeting included a presentation by Victim Services and nominations for the 2009 Chair and Co-Chair. The October meeting is October 6 at 7:00 PM. - Chairman's Report: Acting Chair Mann announced that Chair Ralph Malphurs has begun chemo therapy and is beginning to eat and exercise to increase his strength. Mr. Mann asked members and quests to pray for Chair Malphurs and his family.
- A Nomination Subcommittee was appointed: Bruce Tyson as Subcommittee Chair, Robert Smith, Len Burroughs, Don Ingram and Alice Turknett. The nomination committee will submit a slate of officers at the October 13 meeting. Nominations may also be made from the floor. The election will be held on November 3. The names of those nominated by the nominating committee and those nominated from the floor during the October meeting will be on the November ballot. Space will be provided on the ballot to write in names of other candidates.
- Some concerns have been expressed about having only an Acting Chair and no Acting Vice Chair. In the event the Acting Chair is absent, the Executive Order and By-Laws authorize members to hold an election for a Temporary Acting Chair to run that meeting. Acting Chair Mann appointed Bruce Tyson to run such an election if it should become necessary.

Old Business: None.

New Business: Acting Chair Mann announced:

Fertilizer Ordinance 2008-028



The problem: Fertilizer for turf grass flows to the St. Johns River. The city faces up to \$1 billion in stormwater management costs for nitrogen removal to comply with TMDL for the river.

Homeowners, retailers and commercial applicators must all help solve this problem.

Ordinance 2008-028 when passed will implement the following best management practices (BMPs):

Retail Garden Centers:

- Recommend supervisors attend BMP training
- Follow storage and spill requirements
- Provide literature to customers

Commercial Fertilizer Applicators:

- Follow green industries BMP
- Provide literature to customers

Everyone:

- Clean up fertilizer spills
- Do not apply fertilizer during flood or storm watches
- Do not blow clippings into streets or drainage ditches
- Follow recommended nitrogen application rates

Homeowners:

- Follow Florida Yards and Neighborhoods Program practices
- Phase-in a six foot zone of landscape planting or ground cover which does not require intensive fertilizer, watering and mowing, adjacent to water bodies

What are BMPs?

The State of Florida commissioned and adopted best practices for management of landscape and turf grass to minimize environmental consequences. Those BMPs are published as *Florida Green Industries Guide to Best Management Practices for Protection of Water Resources in Florida.* Those BMPs are highlighted in the ordinance and listed above. Topics addressed in detail in the training include:

- * Environmental issues and protections
- * Plant selection, planting, care
- * Irrigation system design, installation and management
- * Mulching, mowing, pruning
- Fertilization
- * Pest control
- * Safety
- Spill cleanup planning & training

What is the Florida Yards and Neighborhoods program?

This University of Florida
Extension program encourages
homeowners and professionals to
create and maintain Floridafriendly landscapes that protect the
natural environment.

FYN recommendations include:

- * Water efficiently
- * Right plant, right place
- * Fertilize appropriately
- * Mulch
- Protect the waterfront

- * Attract wildlife
- Manage pests responsibly
- * Recycle yard waste
- * Reduce stormwater runoff

Irrigation Ordinance 2008-030

The remedy: Preservation through conservation.



All Duval County residents, businesses and utilities must do their share to save our water supply

Ordinance 2008-030 when passed will implement the following best management practices:

What we know:

- 50% of our groundwater is used for irrigation
- Excess irrigation adds to nitrogen pollution in the St. Johns River
- Wasting water accelerates need for alternative water supply sources



City ordinance will:

- · Enforce own local requirements
- Not apply to Beaches and Baldwin

Approach to achieve compliance:

- Education
- Warning
- Enforcement

City ordinance applies to landscaping regardless whether water comes from private well, utility, and to all customers.

Water Management District Rules apply to:

- Golf courses
- Nurseries
- Ball fields
- · Agricultural crops

2008-030 applies to landscaping around buildings, drives, property boundaries even for facilities listed above.

Year round restrictions:

- Odd address on Wednesday and Saturday
- Even address on Thursday and Sunday
- Non-residential Tuesday and Friday
- Apply ≤½" each watering day



Recommended winter restrictions: December through February

- Odd address Wednesday only
- Even address Thursday only
- Apply ≤¾" one time per week



Exceptions with time limits:

- 24 hours after applying chemicals
- Maintenance and repair of irrigation system (10 minutes per zone)
- New landscape 30 days any time and every other day for 30 additional days

Exceptions – can water any day any time:

- Discharges from air to water heating or cooling units
- Hand-held irrigation using shutoff nozzle
- Micro-irrigation (apply at root)
 Soak / Drip / Small spray heads

Hours apply but days not limited:

- Retention ponds if not augmented from other sources
- · Reclaimed water
- Recycled water (stormwater)

In a major disaster, emergency workers may not be able to reach everyone right away, and in some cases it may take 3 or more days for help to arrive. What would you do if you had no electricity, no gas, no water and no telephone service? Having a plan for your family and their needs will help ensure their safety and comfort during these difficult times.

Disaster Supplies Kit

The following items should be included in a hurricane or disaster kit:

Water

At least one gallon of water per day per person for 3-5 days, two quarts a day for drinking and two quarts for food preparation and sanitation.

Water purification tablets

Food

Enough for 3-5 days.

Non-perishable dry or canned food such as ready-to-eat meats, fruits, vegetables, soups, juices and milk

High energy snack foods such as protein or fruit bars, trail mix, peanut butter and crackers

Comfort foods such as nuts, cookies, sweetened cereals, instant coffee, tea and hard candy

Special dietary and baby foods

Vitamins

Kitchen Supplies

Manual can opener

Eating and cooking utensils, mess kits, plates and cups

Matches or lighters in a waterproof container

Emergency cooking/camping equipment

Liquid detergent and household chlorine bleach

Plastic bucket and lid

Hand sanitize

Ice and cooler

Tools and Supplies

Flashlight and extra batteries

Battery operated AM/FM radio and extra batteries

Toilet paper, soap, personal hygiene items, feminine supplies and toiletries

First aid kit

Mosquito/insect repellant

Special needs items such as prescription medications, eye glasses, contact lens solutions, hearing aid batteries and other personal items

Hat

Extra clothing for one week

Rain gea

Heavy duty plastic garbage bags

Whistle

Specialty items for infants, such as formula, diapers, wipes, bottles and pacifiers, and for elderly relatives and pets

Important documents such as passport, copies of credit cards, identification cards and insurance papers

Other items to meet your unique family needs such as games or books

Blankets and/or sleeping bags

Keys to house

Cash, traveler's checks

Extra charger for cell phone and power cord for laptop computer
