### Call to Order/Quorum:

Chair Ralph Malphurs called the meeting to order. At 7:05 p.m.. A quorum was verified by Mary Beth Ridderman, Coordinator Neighborhood Services Division.

## **Approval of the Meeting Summary:**

Chair Malphurs asked for approval of the April SW CPAC Summary. A motion to accept the summary was made and seconded. The vote: all in favor. None opposed.

#### Introductions/Acknowledgements:

Chair Malphurs acknowledged JSO Lt. T.C. Davis and thanked him for being present. He welcomed guests, Marcus Smith and Sonja Williams and announced two new members, Jim Ross and Kathy Budd.

<u>JSO Report</u>: Lt. T. C. Davis reported the number of robberies are up and he cautioned residents to be careful, particularly in parking lots. He reminded everyone that it is fire season and electricity or other services may not be working. He reminded everyone to get prepared with food and water, the same as for a hurricane. He reported on an apartment complex initiative, which 2 officers to calls at the top five violent apartments – they have made 80 arrests of violent criminals. Chair Malphurs thanked Lt. Davis for his report and for JSO's on-going work in the community. The number for the Zone 4 Substation is 573-3165.

<u>Presentation:</u> Victoria Pennington, with JTA Rapid Transit Authority, presented information about 511, a new, free, national number for traffic information. ## **Public Comments:**

Johnny Carter announced that the Wiley Senior Center recently earned accreditation, one center of 30 center in the state and one of two in the city to earn accreditation. The facility serves 70-80 people each day.

Jean Grimsley reported RAP is planning a conference October 12 – 14. The conference will provide lectures and workshops on historical homes. More information is available at RestoreJacksonville.com.

#### **Reports & Announcements:**

- Chairman's Report: Mr. Malphurs reported:
  - o Seeds of change the mayor's office is working in partnership with postal employees to call in code violations.
  - o Rosyln Phillips, from the mayor's office, called him regarding the proposed state tax reform and its impact on city services. She may ask to schedule a meeting in this area.
  - o He read a Times Union article, *Chop With Care*, that discussed which services may be affected.
  - He suggested residents attend the CommUnverCity classes.
  - o The meeting was held in room G-125 and G-126, with a new conference room style configuration suggested by Robert Smith. The chair asked for a motion to remain in the larger room, E-112, this room or D-120, where the 2006 holiday party was held. There was discussion about remaining in room G-125 and G-126, but no motion to remain in E-112 or G-125/126. A motion was made to move to room D-120 permanently. All were in favor, none opposed. Mary Beth Ridderman said she will check on the availability of room D-120.

- **Duval County School Board**: The Hon. Vicki Drake reported on Teach for America, which recruits top students from across the U.S.. She discussed the Renaissance Program, Tax Relief and the proposed name change of Forrest High School.
  - o **Jacksonville Aviation Authority**:. Rusty Chandler was not present. He had sent an announcement: The Air-Fest is scheduled for May 19, 2007, from 9 a.m. 5 p.m. This is an outreach program for Cecil Field, the day will offer poker runs for cars, planes and bikes, along with static displays to benefit the NE Chapter of Multiple Sclerosis.
- Grants Subcommittee: No report. Volunteers are needed.
- Education/Youth and Recreation Subcommittee: Chuck Mann reported the Renaissance Academy offers classes to children in grades 4 -12 who have failed twice. The program works to get kids back into the system. He asked that people get involved through mentoring.
