Call to Order/Quorum:

Chair Ralph Malphurs called the meeting to order at 7:10 p.m.. A quorum was verified by Mary Beth Ridderman, Coordinator, Neighborhood Services Division.

Approval of the Meeting Summary:

Chair Malphurs asked for approval of the August SW CPAC Summary. A motion was made and properly seconded to accept the summary. The vote: all in favor. None opposed.

Introductions/Acknowledgements:

Chair Malphurs welcomed everyone to the meeting and acknowledged the UNF Nursing students, Amanda Campbell, Kathleen Camancho and Brian Curtis. He recognized Alberta Hipps and JSO Lt. R.A. Norse. Mrs. Hipps thanked everyone for their support of Charles McBurney, candidate for the Florida House of Representatives, District 16. Chair Malphurs introduced Paul McNamara, FCCJ Cecil Center North and asked Mr. McNamara to discuss FCCJ Cecil Center North.

Paul McNamara, Guest:

Mr. McNamara reported students begin classes at FCCJ Cecil Center North on Sept. 24. He invited everyone to the open house on Sept. 11, and the dedication on Oct. 8. FCCJ Cecil Center is hosting the Westside Tour on Sept. 28 - that will give everyone an opportunity to see the new campus.

JSO Report:

Lt. R.A. Norse reported no change in the numbers of home invasions. Robberies to individuals and carjacking were down. Burglaries to businesses were down but burglaries to residences and to conveyance were up. Robberies to businesses were up. He said the simplest thing to prevent

burglaries to autos is to lock car (95% of those burglarized were unlocked or had no sign of forced entry). He suggested residents lock doors on houses, vehicles and businesses and not leave valuables – or even cell phone chargers - in plain sight in vehicles. The number for the Zone 4 Substation is 573-3165.

Presentation: Jocelyn Turner, Duval County Health Department (DCHD), discussed the Health Department's Strategic Plan, and she provided brochures, including the Strategic Plan Summary 2007-2010. She discussed goals outlined in the plan and related services such as providing birth/death certificates, prevention and intervention for certain chronic diseases, health care and screening to jail inmates, and health services to children from birth to age 20 years. She discussed the Agape Health Center which is a federally funded center that provides health services on a sliding scale. Many DCHD programs are grant-funded. <u>Action Item:</u> The slate of officers was presented by the nominating committee. Ralph Malphurs and Charles Mann were nominated to serve another year. Mr. Malphurs announced that nominations may be made from the floor on November 5.

- Chairman's Report: Chair Ralph Malphurs reported he organized a meeting of the CPAC Chairs and Vice Chairs with Council President Daniel Davis to discuss the CPACs concerns about reduction in the six coordinators' positions who provide administrative assistance to the CPACs. The proposed staffing is three CPACs per one staff person. Mr. Malphurs reported he also met with Mayor John Peyton about the same issue and the mayor commended him for the work the CPACs were doing to maintain staff coverage. Mr. Malphurs sent letters to the Council Members, Chairs and Vice Chairs. He and Vice Chair Mann attended the Finance Committee meetings and Mr. Mann spoke at one meeting regarding the CPACs' concerns about adequate staff support for CPAC duties. As a result, the Council voted to fund a third position each coordinator will have two CPACs. Chair Malphurs explained that tonight Chuck Mann is the guest speaker at the ShAdCo K meeting, presenting information about CPACs and recruiting new members.
