Special Workshop - "Community Centers and Their Availability"

On the Panel were:

- Department of Parks & Recreation: Bob Baughman, Director, Denise Ostertag, Chief of Recreation Activities
- Community Services: Dr. Delphia Williams, Director, Marilynn Stevenson, Chief of Adult Services and Larry Dixon, Program Manager
- Office of General Counsel: Tim Franklin

Each panelist presented information on how their services were offered to the community. Members spoke very highly on being able to access Lincoln Villas Community Center. Lists were distributed that had the Adult Services Community Centers that are used by senior citizens and the Parks Department Community Centers that are primarily used by the youth. Community Centers for Neighborhood Associations can be utilized for meetings without a charge.

The following were the suggestions for "Community Centers and Their Availability":

- Children need to have a voice in the process of developing programs
- · Activities need assessments from the youth and adults as to what services are needed at each location
- Check with school programs in each area to see that programs are not duplicated there and to see what is needed
- Need more youth programs to get centers to be open have partnerships with 501.c 3 organizations to provide requested services
- Get more volunteers to help with existing and new programs
- Use centers to develop interest and more children may attend programs
- Have lunch programs during the summer for the youth at all Park Centers
- Get more help from existing Non-Profits and the Non Profit Center
- New Parks Task Force should help in identifying needs
- With the change of staff nee to have better communications on what each department is doing so as not to duplicate services
- Advertise about "Centers as Rental" opportunities
- Have 501.c 3 chartered as a partner in the Adopt-A-Park program with a signed agreement that lasts 3 years for 3 terms (Past agreements had been mostly verbal with past administrators new ones need to be drawn up for the current administration)
- · Should let all groups be aware that long standing agreements are over and it is time to fill out a new application
- Look at having 2 turnkeys at each turn key site to make it more convenient for Neighborhood Associations access to the center for meetings
- · Need better communication from the city to the associations in regards to park & senior centers
- · Check with neighborhood leaders and associations to see what services they need in that community
