**JSO** – Not present

<u>Mayor's Liaison</u> – Devin Reed, Director of Procurement passed out the press release on Mayor Peyton's new initiative – The Jacksonville Journey – Take A Step. This is a comprehensive initiative aimed at the violent crime that threatens Jacksonville's future. It will have city leaders on various committees to come up with solutions to our problems. We have the facts now we need the answers. If you have some ideas and solutions please contact the committee via Devin or Marilyn or the City of Jacksonville's Website. It will be guided by a steering committee co-chaired by John Rood and State Senator Betty Holzendorf. The subcommittees will be on: Education, Funding, Intervention and Rehabilitation, Law Enforcement and Deterrence, Neighborhood Safety and Stability, Positive Youth Development, and Public Relations. Members wanted to be sure that youth were involved with this process. Devin will be sure this happens since he is on the committee.

- Members wanted to be sure that youth were involved with Mayor Peyton's new initiative the Jacksonville Journey, Take A Step and they would also like to become a part of the this initiative.
- Members wanted to know if Take A Step was going to work in collaboration with Councilman Hyde's Forum on Crime and Safety and JSO to have a unified front?
- Members had concerns that when JSO arrests someone that the State Attorney does not follow through and prosecute them. Therefore it is a revolving door that needs to be addressed.
- Members would also like to see Community Policing back in the neighborhood and not move the officers from zone to zone so often. They want to restore trust from the neighbors to the police.
- The need for activities for our children was talked about but also the fact that a majority of our parks are dark and not being used. This needs to change to have positive things for the youth to do.
