Guest Speaker:

Councilwoman Suzanne Jenkins, District 4 "Downtown Entertainment District Bill" (4am Bill) 630-1394, presented information on the proposed bill. A FAQ sheet was handed out with a map of the revised "Entertainment District". Members asked numerous questions especially what the Sheriff's Office thought of this. Lt. Tyree was not at the meetings and could not address this question. Members were also concerned that once this was enacted that in 3 years time they would want to stay open to 6 a.m. and make the area larger. Suggestions from members to add a requirement for a "Tipsy "Taxi Service and to hire off duty police officers was made. While talking about Internet Café's and wireless zones a citizen wanted to see if the NW Bradham Brooks Library could get the wireless zone. Staff Reports

Mayor's Liaison - Devin Reed, Director of Procurement – No report but on several occasions has received requests from citizens to fill a pot hole. He is here to help follow-up with issues that cannot be resolved by putting them into CARE (630-CITY). Members then told him about the need for ditches and nuisance lots that need to be attended too. He also talked about the job opportunity bank where donations and or grants to establish a trust fund to encourage companies to hire teens 18 to 21 that are chronically unemployed. JSO Zone 5 - Lt. Tyree reported that crime in Zone 5 is down 4% from last year. He gave out blank Zone 5 Incident Report forms for neighbors to fill out and bring back to their organizations. Members were very concerned with red light runners and not stopping at stop signs. It appears to be getting worse instead of better. Fines for running red lights are now \$183. Citizens from Palmdale reported problems and offered the use of their yard for JSO to watch from. 2005 D 026 12/15/05 AGR 3 to Rural Residential 540 acres located across from the railroad – south of Plummer Road Lou Gena then answered questions and would check with Lara on the progress of the "halfway house". Member Anderson said that he had spoken with Lara and that the Office of General Council was checking on the lease agreement.
