Builders Care is in the process of rehab of 30 homes. They will have a Fun Day and a cleanup in the spring. Youth Reaching out grant was very successful and hopes to get more funding.

Cassandra Person, Washington Heights Estates said they were working hard on the neighborhood. She also spoke about the COPS (Community Policing) program. Darrell Brock wanted to know when the Charles Reese Boat Ramp would be re-done?

Jean Lewis, Sherwood Forest, spoke on the New Ways Grant her neighborhood received last year and how wonderful it was for the children.

Chairperson Kerr welcomed Councilman Lad Daniels and his Aide, Celeste Hicks and thanked them for attending the meeting.

They also distributed an Exception for a Manufactured Home on Doris Lane and a daycare off Division Street. If you are not listed with the Planning Department your Association will not receive notification unless you live within the 350-foot required notification. It takes the Tax Appraisers Office a year to list new homes on the tax roles. Can this be done sooner since the public needs to be informed on changes in the neighborhood before it happens not after the fact. This also goes for the waivers and exceptions. Peter King will check on this and let us know at the next meeting.
