### Staff Reports

JSO Zone 5 – Lt. Pacheco introduced himself and reported that crime rates are down especially in Zone 5. Members asked the following questions:

- Can an officer that patrols in the North Shore area come to their next meeting? North Shore is in Zone 1. He will e-mail Zone 1 and ask them to call her. Zone 5 boundaries are North of I-10 and West of i-95 to the county line.
- Members would like to see police officers get to know the neighborhood that they patrol and be friendlier with residents. Lt Pacheco stated that in February Zone 5 will have a bike unit and they do patrol the neighborhoods and get to know the neighbors.

Members asked if there was a cost, no, not for neighborhoods. They also asked about dead trees there were located from 26<sup>th</sup> to 33<sup>rd</sup> street and the possibility of removing them. ### **Staff Reports**

Mayor's Representative Devin Reed wished everyone a Happy New Year and reported on the following: There was a meeting last Friday and they discussed the following:

- The Mayor is preparing for an easy transition for the new Mayor. His last day will be June 30, 2011. The new Mayor will take office on July 1, 2011.
- The budget has to be submitted in July. The new Mayor will have less than a month to put • together a budget. Currently all departments are putting together budget scenarios. For the upcoming new budget year 2011-2012 there is a \$61 million dollar shortage. In 2012-2013 there will be a \$124 million dollar shortage and in 2014-2015 there will be a \$171 million dollar shortfall due primarily to pension and health care costs. Departments can not cut anything more except employees. In the last 5 years the city has made cuts that didn't affect the citizens and didn't impact services. The latest scenario will be that services will be cut and people will be laid off. Nothing is off the table. He stated that this was a dreary picture but emphasized the importance of being involved. He encouraged members to get to know the candidates that will be running Jacksonville. There will be a lot of hard decisions that will have to be made in the next few months.
- The FOP rejected the latest proposal for the pension and 2% paycut. This will have to go before the Magistrate and if it is not resolved there will have to go before City Council.

Members had questions on the following:

- What percentage of the budget is service oriented? One third is service oriented and that • one third is where they will cut departments that will impact services residents receive. He also mentioned that the city has 67% of the budget in commitments like the pension and health care.
- Members suggested raising the sales tax to bring in new revenue but couldn't see • candidates campaigning to raise taxes. Mr. Reed stated that the sales tax could only be used for certain things.
- How can the city have money to build a new school? That is capitol improvement money • that has bond money and was set aside years ago.
- Members read about the \$90 million dollar contingency fund. What about using that money • for the shortfall. That money is for an emergency fund and the definition of an emergency is laid out in an ordinance.
- Will the city be laying off employees that are not in critical positions? There is a hiring freeze • and they are not filing any new positions. Every thing is on the table.
- Members would like to see candidates be realistic and just say they will have to raise taxes.

• Members talked about how blogs are destroying our country. People assume they know something when they really don't. That is another reason to be involved.

<u>Planning & Development</u> – Planner Lurise Bannister passed out her monthly report and spoke on the following:

- At the last meeting in November the items are still on the agenda with one change: 2010E-002 converted to 2011-002C at 6720 Norwood Ave. – the land use was high density and it was amended to medium density with a limited number of units. The PUD was approved and will be reintroduced at the end of the month since the land use was changed.
- The Mobility Plan and will replace the Concurrency Plan. If the CPAC would like a presentation on this to let her know.
