### **Guest Speakers**

Leigh Rassler and Jim Pugh from JEA passed out flyers on a meeting to be held Monday, October 14, 2002 at 6:30pm at the Zion Hope Missionary Baptist Church located at 2803 West Edgewood Avenue. This meeting will talk about why JEA is opening a new JEA branch at 1108 Dunn Avenue and the 5363 Soutel Drive will remain open for bill payments only at least until after the new year. JEA has picked 7 areas geographically around town to have JEA full service centers. The first one will open on Dunn Avenue. The new hours will be from 7:30 am until 6 PM and a half-day on Saturday.

**Dr. Dawn Sollee, Clinical Professor & Assistant Director -Florida Poison Information Jacksonville - Poison Control** – They have a new statewide phone number 1-800-222-1222 or 911 will dispatch over to that number. They will keep the old number active as well. Their web site has been updated at <u>www.fpic.jax.org</u> This will assist in providing information on plants, snakes, bites, stings and other toxins. They serve 42 counties in Florida with a population of 6 million people in 139 hospitals. The call number treats 82% calls at home and saves on health care costs by treating at home. There are 3 centers: Jacksonville, Miami, and Tampa. They have a full time educator that will come out to meetings. You can call 244-4465 for Maryann at Shands. Members of the CPAC asked questions of Dr. Sollee. **Sue Bisesi, Volunteer Services Coordinator, JaxCERT "We Will Respond"** presented a new opportunity for citizens to help their neighbors in an emergency. In order to participate one must be 18 years old, be able to lift 25 pounds and volunteer 4 hours a month to a CERT project. A background check and references will be done and no felony convictions are permitted. Training will be on Saturday in teams of 3 and will begin in December.
