Call to Order

Chairman Gadson Burgess called the meeting to order at 6 p.m. with a welcome and the Pledge of Allegiance at the Bradham*Brooks NW Library Auditorium, 1755 Edgewood Ave. West.

Approval of the Meeting Summary

A motion to approve the September 10, 2009 summary as written was made by Member Arnold and a second by Member Hall. The Vote: All were in favor. None opposed

Staff Reports

JSO – Lt Tyree and Sgt. Mahaffey reported on the following:

- The car wash on Hunt Street and McDuff Avenue had 2 arrests.
- The underage selling at the store on McDuff was turned over to the Dept. or Alcohol and Tobacco.
- The request from NWJCDC to sign a form for no trespassing was signed.
- They made 3 arrests on West 24th Street.
- They are working on 23rd Street and Moncrief with the people hanging out.
- Crime is down by 11%
- They will be focusing on the Florida/Georgia game and Halloween. No-one is allowed off.
- There was a business burglary on Edison Ave. at Marsh Marine. They had a building where they were storing material with wires from various towers from 47 or 48 highways. They made 11 arrests. Members were very concerned with the fact that anyone can sell copper to the recycling plants without getting any I. D. when the wire could possibly be stolen. This drives up the burglaries. They discussed the need for a law like the one used at pawn shops to get I.D. from the person bringing in the wire to be sold.
- A Motion was made by Member Arnold and a second by Member Hall to write a letter to the City Council to enact legislation to require recycling facilities to require identification like the pawn shops to help alleviate theft to air conditioners for the copper. The vote was unanimous.
- Members asked if the Community Service Officers were still in place. Yes and they answered 33,000 calls for service last year.
- Members asked how long a car could be parked in a residential neighborhood. It depends if it is illegally parked, it there is no registration tag on the car or if it impedes traffic.

Guest Speakers

JaxPride Executive Director Lou Gena Smith gave an overview of what they do: JaxPride is a non-profit citizen coalition, committed to creating beauty and civic pride in Jacksonville. They can't do it alone. They need neighbors like you to say where to do it.

- The JaxPride Programs are:
 - JaxPride Week (held in February) where citizens are honored for programs they have done in their neighborhood. This past year Mayor Peyton gave out the awards.
 - o JEA/JaxPride Site Improvement Program
 - NIVP (Neighborhood Inventory of Visual Pollution) is an advocacy program that advocates for vigorous enforcement of various ordinances like the sign and code which if not addressed could hurt the quality of life. They will contact code and be sure to follow up on issues and also notify members of the City Council.
 - NIVP Junior schools invite them to speak to students about litter control and the possibility of doing projects around the school. It gives them pride and fun way to get them involved. Currently at Ribault High School they are working with a group to beautify an area around the school.
 - Neighborhood Visioning Program they worked with the city on the Charette for Metro Park. They ask neighbors for their ideas and they come up with a vision plan and a report to accompany it. This will help developers on what the area wants.

 JaxPride increases public awareness of the city's needs and the opportunities available to improve visual appearance like the bus shelters. They do not want to see the city go back to the 1990s with the amount of billboards that once lined all major roads. Ordinance 2009-401 would allow JTA bus shelters advertising on the shelters and this may open the door to litigation. That is why Ordinance 2009-402 was introduced to prohibit JTA advertising on shelters or pay phones. Lou Gena hopes the CPAC will take a stance on these issues. Members commended JaxPride for their work and had guestions and concerns on the following: How can litter be fined and enforced by JSO? There is a zero tolerance for litter in Jacksonville and can be fined up to \$100. They also wanted to know about the signs on the city right-of-way. The signs can be removed by citizens. Members wanted to see JaxPride work on Myrtle Avenue from 25th Street to Moncrief and 45th Street. It needs to be cleaned up. It is in the 29th & Chase Neighborhood. They wanted to know if they could leave their neighborhood meeting sign up for at least 72 hours or a week. They would like to see JaxPride ask for help with amending the Ordinance to have neighborhood meeting signs have an exception. It was suggested to ask upcoming political candidates how they could help with these requests. They wanted to see highways and interstates landscaped and maintained better especially in the Northside. There needs to be a tree trimming program in the city that will cut trees and keep ditches cleaned. Members talked about the street lights on Clyde Drive that due to the over growth of the tree limbs the streets are extremely dark. Street lights need brighter wattage. JEA continues to say it's not up to them to keep the lines clear and Public Works says it's JEA. Members discussed putting signs on private property and keeping the city right-of-way clean. It helps beautify the neighborhood.

JEDC (Jacksonville Economic Development Commission) Business Development Division Joe Whitaker talked about **Resolution 2009-711** which will declare portions of Jacksonville as a **Recovery Zone** (RZ). He passed out handouts with an overview of the resolution which included the recovery bond program and a map with the proposed Recovery Zone Areas which include the Enterprise and Empowerment Zones, The Airport, the Community Redevelopment Areas and former Naval Air Station Cecil Field. This would allow the City of Jacksonville and the State of Florida to issue Recovery Zone bonds for private and public projects that promote job creation and econmomic recovery. If passed by City Council there would be two types of Recovery Zone Bond for approximately \$40,000,000 total:

- RZ Facility Bonds: tax-exempt private bonds with lower interest rates and can be used for capitol projects to create jobs. The bond holder is tax-exempt on the interest for Federal tax purposes.
- RZ Economic Development Bonds: can be used for the city for public capitol projects, job training and education and interest on the bond is subsidized by 40%

The program must be used by December 31, 2010 or it goes away. It is on a first come basis. The North Florida Shipyards are asking for \$7 million. Members asked if there was a down side to this program. No. The map had no street names and wanted to know if the Enterprise and Empowerment Zones were the same as the ones in 2005? Yes. They wanted to know how many jobs this would create. Not really sure but possibly 300 to 500 jobs. What does the Bond Program cost and how do you purchase them? This is for private bond transactions that need legal opinions to be tax-exempt for one's income tax. Therefore; JEDC charges \$10,000 for an application and the cost of issue is 2%. How is this different than regular bonds? It is a broader category and not restricted to manufacturing. It can only be used for capitol improvements and not working capitol. <u>Planning & Development</u> – Planner Susan Cohn handed out her monthly report and talked about the following:

- The top 3 items have been deferred.
- 2009-0252 is a PUD rezoning at Jones Road and Pritchard intersection.
- In February 2009 Kristen Reed came to the NW CPAC and talked about the EAR. They are
 now going to go before City Council on Oct 13. The first public hearing will be on Oct. 27,
 then before the Planning Commission on Oct. 29, the LUZ Subcommittee on Nov. 3 and
 then hopefully for adoption by the City Council at the Nov. 10 meeting. There will now be
 10 elements of the EAR historic and schools were added to the 2030 Plan. They have also
 added preservation of working waterfronts. The report is easier to read. The Plan will also
 include strategies to require the link between land use and transportation. They will also look
 at goals and objectives to reduce green house gas emissions.

<u>Municipal Code Compliance</u> – Zone 5 Supervisor Danny Connell is pleased to report the annual figures for this past year. He made some promises when he first came to the NW there changes would be made. He passed out brochures on junk vehicles, garbage and new addresses. In the Southeast District (Mandarin) there were 15,162 cases this past year. In the NW there were 34,507 cased with an increase of 35% from the previous year. Currently there are 2698 active cases. They are required to do 2 systematic inspections each month and in Zone 5 they did 51 this past year.

For the new fiscal year they have already done 2 systematic inspections – one in Grand Park and the other in Mid-Westside. The Code Officers are now doing zoning and will be doing sign enforcement along with Solid Waste.
