Call to Order

Chairperson Kerr called the meeting to order at 6:20pm at Riverview Community Center – 9620 East Waters Street and welcomed everyone. Chairperson Kerr apologized for being late due to the New Ways Grant Sub Committee reviewing neighborhood grants.

Approval of the Meeting Summary

When a quorum was established the meeting summary from the March 13, 2003 meeting was reviewed. A Motion to Approve was made by Gadson Burgess and a second from George Leverett. The Vote: All were in favor, none opposed.

Guest Speakers

"Presentation of Street Light Survey Program" by Fred Kyle, Public Works – Traffic Engineer along with Nancy Kilgo, JEA, Rick Ball, Public Works who gave a power point presentation on street lighting. This is being done in response to City Resolution 2002-554 stating "A resolution requesting the Mayor and JEA to hold a series of meetings with CPACs to allow constituents to perform community organized reviews of street lighting to make recommendations to the Department of Public Works. The purpose of street lighting is "to provide for the safety of vehicular and pedestrian traffic, it is the policy of the City of Jacksonville to require adequate street lighting for all new residential and commercial subdivision streets". Currently there are 93,000 streetlights at a cost of approx. \$5 million dollars a year for JEA to install and maintain them. They asked members to survey their neighborhoods at night and bring the surveys back to the next CPAC meeting. They would like this process done in 60 days.

Transportation Improvement Program (TIP) 2003/2004 through 2007/2008 presented by Jeff Sheffield, Sr. Planner gave an overview of the NW Projects. Members asked why there were projects such as overpasses not listed. They were told that it would be added but they were awaiting specific locations and there were no dedicated funding sources allocated for this project at this time.

Northwest and Southwest Vision Plans - developing draft now, getting feedback from the Urban Land Institute. A draft will be introduced at 4/22 Council meeting. Public meetings will be in mid or late May. Smaller, neighborhood level meetings are being conducted by Asset Property Disposition over the next few weeks. Land Use Changes -

Chairperson Kerr asked for a volunteer to oversee the Zoning Sub Committee and to go over requests before our meeting. Randy Mallory, Murray Hill, agreed to do this. There was also a concern that the State has a law on waivers for obtaining a liquor license with the distance from a church or school and citizens want to change that law. The Planning Department will check with General Council on this.

FDOT – Milton Locklear had no report but stated that the overpasses were looking for specific locations such as New Kings Road. If you have any questions please call 360-5686

<u>Code Enforcement</u> – Terri Lindemann came with packets from last months "Workshop on Know the Difference on Codes" and passed them out. They just performed a sweep in the Washington Heights Estates Community. There were questions on junk cars and concerns with groups coming into parks that block off the entire community. These groups usually bring bad elements into the neighborhood. There was also a question on noise from a park with children playing basketball. This park was built right next door to the house and the sound is continuous.

<u>NW CPAC Bus Tour</u> - Members commented on how detailed the evaluation form was this year. This will be very helpful in planning the Town Center Plan. Murray Hill has started utilizing this to go to merchants to see if they would be willing to spruce up their place of business. Elaine Burnett thanked Marilyn, Diane and Thomas for a job well done. Randy Mallory also wanted to extend thanks to Code Enforcement for the sweep in his area and said the Bus Tour Evaluation was a very useful tool for the Town Center Plan. Members had questions on how do you get businesses in your area to cleanup their property? Try to work with them. Encourage them to apply for a façade grant and watch to see if that property goes on the tax lien list to buy the property.
