### Call to Order

Chairman Gadson Burgess called the meeting to order at 6 p.m. with a welcome and the Pledge of Allegiance at the Bradham\*Brooks NW Library Auditorium, 1755 Edgewood Ave. West.

#### Approval of the Meeting Summary

A motion to approve the May 14, 2009 meeting summary as written was made by Member McIntosh and a second by Member Cecconello. The Vote: All were in favor. None opposed.

## <u>Staff Reports – JSO</u> – Zone 5 Sgt. Gidcumb reported on the following:

- Five robberies to individuals have been solved. A good physical description from a car jacking helped identify the man.
- They are working on the homicide on Canal Street with a few positive leads.

- Burglaries to residences are happening at all times of the day and night and some homes are occupied. Protect yourself by locking your home and cars, putting your alarm on and knowing your neighbors.
- On June 30 the new "Primary" law for seatbelts will begin and what that means is that a Police Officer can pull you over if they see you not wearing your seatbelt. This law will help save lives. Covered are 6+ year olds in the front seat; 6 through 17-year olds in all seats. Members wanted to know what the fine will be? \$99 for the non-moving violation.
- Block parties need a permit. There was a shooting a month or so ago on Cherokee St. at a block party and a teen died at the scene and 8 people were shot. Remember a permit is needed to shut a block down to traffic. If you see or hear of a block party let JSO know so they may monitor it. Members asked if the neighbors on the block have to sign off on closing the road. Yes, that is why JSO wants to know about a block party to check in with the organizer early in the day to let them know the rules so they will not get out of hand. They are not allowed to have alcoholic beverages.
- Members wanted to know if a child under the age of 12 needed to have a bike helmet and what would happen if they did not have one? The officer may give them a verbal warning and children under the age of 14 would get a fine of \$47.50 and children 15 years of age and older would get a moving violation and a fine of \$49.00.
- With the extra police deployments members want to know why it is that police officers are pulling people over and running the cars tag when there are no violations? It appears to be profiling. You can always ask to speak to a supervisor if you think this is occurring.
- Members talked about the JSO Ride-A-Long program to see what an officer actually does

#### **Guest Speakers**

<u>JEA - Brian Pippin</u>, CEM, CGP gave a presentation on a portion of the 45-minute program "Savings without Sacrifice" Low and no cost energy and water conservation behaviors and products that will help to significantly lower your utility bill. If this will spark your interest and you would like to become a trainer please contact Brian. With summer time being so hot and the need to lower utility bills by 50% with no cost, low cost and or a capital solution was presented.

- First; control your thermostat: set it at 78 degrees in the summer (68 degrees in the winter). If you set it lower in the summer it will cost you more money each month.
- Low cost: If you install a fan in every room and only turn it on when you are in the room it will make you feel 3 to 5 degrees cooler. Fans cool people not rooms. If you leave it on when not in the room the motor will produce heat. If you leave it on 24-hours a day it will cost \$5 a month.
- Everyone needs interior shading and the need for more exterior shading with trees and bushes but that will take years. Awnings and shutters will help as well as solar screens. Window tinted film on the east and west windows of your home would be much better.
- Air conditioner heat pumps take the heat out of house in the summer. If you check your attic and you can see your rafters you need more attic insulation for an R 38, walls R19 and windows with no shade will be an R2 value. If you run your air conditioner this will help with controlling the humidity and this will help in alleviating mold.
- You can chalk and weather strip your home "If you see light it isn't tight"
- Have CFL light bulbs for every lamp in your house. They save money. At the end of the meeting each person received a CFL light bulb.

Members asked questions on the following:

- How much time does a person have before their electricity will be turned off if they do not
  pay their bill? Does JEA report late and no payments to the Credit Bureaus? Brian will check
  and get back with the answer.
- Are there incentives? Yes. There is a \$1.50 coupon off for the purchase of a CFL light bulb as well as incentives for solar water heaters.
- Is it better to have a large central air conditioner or lots of window units? If you plan to use the window units at the same time it is better to have a central air conditioner.
- Are CFLs safe to use? Yes. They have a very small amount of mercury. Once the bulb goes
  out dispose of the bulb by bringing it to a store like Home Depot to recycle it.

Emergency Preparedness Elizabeth Henderson, Planner, gave a PowerPoint presentation on "Disaster Preparedness" June 1st is the first day of the 2009 Hurricane season and lasts to Nov. 30. Are you ready? We haven't been hit in a few years but that doesn't mean it may not happen here. Everyone needs to be prepared. If a hurricane does hit there may 3 to 7 days without assistance from the government. You need to prepare yourself. The 2009 National Weather Bureau is predicting 9 to 14 named storms. Are you ready to survive a Category 3, 4 or 5 storm?

- Category 1 winds 74-95 mph
- Category 2 winds 96-110 mph
- Category 3 Winds 111-130 mph
- Category 4 winds 131-155 mph
- Category 5 winds over 155 mph

Color-coded storm surge markers can be found throughout Jacksonville and the Beaches. You may only have a 12-hour notice to prepare. If a storm is a approaching prepare by doing the following: Set you freezer on the highest setting, freeze water bottles for ice water and or an ice pack if someone is injured wrap the bottle with a towel, remove all objects from your yard, make an evacuation plan, remember to call 511 (Florida Highway Patrol) to see what roads are blocked and where to travel, if you need transportation to go to an evacuation center go to your nearest bus stop. If you are told to evacuate call ahead to a hotel to make a reservation, place all your financial, medical and home information on a flash drive and if told to leave your home LEAVE. JSO and the Fire Department will not put themselves in harms way if you were asked to leave and didn't. Register yearly if you need medical care or need to go to a pet friendly shelter. Currently there are 897 registered for medical. Secure your valuables in a water proof container. Stay away from windows and don't go outside. Do not open your windows and doors. Know where your safe room is. After the storm do not use equipment or go on roof tops if you have never done it before. Don't let children play in standing water there may be live electrical wires or snakes. If you are in a car during a tornado get out of the car and go to the lowest point. Recommended Supply Kit:

- 1 gallon of water per person per day for 3 to 5 days
  - Water purification kits are sold in sporting goods stores
- Canned food and non perishable items for at least 3 days
  - o Stay away from flames but sterno cans can be reused
- Battery operated or hand crank radio and a NOAA Weather radio with tone alert and extra batteries for both
- First aid kit
- Whistle to signal for help
- Get cash ATM won't work without power or the machine may be empty
- Take clothing and bedding and place in a plastic bag
- On June 12 your old battery operated TVs will NOT work. If you get a new digital TV make sure you read the instructions on how long it will work and how to change batteries or recharge them.
- Flash lights and extra batteries

- Manual can openers
- Hand sanitizer, moist towelettes, garbage bags and plastic ties for personal sanitation
- Prescription medication call the pharmacy to fill once a storm is approaching
- Books and games to entertain

Continue to monitor the storm and call 630 CITY for questions and if you have power check the City of Jacksonville's Website at <a href="www.coj.net">www.coj.net</a> There were numerous handouts for various emergencies including an opportunity for JaxCERT which is the Citizens Emergency Response Team. This is a free 21-week program to learn how to help your community in an emergency. A question about DTV came up too. Old battery operated portable TVs will NOT work now. <u>LUZ Subcommittee</u> – Subcommittee Chair Diane Kerr brought the following recommendation from the LUZ subcommittee meeting held at noon, June 11, 2009 as follows even though they were voted on at the Planning Commission they want to have the entire CPACs vote:

- E-09-25 at 5668 Avenue B with the exception to be a Private Club. This was the Silver Star. The Private Club is the Royal Terrace Men's Club which is a non-profit. Planner Cohn went over the definition of what a private club is. Some of the concerns are: It does not include pool tables, the legal description was misrepresented, there was not enough parking, The previous owners were in operation since 1948 but somehow it had never been regulated. It came to the attention with a Code violation. The Certificate of Use was not recorded. It did not mesh with zoning. It has had problems with drugs and prostitution and a murder occurred there not long ago. During the hearing the owner said that the club only had 7 or 9 members and each member was allowed to bring 9 quests when earlier he stated that on Friday or Saturday night they had 200/300 people in the club. This was not what the community wanted in the neighborhood according to the Neighborhood Action Plan (NAP). CDBG and City money was used to help improve the neighborhood. If the building was closed for more than a year it would have to come up to 2009 standards. A Motion was made by Member Cecconello to agree with the Planning Departments findings of a denial on E-09-25 at 5668 Avenue B with the exception to be a Private Club. It was properly seconded. Discussion: Member Wilson remembered the day when the Silver Star was a very nice place but has gone down hill with a lot with crime. The Vote: All in Favor; None opposed.
- V-09-08 at Utsey Road with the variance to be a family homestead from AGR to AGR IV to have 2 dwellings on 3.56 acres. The Cisco Gardens Neighborhood had no problem with this. At the Planning Commission this was approved, amended with conditions.
