- ♦ Neil A. Armingeon, St. Johns Riverkeeper "Your Right, Your River, Your Riverkeeper" presented information on the protection of water and land in the St. John's River. This organization is one of 110 in the world. Citizens are working to protect the environment. Educating the community and supporting legislation is the main focus of the 700 members. - ♦ Michael Kelly, Super Bowl Host Committee President and COO "Jacksonville Super Bowl XXXIX" The game is only 609 days away on February 6, 2005. They are expecting 100,000 visitors to the region of which 3500 journalists (500 foreign) and 800 million will watch it on TV. The Stadium will hold 83, 000 when work is completed. They will need 30,000 quality hotels rooms and 12,000 are accounted for. They will use cruise ships of which 3600 rooms times 5 ships for the remaining 18,000. They will have one ship in front of the Adams Mark, 2 at Tallyrand and 1 at Blount Island and 1 not sure. This fall they will establish a program for emerging businesses to be able to provide services. They will need 8000 volunteers mostly at special events (not the game) − a uniform will be provided − recruiting to begin in Jan. 04. - James Constande Paxon Full Service School reported that the next meeting of the Super Neighborhoods will be in August details to follow by Marilyn Fenton-Harmer

Chairperson Kerr talked about the Town Center Initiative and how the City Council cut \$6 million for new legislation. Randy Mallory also talked about the entire program. There were no set rules found, no ground rules, no money to rebuild, no access, how can it be gotten and by whom, no readily available answers and how will it work? Chairperson Kerr asked members to be ready to

respond to a request to go to the City Hall to petition to reinstall this program. It was mentioned that in 2weeks time there was legislation to reverse the bill. Please watch, listen and report back.

The City Council will be sworn in on Tuesday, June 26th at the Times Union Center for the Performing Arts at 6pm and the Mayor will be sworn in on Tuesday, July 1st at the Times Union. - Riverview foot patrols are needed to see violations; parks need improvements and security needed
- Get police out of their cars and get to know people also rude driving habits in the neighborhoods by JSO
- Landlords need to get a dumpster when they have move-outs
- Standing water and drainage needs
- City workers Marilyn Fenton-Harmer very effective, Code Enforcement, Clean It Up/Green It Up "truly jewels" assisted in a very timely manner
- Neighborhood Magazine info-knowing you're not in this struggle alone, people are working
- Call Center- gives you the run around
- Happy about more code inspectors but still need more with tighter codes and enforceable codes
- Leadership Institute very informative
- Neighborhood Summit is great
- Dogs still roam especially at night and need stray animals with leash law
- Legal issues need to be addressed by Neighborhoods Dept.
- Need training in Rules & Regulations
- Need training at various levels in Organizational Development
