Call to Order

Chairman Gadson Burgess called the meeting to order at 6:06 p.m. with a welcome and the Pledge of Allegiance at the Bradham*Brooks NW Library Auditorium, 1755 Edgewood Ave. West. Chairman Burgess then introduced Mayor John Peyton as the guest speaker.

Guest Speaker

<u>Mayor Peyton</u> talked about the budget cycle and his priorities for the next 36 months: Jobs, The St. Johns River and Crime - making Jacksonville safer. He discussed the budget and the Jacksonville Journey recommendations: enforcement, intervention and prevention. This included hiring more police, having more after school programs and renovating community centers which will have better programming. Members had numerous questions and concerns for Mayor Peyton on the following: animal safety, if BluePrint for Prosperity was included with the Jacksonville Journey recommendations, repeat criminal offenders, the funding for Housing and Neighborhoods Department and CPACs, programs for children, the noise ordinance, fees and the St. Johns River.

- Member Parker discussed the car wash at 7841 Lem Turner that has been a nuisance for the Lake Forest neighborhood for the last 3 years. Mayor Peyton will follow up on this.
- Member Royals discussed the problem of the joint Palmdale retention pond and her getting no assistance from Public Works. Mayor Peyton will have the Director of Public Works, Joey Duncan, check into the problems with the retention pond.
- Member Thomas talked about his neighbor that continually plays loud music at all hours that shakes his home. He calls JSO and nothing is done. He has reported this issue numerous times into CARE as well. He would like to see action from our law enforcement and the city on issues that affect the neighborhoods like drugs, prostitutes and loud music. He stated that we all need to work together and stop making excuses for problems that affect the quality of life for residents.

JSO – Sgt. Spates reported on the following:

- School will be starting and help is needed with truants. Call 630-0500 to report them.

- Members reported that they are scared to give their name and phone number when
 reporting problems to the JSO dispatcher. In the past some JSO officers have come to their
 house and they do not want any retaliation. When reporting an issue be sure to tell the
 dispatcher not to come to their home and this will be placed on the screen for the JSO
 officer to see.
- Members want action from our law enforcement and the city on issues that affect the neighborhoods like drugs, prostitutes and loud music. They continue to call JSO and 630-CITY to report issues yet the same problems that affect the quality of life for residents continue to go on for years and years. Mixon Town in the North Riverside neighborhood is a great example of an area that continues to have lots of illegal activity occurring with nothing being done about it. Lincoln Villas East, Diane Tucker talked about the continuous problems on US 1 with the prostitutes and drugs. She would like to see JSO not treat this lightly especially with a school in the area.

Irrigation and Fertilizer Ordinance

entertainment at the Mayor's Festival allows seniors to celebrate the holidays in style.

Mayor Peyton, Council President Ronnie Fussell, Councilman Michael and the St. Johns's Riverkeeper executive director Neil Armingeon signed two bills approved by the City Council to conserve Jacksonville's water supply and reduce the amount of nutrients flowing into the St. Johns River. The irrigation ordinance (2008-030) enacts landscape irrigation conservation measures or requirements that are based upon the St. Johns River Water Management District's model ordinance. The landscape irrigation requirements provide for odd/even addresses to irrigate on scheduled days, and prohibit irrigation between the hours of 10 a.m. and 4 p.m. Exceptions under certain circumstances are allowed (such as using a hand-held irrigation tool, micro-irrigation systems, maintenance and repair or watering to establish new landscaping). The irrigation conservation requirements may be enforced by the Environmental and Compliance Department, the Jacksonville Sheriff's Office, or any state law enforcement officer. To assist in meeting the nutrient total maximum daily load (TMDL) requirements for the St. Johns River as set forth for the City of Jacksonville by the Clean Water Act, the fertilizer ordinance (2008-028) addresses fertilizer application and retail storage requirements for retail garden centers, commercial fertilizer applicators and homeowners.

Sec. 366.504. Landscape irrigation schedule.

(a) During the time period when Daylight Savings Time is in effect, from the second Sunday in March to the first Sunday in November, the following landscape irrigation schedule shall apply and is limited to only that necessary for efficient utilization. No more than ½ inch of water is recommended to be applied, on each of the following specified irrigation days:

- (1) Landscape irrigation at **odd numbered** residential addresses shall occur only on **Wednesday and Saturday and not between 10:00 a.m. and 4:00 p.m.**;
- (2) Landscape irrigation at even numbered residential addresses or at places without an address shall occur only on Thursday and Sunday & not between 10:00a.m.& 4 p.m.
- (3) Non-residential landscape irrigation shall occur only on Tuesday and Friday and not between 10:00 a.m. and 4:00 p.m. During the time period when Eastern Standard Time is in effect, from the first Sunday in November to the second Sunday in March, the irrigation schedule listed in paragraph (a), above is still mandatory; however the following landscape irrigation schedule is strongly encouraged to apply to both residential and non-residential landscape and property owners are advised to limit landscape irrigation to only that necessary for efficient utilization. No more than ¾ inch of water is recommended to be applied, on each of the following specified irrigation days:
- (1) Landscape irrigation at odd numbered residential addresses shall occur only on Wednesday and not between 10:00 a.m. and 4:00 p.m.;
- (2) Landscape irrigation at even numbered residential addresses or at places without an address shall occur only on Thursday and not between 10:00 a.m. and 4:00 p.m.;
- (3) Non-residential landscape irrigation shall occur only on Tuesday and not between 10:00 a.m. and 4:00 p.m.:
- (c) All landscape irrigation shall be limited to only that needed to meet landscape needs;
- (d) Where reclaimed water is available, the use of private irrigation wells for landscape irrigation is not authorized;
- (e) Any person who irrigates landscape with an automatic lawn sprinkler system installed after May, 1991, shall install, maintain and operate a rain sensor device or switch that overrides the irrigation system when adequate rainfall has occurred.
- Sec. 366.505. Exceptions to landscape irrigation schedule. Landscape irrigation is subject to the following exceptions:
- (a) Irrigation using a micro-irrigation system is allowed anytime provided the amount of water used is limited to only that necessary for efficient utilization.
- (b) Irrigation of new landscape is allowed at any time of day on any day for the initial 30 days following installation and on every other day for the next 30 days for a total of one 60 day period, provided that the irrigation is limited to the minimum amount necessary for such landscape establishment.
- (c) Watering in of chemicals, including insecticides, pesticides, fertilizers, fungicides and herbicides when required by law, the manufacturer, or best management practices is allowed anytime within 24 hours of application. Watering in of chemicals shall not exceed ¼ inch of water per application except as otherwise required by law, the manufacturer labeling instructions, or best management practices.
- (d) Irrigation systems may be operated anytime of day for maintenance and repair purposes not to exceed 10 minutes per hour per zone but such operation shall not occur more than one time per week.
- (e) Irrigation using a hand-held hose equipped with an automatic shut-off nozzle is allowed anytime, provided the amount of water used is limited to only that necessary for efficient utilization.
- (f) Discharge of water from a water-to-air air-conditioning unit or other water-dependent cooling system is not limited.
- (g) The use of water from a reclaimed water system is allowed any day, but not between 10:00 a.m. and 4:00 p.m. For the purpose of this subsection, a reclaimed water system includes systems in which the primary source is reclaimed water, which may or may not be supplemented from another source during peak demand periods. This exemption is allowed to promote use of reclaimed water and to aid area utilities in expanding reclaimed water availability and distributing more reclaimed water to reduce treated effluent discharge to the river.
- (h) The use of recycled water from wet detention treatment ponds for irrigation is allowed any day, but not between 10:00 a.m. and 4:00 p.m., provided the ponds are not augmented from any ground or off-site surface water or public supply sources.

 Sec. 366.506 Variance from specific day of the week limitations.

A variance from the Landscape Irrigation Schedule set forth in Section 366.504, above may be granted if strict application of that schedule would lead to unreasonable or unfair results in particular instances, provided that the applicant demonstrates with particularity that compliance with the schedule will result in a substantial economic, health or other hardship on the applicant requesting the variance or those served by the applicant. Where a contiguous property is divided into different zones, a variance may be granted hereunder so that each zone may be irrigated on different days than other zones of the property. However, no single zone may be irrigated more than 2 days a week during the time period when Daylight Savings

Time is in effect, from the second Sunday in March to the first Sunday in November, and no more than 1 day per week during the time period when Eastern Standard Time is in effect, from the first Sunday in November to the second Sunday in March. Sec. 366.507. Penalties. Violation of any provision of this part is subject to the following penalties:

First violation Written warning

Second violation \$50 ticket Subsequent violations \$250 ticket

Each day upon which a violation occurs shall be considered a separate offense. No violator shall be granted more than one (1) warning. In addition to the ticketing authority provided in this section, nothing shall prevent the City from instituting any other enforcement mechanism authorized in this Chapter, including injunctive relief. Further the provisions of this part may be enforced as provided in Sections 366.210 and 366.211.

Sec. 366.508. Enforcement and information. This part may be enforced by the Director, his authorized representative, the Jacksonville Sheriff's Office, and any law enforcement officer of the state. Water supply utilities shall annually notify their

customers of the foregoing irrigation regulations at a minimum of twice annually in months that provide pre-growing seasonal conservation reminders.
