 - Ocopies of the UF/IFAs Extension Duval County 2014 Annual Report were provided. The Extension Office is a joint partnership with 35% funding provided by COJ, and other funding by University of Florida, and State and Federal grants serving 350 kids, and 62,000 residents. The Extension Office operated with 425 volunteers, or 32,000 hours at a savings of over \$710,000 in 2014.

- FDOT (Florida Department of Transportation) Jim Green reported:
 - o FDOT is celebrating its 100 year anniversary.
 - A maintenance crew was sent to Main Street and Pecan Park Road. CSX was contacted for needed rail crossing repairs.
 - A resident commended contactors for their work on Busch Drive. Residents expressed appreciation for the sidewalks and bike lanes.

- **4. Presentation:** The Honorable John Crescimbeni was introduced and welcomed. Council Member Crescimbeni thanked residents for their support in the election. He enjoys public service. He reported:
 - Concerns were expressed about dredging, effects on nearby properties (erosion), environmental issues and economic impact. The City Council does not have much information at this time. A report is expected from the Port Task Force. Funding remains an issue.
 - The Pension Task force completed an excellent report. The 2015 Fire and Police Pension fund cost is approximately\$153 million, which has resulted in budget cuts to libraries and roads. It is an unsustainable expense with no solution, it will result in layoffs, library closures and other cuts. Pension negotiations are now up to the Mayor's Office. A discussion was held about pension board membership selection process.
 - He volunteered at the 2015 Tire and Sign Buy Back. Over 22,000 used tires were purchased from residents. The purpose of the Tire and Sign Buy Back Program is to reduce neighborhood blight.
 - A question was raised about the work of the Capital Improvements Program (CIP) Committee.
 Council Member Crescimbeni explained that it is a special committee which is looking into capital
 improvement projects, purchases and long term assets. The Better Jacksonville Plan added to the
 current budget problems. The estimates were unrealistic, and not all projects were completed, due
 to lack of funding.
 - A question was raised about status of a project to identify city-owned real estate. David DeCamp explained the PAMO report has been completed.

- A concern was expressed that a COJ contractor came into the privately-owned Heckscher Drive Community Club, next door to the city-owned Heckscher Drive Community Center, to spray insecticide. The person was redirected or this resource would have been wasted on privately owned property. A safety concern was expressed regarding shipping cargo containers stacked too high for safety. Containers recently collapsed onto nearby parked cars. A maximum height and other safety regulations need to be established. Council Member Crescimbeni said he will research and report on the existing ordinances.
- A safety concern was expressed about portable basketball goals and kids playing basketball in or near the public right of way. Council Member Crescimbeni said he will research and report on the existing ordinances.
- Chair Neidlinger thanked Council Member Crescimbeni for his interesting report. He was invited to attend CPAC often.

5. Chair's Report – Chair Rex Neidlinger reported:

- Concern that although all CPAC volunteers want a voice in government, members feel their
 recommendations do not receive attention. CPACs experience problems in receiving timely
 information from the Planning and Development Department. The CPAC Chairs have been
 meeting. They will request a meeting with Mayor Brown and will ask to have a CPAC member serve
 on the Planning Commission. Each CPAC Chair will ask 25 members for letters of support for a seat
 on the Planning Commission.
- David DeCamp reported Mayor Brown welcomes input from the CPAC. The Mayor has no authority to act in the Planning and Development Department's quasi-judicial process. The Mayor's Office often finds out after City Council acts on Planning and Development Department issues. He suggested the CPACs ask for Mayor Brown's support to serve on the Planning Commission.
- David DeCamp suggested the CPAC work with City Council Legislative Services to obtain information as soon as it is filed. He offered to assist with that process.
- Charter Member Dot Mathias expressed concern that the CPAC was created as an advisory board to the Mayor it was not intended to have members serve as ad hoc committee members.
- Member Bobby Taylor expressed his concern that a CPAC member on the Planning commission will
 create a conflict of interest when the CPACs make recommendations.
