1. Call to Order/Verify Quorum

Chair Rex Neidlinger called the meeting to order and welcomed everyone to the meeting at 5:30 p.m.

2. Approval of the Previous Meeting Summary

The North CPAC did not meet in December. A motion to approve the November summary was made by Shauna Allen and seconded by Tommy Ruffin. The vote: All were in favor.

3. Staff Reports

- Jacksonville Sheriff's Office (JSO) Lt. Victor Pacheco reported:
 - o Assistant Chief T.C. Davis is recovering from surgery. He plans to retire in March, 2015. IN behalf of the North CPAC, Bill Baker thanked Chief Davis for his years of service.
 - o Violent crime is down 21%, citywide.
 - o Property crime is down 21% citywide.
 - o A recent trend is occurring throughout Jacksonville: appliances are being stolen from new construction sites. Please call 630-0500 if suspicious activity is observed.
 - o In 2014, 126 law enforcement officers were killed nationwide. Fifty were gun-related. Other causes of death including death in traffic accidents or while in pursuit of a felony crime, health reasons and stress-related reasons while on duty. Fifteen officers were ambushed. The number of deaths has increased 26% since 2013.

One portion of the App, "Fight Blight" is designed to easily report concerns such as blight, potholes, missed garbage collections, animals and other issues, pinpoint the issue location using GPS, attach photos, and receive automatic status updates from a smart device.

 - FSCJ is in the process of reviewing its facilities use agreement. FSCJ may no longer host the CPAC meetings at no charge. The review is expected to be completed on December 31, 2014. A brief discussion was held regarding alternate meeting space.
 - Tommy Ruffin asked Ms. Ridderman to contact Debbie Presnove, JSO, and provide a list of CPAC meeting dates.
- o Regulatory Compliance Municipal Code Compliance Division Tim Myers reported:
 - Since last month's CPAC meeting, Zone 6 officers completed 2474 inspections. City wide, officers conducted 18539 inspections.
 - The Urban Blight project is starting up again. Officers will work at 45th and Moncrief today.
 - The division has three full time inspectors and two in training in Zone 6.
 - A concern was expressed about semi-trucks parked at Dunn Avenue at the former

- Blockbuster store. Officer Myers said it is commercial property, but he will look into it.
- A concern was expressed about the overall appearance of the CVS store. A complaint was filed with 630-CITY today.
- Appreciation was expressed to the City for cleaning area ditches in the area.
- A concern was expressed about hundreds of old tires stacked beside the road. The resident was asked to report to 630-CITY.
- Municipal Code Compliance Officer Maria Powers, a new hire, was commended by residents for being helpful, hard-working and conscientious. Her supervisor also commended Officer Powers for being smart and for quickly and accurately absorbing training information.
