- 1. The meeting was called to order at 4:00 p.m. by Vice Chair/Acting Chair Nancy Landau. Chair Mike Getchell's absence was excused.
- **2. A quorum was verified** by Mary Beth Ridderman, Coordinator, Housing and Neighborhoods Department.
- **3. Guest Speaker –** Council Member John Crescimbeni provided information about redistricting. He discussed the population shifts from the 2000 Census and the 2010 Census. Currently, the committee is working on proposals for new districts based on

- total population and a proposal for new districts based on voting age population. They have discussed the creation of a Beaches district which would include Mayport. Council Member Crescimbeni said he would like to see districts with natural boundaries and a minimum of bridge/river crossings.
- 4. Presentation Water Conservation by Cheryl Bell Abbott, St. Johns River Water Management District. Florida has the largest concentration of fresh water springs in the world. A clay layer, the "Hawthorne Formation", protects our drinking water and can be up to 300 feet thick. The largest recharge area is in Keystone Heights. The Earth is comprised of ¼ land and ¾ water. Only 3 percent of water is fresh water and only about 1 percent is available for use from the aquifer. In the aquifer is a limestone layer, where ancient sea water is trapped in deposits in Florida, Georgia, South Carolina, and Alabama. If the fresh water in the aquifer is over-used, the ancient sea water will leach into the fresh water. It is important that residents conserve water by installing water-saving devices such as low-flow shower heads, water efficient toilets and appliances, follow water restrictions, and install water-wise landscaping with the right plant in the right place. - 7. Chair's Report: Chair Getchell's absence was excused.
- 8. Staff Reports
 - **A.** JSO Lt. Shawn McCormick reported:
 - JSO has an excellent group of officers in Zone 6.
 - In the past 30 days, burglaries to residences were down 41 percent, auto theft was down 34 percent and burglaries to autos were down 51 percent.
 - JSO's website will have additional information on statistics (http://www.coj.net/Departments/Sheriffs-Office).
 - One concern is that school will be out. JSO is visiting middle and high schools to prevent problems at school. JSO will be enforcing a curfew. Sunday Thursday, the curfew is 11 pm. Friday and Saturdays, the curfew is midnight. If you see kids under the age of 18 out after those hours, please call JSO. JSO will contact the child and the parent. Parents can be fined \$100 or they have an option of attending a parenting class.
 - Gerie Leigh discussed her concerns for drivers' safety on Heckscher Drive at Little Marsh Island and Palm Bluff Road. Drivers and are blind to upcoming intersection. FDOT Operations concluded there is not enough traffic conflict to warrant signage and said it is an enforcement issue.

 - **B.** Mayor's Representative Mike Sweat announced:
 - Thank you to Mary Beth Ridderman for sending out the Extension Office websites. The websites have a lot of useful information.
 - The Duval Extension newsletter is called Captive Audience.
 - A make and take rain barrel workshop is scheduled for June 17. The cost is \$5 for the class and \$40 for a barrel.
 - Camp Florida Friendly, for adults only, begins June 15. Day-campers learn about bees, landscape design, irrigation tune-ups, rain barrels and more. The cost is \$5 per class.
 - Master Gardener training begins August 3. Classes are 9:30 3:30 on Wednesdays.

- C. City Council Member's Reports Council Member Crescimbeni was the invited guest speaker.
- D. Duval County School Board No representative. No report.
- E. Florida Department of Transportation (FDOT) Thomas Hill reported:
 - As a follow-up to questions at the May meeting:
 - o Alta Drive is a widening project. Lanes will be expanded from 2 to 4 lanes from I-295 to the current 4-lane section at New Berlin.
 - o The Dames Point Bridge is being repaired with a strong back installation system. FDOT is contracting with a group to measure how well the system is doing and its effect on cruise ships.
 - o Residents had expressed concern that signage was inadequate when approaching the Dames Point Bridge where lanes are reduced from 2 lanes to a single lane. He spoke with the project manager and the signage will be changed. He reminded residents to look at the signs and be careful in the area.
 - FDOT will host a workshop regarding widening SR 243 from Airport Road North to Pecan Park Road. Open house begins at 4:30 p.m., formal presentations at 6:30 p.m. on June 30 at Hampton Inn and Suites on Airport Road.
 - Resident Gerie Leigh expressed concerns:
 - The Alimacani River has shoaled up under the Heckscher Drive bridge making it impassable to boats. Residents believe it was caused by equipment parked under the bridge.
 - o Signage on Heckscher Drive indicates the entire road will be closed on June 20. It is the hurricane season and Heckscher Drive is the evacuation route and resident has an event planned for June 20.
 - F. Municipal Code Compliance Bruce Chauncey reported:
 - Development has begun on Alta Lakes warehouse project which has access on New Berlin road but also had a former access point on Alta Drive. His department received a complaint that Alta Drive is being used by large trucks. The contractors have been warned not to use the former Alta Road access road. Please call 630-CITY (2489) or 255-7035 if the problem continues.
 - Please report suspected code violations to 630-CITY (630-2489).
 - G. Planning and Development Amy Hays reported:
 - This is her last meeting as a CPAC representative from the Planning and Development Department. Due to budgetary issues, her job was cut. A total of 7 jobs were cut and others were affected by position downgrades. She is one of two people who found COJ employment. She will be working as the manager of Metropolitan Park. At this time, the Planning and Development Dep't. has not identified the employee who will attend future CPAC meetings.
 - H. Recreation and Community Brian Burket reported:
 - He provided copies of the Master Plan for Sheffield Park. Phase I is beginning.
 - The Palms Fish Camp- the previous management group is in negotiations with the COJ Office of General Counsel.
 - Sisters Creek a boat pump out station should be completed by the end of July, 2011. Construction will not interrupt the Kingfish Tournament.

- Carlucci Park the parking area is being redesigned to improve traffic flow.
 A concrete slab and deteriorated playground equipment were removed. The Chair requested an update for the next meeting.
- Huguenot Park chicks are hatching. Zone 11 and half of Zone 12 are closed to vehicular traffic due to the presence of flightless shorebird chicks. Seven sea turtles have nested but none have hatched yet.
- The department is aware of reversion rights of the property donated for a
 pocket park by the Oceanway Volunteer Fire Department. By October 5,
 2011, if no construction begins, the property will revert to the previous owner.
- Dick Berry commended the department on the beautiful improvements at Betz –Tiger Point Preserve.

- **I.** Housing and Neighborhoods Mary Beth Ridderman announced:
 - Seventy seven residents from 77 different organizations completed training "How to Run Effective Meetings/Roberts Rules of Order" on May 26.
 - Council Member Crescibeni requested that neighborhood coordinators place CPAC archival summaries on the website. The project has been completed for the North CPAC.
 - The Extension Office is offering a class in jam-making in June 18 for a cost of \$20. She is registered for the class and she thanked the Extension Office for offering Saturday classes.
