- 1. The meeting was called to order at 4:02 p.m. by Chair Mike Getchell.
- 2. A quorum was verified by Mary Beth Ridderman, Coordinator, Housing and Neighborhoods Department.
- 3. Presentation The American Red Cross, presented by Bud Hescock. Mr. Hescock advised residents to be informed, have a family disaster plan, decide if you are sheltering in place or evacuating and have water/food/supplies if you are staying or leaving. Be sure to plan ahead for your pets, turn off propane tanks, fill cars with gas, cell phones with chargers, flashlight, battery powered or hand-crank radio, a whistle, extra cash on hand and sanitation/personal hygiene items including hand sanitizer. Documents needed are proof of address, insurance policies, family contact information and medical contact information. He suggested having insect repellant sunscreen, medical supplies, glasses/contact lenses, baby supplies, and pet supplies. For more information, please visit http://www.redcross.org/.

- 4. Summary of the previous meeting was approved.
- 5. Old Business none.
- 6. Chair's Report: Chair Getchell announced:
 - He was glad to see that the Northside Civic Association will join the North Vision Plan Subcommittee (NVPS). The NVPS subcommittee members are: Nancy Burnette, Kathy Myers, David Spruill, Delores Spruill, Bobby Taylor, Dot Mathias and Dick Berry.
 - Information about the budget workshops was sent electronically by Mary Beth Ridderman. He was disappointed to see that none are scheduled for North Jacksonville. A brief discussion was held. Council Member Ray Holt said he will arrange for a budget workshop to be held in North Jacksonville.
 - He is involved in a port issue Southeast Implementation for Ship Strikes on Right Whales. The last incident shut down the entire port for one day, affecting a total of 25 ships.
 - Seventy Right Whales are in the area now, including 15 mother and calf pairs.
 - The juvenile Right Whale found dead on the beach was entangled by fish nets but had no evidence of ship strikes. The necropsy report is still outstanding.

7. Staff Reports

- A. JSO Sgt. Pendley announced:
- The crime report is the best it has been in 7 months. Crime is down in all areas of the city.
- A current issue involves thefts of air conditioning units in residences and construction areas. He suggested residents arrange to have a guard constructed to protect their units.
- Gerie Leigh expressed her appreciation for the sign regarding not crossing on yellow lines. More signs may be needed on Heckscher Drive a third fatality has occurred in the area. Sgt. Pendley said FDOT or FHP may have installed the signs.

- B. Mayor's Representative Mike Sweat's absence was excused:
 - Mr. Sweat may be reached at 387-8850.
- C. City Council Member's Reports Council Member Ray Holt reported:
 - Oceanway has a library drop-off and pick up location being installed to provide services until financing may be obtained for a library.
 - Sheffield Park will have a groundbreaking in April, no date has been set. New bleachers and a dog park are some of the new amenities.
 - He is working with FDOT and Ander Crenshaw to build a roadway to the National Cemetery from I-95.
 - The Lainie Road Park is temporarily closed for construction. The boat ramp is also under construction.
 - He spoke with the North CPAC Chair, who expressed his concern that residents had not received notice about the Industrial Sanctuary. The ruling was that no public notice was required, but CM Holt said he pushed the issue and notices are being sent to over 18,000 residents. A public meeting is scheduled for March 14 at 6 p.m. at City Hall.
 - A resident expressed concerns about water runoff from Jacobs Way affecting residents in Garden City. He also expressed concern about children who are dropped off after school at the Highlands Library and have no adult supervision and are disruptive to library services. The resident said a police officer or security officer may be needed at that location. CM Holt said he will look into both issues.

D. Duval County School Board – Selinda Keys introduced herself and said she will be attending future CPAC meetings.

- A current issue exists regarding a proposed plan for Ribault, Northshore and other school. Possibilities discussed include creating magnet schools or closing the schools. DCSB is trying to come up with a solution that meets the State requirements and does what is best for children.
- FCAT testing will begin soon.
- A brief discussion was held. Residents expressed concerns about reduced State and federal funding, and the variety of socio-economic issues impacting children and their families.
- E. Florida Department of Transportation (FDOT) Jim Green was present but had no report. A resident asked for a traffic light at the intersection of Hawaii and Atlantic. Mr. Green said he will take the suggestion to the committee.

• A very lengthy discussion was held involving 2011-0014.

2011-0014	Oppose	ORD-Q Rezoning 4527 Irving Rd (2.20± Acres) - IW to PUD
		 The PUD was deemed inconsistent with the New Berlin Residential Enclave Ordinance established to protect the existing residential enclave in 1994; CPAC members recognize the diversity of uses within the community, including Industrial Water, and acknowledge the mutual actions of the Planning Department and the applicant to reduce impact to the residential neighbors. However, members remained concerned that the proposed intensity of use, including both wet and dry dock for ship maintenance and repairs, was not compatible with the nearby residential uses in the Enclave, and While the applicant continues to offer assistance with a proposed move of the historic Grey Hotel (listed on the Jacksonville Historic Society's list of 12 significantly endangered historic structures in 2007), its move was not documented as a pre-condition to site work on the new facilities, and the CPAC desired more positive affirmation of its protection.
