1.	2007-33	PUD for 31.6 acres on the west side of New Berlin Road north of Faye Road. The property lies between Faye Road and Cedar Road. Property is presently category LDR - <b>No action</b>
2.	2007-40	3.7785 acres property from AGR to AGR-N located between Highway 17- N and across from Yellow Bluff Road. This request by the owner for waiver of minimum road frontage. <b>Approve</b>

3. 2007-79

Land use designation: LDR 1.1 acres from PUD and RR to PUD. The property is located on the north side of Dunn Avenue and east of Braddock Road. The additional lands added to the PUD have caused the project density to decrease from 2.36 units/acres to 2.14 units/acres. Approve with the condition that space be set aside for storage of boats and recreational vehicles.

4. 2007-81

3.1 acres located in the northwest quadrant between Duval Station Road and Starratt Road. Property is currently zoned PUD and is category LDR. Proposal is for a childcare learning center. The PUD allows development consistent with the CN (Commercial Neighborhood) zoning district. **Approve** 

5. 2007-82

2.9 acres of property from RR to PUD located at New Berlin Road at the intersection of Cedar Point Road. Current land use category LDR. The proposal is for Commercial and Professional Offices. Approve with the condition that linkage be made to both residential development, both to the east and west of this property. Also limit operational hours of the gas station at night.

6. 2007-86

39.12 acres current land use category LDR, BP. Located between Duval Road and Interstate 95, north of Cole Road. The proposed development is a 240 unit town home subdivision. The developer seeks justification for planned unit development classification for this project. **Approve**, **6 opposed**
