**Mayor's Representative** – Randy White was excused from tonight's meeting. Gene Callahan reported that Fire Station 35 might be completed in 1.5 years.

**Councilman Warren Alvarez** – C/M Alvarez has not received input regarding the parks program. Annually, 5,000 – 7,000 visitors go to Huguenot Park. Only three portable toilets are available. Updates were provided regarding various north district projects.

**Jacksonville Sheriff's Office** – Assistant Chief Jones provided crime statistics. Crime is up 6% compared to last year.

**Building Inspection Division** – no report

**Property Safety Division** – Del Miley provided information regarding a recent Sheriff's Walk. A number of citations were written during the walk. He praised code inspectors for doing a good job.

**Consumer Affairs Division** – Ty Burke reported that 182 Superbowl inquiries have been received from outside vendors. So far, none have been from Jacksonville. Vendor requests have come from Canada, Mexico, and the Islands. Vendors are required to post a permit at all times and can now be removed by Consumer Affairs personnel.

Currently, there is no ordinance addressing motorized scooters. Their quality is very poor. Consumer Affairs is currently working with feds regarding these scooters.
