Governmental Affairs – report given by Tommy Ruffin

AD-05-173 Request to increase the maximum height of a structure from 15' to 20' for a proposed garage. Property is located at 10812 Alta Drive. Approve

2005-1111 Rezoning of approximately 4.12 acres between Boote Drive Boulevard and Glen Drive from RR to RLD-F (Residential Low Density-F) for the development of 14 dwellings. **Approve**

2005-1156 Rezoning of property located between Bowie Road and Harrell Road from CO to a PUD (New Kings Road PUD) for the development of a mixed use project – office/warehouse buildings and storage units. No residence is in close proximity to the property. **Approve**

2005-1157 Rezoning of 57.7 acres from RR to a PUD (Hampton West PUD). Property is located North of Dunn Avenue, West side of V. C. Johnson & South of Angel Lakes. The PUD seeks approval for 152 single family dwellings at a gross density of 2.63 units/acre. Dimensions: Lot 60'; setbacks – front 20', sides 5' & back 10'. **Motion failed; Approve – 4, Opposed – 9**

2005-1158 Rezoning of 39.9 acres from RR to a PUD (Hampton East PUD). Property is located at 11859 V.C. Johnson Road (North of Dunn Avenue). The PUD seeks approval for 71

dwellings at a gross density of 1.8 units/acre. Minimum lot width -60° and setbacks - front 20°, sides 5° and rear 10°. **Motion failed; Approve** -4, **Opposed** -9

<u>2005-1244</u> Rezoning of 11.56 acres from RR to a PUD to allow for the development of Yellow Bluff Townhomes, Phase II – a maximum of 7 units/acre. Property is located at 12780 Yellow Bluff Road (between Berlin Road and Starratt Road). **Approve, Opposed** – 1

2005-1249 Waiver of minimum road frontage application (WFR-05-31) to reduce the minimum road frontage requirement from 180 feet to 120 feet. Property is located at 14204 Grover Road (between Starratt Road and Fox Meadow Lane). This application is not scheduled for hearing until December. **Defer**

2005D-017 was disapproved at the October 12, 2005 meeting. Additional information about this development was provided at tonight's meeting. As a result, Arthur Sullivan made a motion to reconsider. Ed Andrews seconded the motion. The motion passed. Harry Wagner made a motion to approve the bill. Arthur Sullivan seconded the motion. The motion passed.

2005D-017 Land Use Amendment to change approximately 56.11 acres from AGR-III and 11.60 from AGR-IV to MDR and a Companion Rezoning to rezone the property from AGR to a PUD. The property is located on New Kings Road, north of Acree Road. **Approve**
