Property Safety Division – Danny Connell reported that 150 to 200 complaints are being handled each month.

Duval County School Board - no report

Planning and Development Department – Doug McDowell announced that Brad Thoburn is the department's interim director.

Florida Department of Transportation (FDOT) – Milton Locklear reported that so far there has been no resolution to the peeling traffic signal devices on Lem Turner Road. A study is currently being done at the Lem Turner Road and I-295 interchange. Though the study will be completed in the next month, funds are not available for the area at this time.

Duval County Health Department – Jocelyn Turner announced that Dr. Robert Harmon, new director of the health department, is having a town hall meeting here tonight. Pneumonia vaccines are available all year. Flu vaccines will be available at the end of the month.

Neighborhood Services Division – Cami Cooper announced that Mayor Peyton's town hall meeting will take place Monday, Oct. 16, at 6 p.m., in the First Coast High School auditorium, 590 Duval Station Road. Copies of the mayor's presentation on Sept. 13 are available on the back table.
