- 1. Chair Bill Baker called to order and Amy Holliman verified quorum. Organizations represented: 18 of 35 = 51% membership represented.
- 2. Presentation: Mayor Peyton presented his proposed budget for 2007/08. Highlights included comparisons of Jacksonville's millage rates and spending to comparable Florida municipalities. Mayor Peyton feels the best budget option is to both cut spending and increase revenue. He outlined his proposed budget reductions and the proposed fees for solid waste collection, storm water run-off and JEA franchise. Most homeowners will still have a substantial savings after the fees when considering the state proposed property tax reform.

- **4.** The amended **by-laws** were submitted for approval. Harry Wagner made the motion to approve the proposed changes as submitted with the second by Dick Berry. The by-laws were unanimously approved.
- 5. CPAC Chair Bill Baker asked for volunteers for the TRUE Commission and the SWAC.
 - Dick Berry volunteered for the TRUE (Taxation Revenue Utilization and Expenditures) Commission.
 - Lake Ray volunteered and stated that although he is not a member he would be happy to represent and report on behalf of the North CPAC on the SWAC (Storm Water Advisory Council).

- **D.** Harry Wagner, chair of the **Membership Subcommittee**, introduced Donald Sanderson, our newest CPAC member from Ashford Wood.
- **E.** Dick Berry, chair of the **Transportation Subcommittee** reminded everyone about the meeting with JaxPort tonight regarding the ferry at Highlands Middle School at 7 p.m.

7. Staff Reports

- A. Rick Godke, Mayor Peyton's representative, felt Mayor Peyton said it all.
- **B.** Milton Locklear from the **Florida Department of Transportation** reported that there will be a public meeting about the Heckscher Drive Shad Creek Bridge replacement on Oct. 30, from 4:30 to 7:30 p.m. at the Heckscher Drive Community Club.
- **C.** Jacksonville Sheriff's Office a representative for Asst. Chief Michael Rutledge reported that there have been four home invasion robberies in the New Berlin area. All other crimes are down in the district.

- **D.** Jocelyn Turner from the **Duval County Health Department** had no report but would like the opportunity to present the strategic plan at a future CPAC meeting.
- **E.** Terri Lindemann from the **Property Safety Division** went out to The Cape for a reported junk vehicle. The owner has since removed the vehicle. At Eagle Bend a gentleman was told to move a junk car and he complied. It may not be in compliance with the homeowner's association but it is in compliance with the city.
- **F.** Paul Davis from the **Planning & Development Department** said that he continues working with the Governmental Affairs subcommittee and will e-mail all recommendations to his colleagues in the Planning Department. There will be a workshop on Sept. 17, if anyone interested in land use issues.
- **G.** Amy Hays Holliman, **Neighborhood Services Division** reported that the Sister's Creek Bridge will not be closed for extended periods of time. At a public meeting at Heckscher Drive Community Club, FDOT explained that the bridge will have to close late at night while they remove the old pilings, but will not need to close while constructing the new skirting. She announced the Senior Games next month and that flyers are available. She reminded everyone of the meeting tonight at Highlands Middle School about the Jacksonville Ferry. Dot Mathias would appreciate all our support.

8. New business

- Harry Wagner motioned that we support Mayor Peyton's budget proposal. Seconded by Mary Thompson. Motion passed with one opposed.
- Harry Wagner motioned that we show our support for Mayor Peyton by writing a letter and submitting it to the city council before the budget meeting and Ed Andrews seconded. Motion passed with one opposed.
