- **1.** The meeting was called to order at 4 p.m. by Vice Chair Mike Getchell. A quorum was verified by Mary Beth Ridderman, Coordinator, Community Development Division, Housing and Neighborhoods Department.
- 2. **Presentation** William Taylor, Ghyabi and Associates, presented the North Area Transportation Study. Copies of the study were provided to all in attendance. A question and answer session followed the presentation and Charter Member Dick Berry assisted Mr. Taylor with answering questions. Chair Bobby Taylor thanked Mr. Taylor for his presentation and thanked Mr. Berry for suggesting the presentation

- and contacting the speaker.
- 3. The summary of the previous meeting was approved with the following correction: Page 2, the last line should read East instead of West.
- 4. Old Business none
- **5. Chair's Report -** Chair Bobby Taylor:
 - o Apologized for arriving late for the meeting, he was caught in traffic. He thanked Vice Chair Getchell for calling the meeting to order.
 - o Announced that notices of meetings of the Governmental Affairs (GA) any other subcommittee is available electronically. Although it was necessary to reduce the number of members on the Governmental Affairs subcommittee, everyone is welcome to attend the meetings. The criteria for removal from the GA subcommittee was last on-first off.
 - o Announced that last month Mike Sweat, the Mayor's Liaison, suggested Power Point be made available for presentations to the CPAC and the GA subcommittee. FCCJ does not have the technology in the meeting room only a screen is available. He asked for a volunteer to bring a lap top, projector and power cord to each meeting.

6. Staff Reports:

- B. JSO Chief Michael Rutledge reported:
 - o In the past thirty days, no abductions, no sexual batteries and no home robberies were reported in Zone 6. One individual was robbed at the Sprint Store. One car jacking occurred at Monaco Street next to the Food Mart. Two businesses were robbed: the Kangaroo at New Kings and the Kangaroo at Starratt Road. Gang graffiti was reported in Sector Q at Sago and Airport Center Drive; JSO is investigating, but they believe the graffiti is the work of school age kids who want to identify with specific gangs but are not actually gang members.
 - The April 2 Sheriff's Walk was well-attended and he thanked those who had participated.
 - The PERF Grant has funded a study and the results will be reported at a later date. Chair Taylor thanked Chief Rutledge for his report

C. Mayor's Representative - Mike Sweat announced

- The COJ is involved in budget planning with the goal of reducing overall spending while maintaining or increasing services.
- o The Extension Office offers classes on various subjects.

- **D. City Council Member's Reports –** No one present no reports.
- E. Duval County School Board Vicki Drake reported: due to budget cuts, bus routes were changed to begin at two miles from schools the same as the State mileage requirement. Transportation to magnet schools will not be cut. The legislature is currently working on their budget. The Senate utilized stimulus monies. Chair Taylor thanked Ms. Drake for her report.
- **F. FDOT** Milton Locklear announced a public hearing is scheduled for April 20, 2009, at the San Marco Llbrary/Balis Community Center, 1513 LaSalle St., 32207. The purpose of the hearing is to discuss the I-95

- Overland Bridge Replacement Project. Doors open at 4:30 p.m. to allow time to view the exhibits. The hearing will begin at 6:30 p.m. Mr. Locklear provided copies of the notice. For more information, call 360-5686.
- **G. Duval County Health Department** Jocelyn Turner announced she was available for questions.
- H. Municipal Code Compliance Maria Buckwalter answered a question that arose during the March meeting the systematic inspection in Garden City resulted in 50 new cases. A systematic inspection in Brentwood resulted in 94 new cases. She asked that residents contact her if they know of other areas in need of systematic inspections. Mike Getchell suggested she conduct a systematic inspection at "Jake's Place" mobile home park on Yellow Bluff Road North of Starratt. Jim Breland commented the systematic inspection in Garden City resulted in a lot of improvements but tractor-trailers remained a problem for the neighborhood. Chair Taylor thanked Ms. Buchwalter for the work done by the Zone 6 team and thanked her for her report.

I. Planning and Development -

- O David Kaufman, Senior Director of Planning, Jacksonville Port Authority, reported that the JAXPORT Master Plan requires updates public meetings will be scheduled to discuss goals, objectives and policies. Copies of the Master Plan Update were provided and may be downloaded from www.coj.net/Departments/Planning+And+Development/Community+Planning/default.htm. Questions were raised about the cruise terminal information is not included in the Master Plan. Mr. Kaufman said the plan may be revised at a later date. Concerns were expressed about the Mayport Ferry with only one boat, service is unreliable and the ferry service hours are not long enough. Discussion was held about possible funding sources. Mr. Kaufman replied that lobbying would be helpful if the community is interested in federal funding or grants.
- Paul Davis announced he was available for questions.
- J. Rereation and Community Nathan Rezeau reported Spring Activities Guides for parks are available. He provided copies of the Activities Guide and the JaxParks Aquatics Programs brochure. A question was raised about Old Palms Fish Camp. Mr. Rezeau said the contract was awarded in 2006, but the contractor cited an economic hardship. The latest deadline is September, 2009. Ms. Leigh inquired about having trash cans installed at the entrance to major fishing bridges to reduce litter. Mr. Breland expressed his concern about the ice cream vendor at Huguenot Park the vendor's sound system is a public nuisance. - A. Governmental Affairs:
 - Subcommittee Chair Getchell thanked Charter Member Dick Berry for chairing the April 2 meeting and for running a very efficient meeting, which lasted only one hour and twenty minutes. Mr. Berry prepared and provided copies of the meeting minutes.
 - Greg Kupperman presented information about Bill #2008-541, 2008-542 and 2008-549.
 - A discussion was held about #2008-538. Mr. Berry said the Times Union had presented good information about both sided of the issue. Questions were raised about Republic's position. Chair Taylor recognized Tom Ingram and asked him to answer the questions. The discussion was called. A motion was made and seconded to defer taking a position until more information is obtained. The motion passed.

- **B.** Beautification: Subcommittee Chair Arthur Sullivan said he had no report. Ms. Leigh said she wanted to know what the Beautification and other subcommittees do and when they meet. Mr. Sullivan reported the Beautification subcommittee observes what needs improving or

beautifying. At this time he is the only member of the subcommittee so there are no meetings. Chair Taylor announced that except for the Governmental Affairs Subcommittee and Transportation Subcommittee, the subcommittees consist of one person and no meetings are noticed or scheduled. The CPAC By-Laws require three members on each subcommittee and volunteers are needed for Beautification and Membership. Mary Beth Ridderman suggested the subcommittees meet just prior to the CPAC meetings – she can prepare the notice of meetings on the CPAC agenda and can provide a simple form for minutes. She asked that each subcommittee submit minutes of each meeting to her so the minutes may become part of the public record.

- C. Membership: Subcommittee Chair Harry Wagner was excused. Jim Breland said he had called Mr. Wagner about the Membership Subcommittee but had not received a reply. Chair Taylor said he would ask Mr. Wagner to talk with Mr. Breland about what the subcommittee does.
- D. Transportation: Subcommittee Chair Dick Berry announced:
 - o Rex Neidlinger and Nancy Landau had volunteered for the Transportation Subcommittee and they would provide notice of their first meeting soon. Chair Taylor appointed Mr. Berry as subcommittee chair and appointed Ms. Landau and Mr. Neidlinger as subcommittee members.
 - Mary Beth Ridderman sends reports from FDOT and JTA electronically.
 He suggested members and guests provide their e-mail addresses to
 Ms. Ridderman to and request to be added to her distribution list.
 - o Mr. Berry attended a citizens advisory group meeting at the Transportation Planning Organization and the group may recommend which projects should receive stimulus funding.
 - Mr. Berry made a motion to approve the North Area Transportation Study. Mike Getchell provided a second. All were in favor/none opposed.

8. New Business: None

- **A.** Richard Bryant announced construction on Old Buddy's Fish Camp is scheduled to begin within 90 days. The old boat ramp will be closed.
- **B.** Richard Bryant announced the National Park Service may receive stimulus dollars. If the money is available, college students will be hired for seasonal jobs (eliminating unwanted plants in the parks).
- C. Jocelyn Turner, as a resident, announced the American Cancer Society North Jacksonville Relay for Life on April 17-18. She inquired about placing signs at the entrances to nearby neighborhoods. Tamara Kitchens, North Creek, asked to have a sign. Kathy Myers said her neighborhood, Ashford Wood, creates their own signs each year and prepares a luminary each year to celebrate the event. Ms. Turner said the music may be loud at times. Mr. Breland said the music should not be permitted. Ms. Myers

replied that her neighborhood is adjacent to the relay site and they enjoy the music and have no objections.

10. Adjourn: A motion was made and properly seconded to adjourn. The meeting was adjourned at 6:22 p.m.
