- 1. The meeting was called to order at 4 p.m. by Chair William Baker. A quorum was verified by Mary Beth Ridderman, Coordinator, Housing and Neighborhoods Department.
- 2. The **summary** of the previous meeting was approved.

3. Old Business: none

- 4. Chair's Report: Chair Bill Baker announced that Dot Mathias may be back next month because Bill is home from the hospital. She asked him to thank members for their prayers.
- 5. JSO Report: Chair Baker introduced Assistant Chief Michael Rutledge and reminded the members that JSO had been moved up on the agenda the officers could give their reports and get back to work. Assistant Chief Rutledge reported a slight increase in the numbers of violent crimes had occurred in Zone 6. The number of robberies decreased. He reported a slight increase in the number of auto burglaries all of the cars were unlocked. He reminded residents to lock their cars, even when in their own driveways; do not leave the garage remote control in the car. The numbers of residential burglaries increased. He suggested alarm systems as valuable tools and reminded residents to turn on the alarm when they are at home, especially when they are working in the yard. He asked residents to use caution when shopping do not leave packages in the car, hold keys in hand when leaving the store, use the buddy system when shopping, and avoid shopping at night.
- 6. Election of Officers: Nominations Chair Tommy Ruffin thanked Jennelle Bray and Mary Thompson for their work on the nominations subcommittee. He announced the slate of officers: Bobby Taylor for chair, Jack Stewart and Mike Getchell for vice chair. He asked for nominations from the floor for chair and vice chair. No nominations were received. A motion was made and properly seconded to close the nominations. All were in favor – nominations were closed. The Nominations Subcommittee provided ballots and tabulated the ballots. Bobby Taylor was elected chair. Mike Getchell was elected vice chair.

 Bobby Taylor said Council Member Ray Holt had asked for comments regarding Ordinance 2008-969. No action was needed. The ordinance was passed by City Council on November 25, 2008 but it has not been enacted. Vice Chair Taylor reported the full text of the ordinance is on-line. A discussion was held about the ordinance, which creates major changes in the zoning code. Concerns were expressed regarding reduced set-back requirements, height limitations, identity of the lobbyist and the identity/intent of the person who sponsored the ordinance.

 Bobby Taylor announced that a land use change (2008 E-083) will be presented by CPAC Chair Bill Baker. Chair Baker announced he will recuse himself from the CPAC's vote. He explained this is for an existing office building which he renovated and has leased to a non-profit organization for a daycare. Questions were asked and answered regarding parking,

Bobby Taylor announced the next meeting of the Governmental Affairs Subcommittee is scheduled for January 8, 2009, 4 p.m. at FCCJ North Campus, 4501 Capper Rd. Room 136 C. He congratulated Mike Getchell, Chair of the Governmental Affair Subcommittee for 2009.

- E. Duval County School Board Vicki Drake reported the revenue from the state for had been cut again. For example, staff will be reduced, the number of class periods may be reduced and cuts to transportation are being considered. Members and guests asked several questions and received answers.

- I. Recreation and Community Nathan Rezeau said the file on the First Coast High School Pool is being reviewed by the Office of General Council. Charter Member Berry expressed his concern that the property was deeded in 2006 and the bill was passed to fund the pool but nothing has happened. He said he was also concerned about the city's negligence in maintaining parks and picking up garbage. Mr. Rezeau said he had submitted a CARE issue. Member Sullivan discussed his concern regarding the park on Harts Road – the bathroom exterior needs renovating and painting and the doors need to be replaced.
