- **2. A presentation** was made by attorney Carla Miller, COJ Ethics Officer, about Ethics and government. The COJ has a new, innovative Ethics Code stronger than most cities in the U.S. and many changes are in progress. The COJ began a Whistleblowers Hotline. - **B. Education Subcommittee** Vicki Drake reported the Duval County School Board will have increased budget cuts due to the tax referendum. To try to meet operating expenses, DCSB may increase the school's portion of property taxes. She added that her neighborhood, Little Marsh Island, is experiencing a rash of car/home break-ins and vandalism from children who are not in school during the day.
- C. Beautification Subcommittee Arthur Sullivan reported that JaxPride Week is February 23 March 7 and suggested residents take part in neighborhood clean-up projects.
- D. Membership Subcommittee Harry Wagner introduced members: Ashford Wood Kathy Myers; Dinsmore Civic Association Cheryl Jones and Janet Pringle; Woodmont Esther Sumpter. Chair Baker mentioned the three meeting rule and reminded everyone that after three meetings their CPAC membership automatically ends. He asked Mr. Wagner to use his discretion to contact members who have missed two meetings and said that several members will be removed before the next meeting.
- **E.** Transportation Subcommittee Dick Berry announced a meeting tonight at 6 p.m. at FCCJ North, Room A286. The subject is the North Jacksonville Area Transportation Study and proposed projects for the next 20 years. Chair Baker thanked all of the subcommittee chairs for their reports.

A. Mayor's Representative - Rick Godke announced the city quarterly department reviews are in process. Training is underway at the Duval County Extension regarding use of water, pesticides and fertilizers. He offered to send a copy of the proposed fertilizer ordinance, upon request. University of Florida IFAS Extension could possibly

take some large budget cuts by the state. A large portion of the Duval County Extension budget comes from the state, so the cuts could have a negative effect on the services provided to the Duval County Extension. - F. Municipal Code Enforcement Terri Lindemann announced her division has been making systematic inspection in Polly Town and San Mateo. She said she will check on the reported issues at Meadowlea (Woodmont). She and other officers are now performing zoning and code compliance. Ms. Lindemann suggested that anyone can provide input to the Special Master hearings. The Special Master hearing process has improved, for example, resulting in reduced time for orders to abate.
