1. The meeting was called to order at 4:00 p.m. by Vice Chair Mike Getchell, who announced that Chair Bobby Taylor would be late due to his job requirements. A

- 4. Guest Speaker Joe Whitaker from JEDC provided information about the Recovery Zone. Last night, the City Council passed Bill# 2009-711 regarding the American Recovery Investment Act. Certain areas will be designated Recovery Zone (RZ) and will allow the City to issue Recovery Zone bonds for private and public projects that promote job creation and economic recovery. These areas include: the Enterprise Zone, Empowerment Zone, Community Redevelopment Areas and former NAS Cecil Field. A question and answer session followed the presentation. - E. FDOT Milton Locklear announced

- **A.** Governmental Affairs: Governmental Affairs Subcommittee Chair Mike announced:
 - The bus shelter advertising ordinance passed City Council after a long debate and public comments session. Ten Council Members sponsored the bill.
 - Bills 2009-515, 516 and 517 were filed to withdraw the stormwater and waste fees.

- A new policy was enacted for COJ employees to monitor documentation at the Court House construction site to assure no more illegal employees are hired. An oversight committed will check COJ monitoring results.

- Governmental Affairs Subcommittee Chair Mike Getchell announced the next meeting of the Governmental Affairs Subcommittee is scheduled for November 5, at 4 p.m., Florida State College at Jacksonville, North Campus, 4501 Capper Rd. Room 136 C.
- Member Nancy Landau commended Subcommittee Chair Getchell for a detailed report. Chair Taylor commended Mr. Getchell for doing a good and diligent job.

- C. Transportation: Subcommittee Chair Dick Berry reported:
- The North Florida TPO has proposed \$4 billion for 73 projects. Projected improvements to I-95 include widening I-95 to 8 lanes from downtown to the Trout River Bridge and a cloverleaf flyover I-95 at I-295.
- Alta Drive will receive paved shoulders this year and eventually will be fourlaned to Heckscher Drive.
- A toll road is being discussed for the Outer Beltway and also tolls on I-295 from I-10 to I-95 with special lanes blocked for toll lanes.
- D. Nominations: Subcommittee Chair Gerie Leigh's absence was excused. Acting Subcommittee Chair Mary Thompson announced the slate of officers: Bobby Taylor for Chair and Mike Getchell for Vice Chair. Mrs. Thompson said the committee, which included Gerie Leigh and Roland Biederer, had received no other nominations. She commended the officers for doing a good job in 2009 and added that Taylor and Getchell were willing to continue to serve the CPAC. She asked for nominations from the floor. No nominations were received. Mrs. Thompson said nominations will be accepted on Nov. 18. The election will be held on Nov. 18.
