JOHN KEANE ASKED CHAIRMAN BUSSELLS IF COUNCIL MEMBER BILL GULLIFORD COULD SPEAK TO THE BOARD PRIOR TO THE AGENDA REGARDING HIS PROPOSED BILL TO CITY COUNCIL.

IF NEEDED, THE BOARD WOULD MEET RAPIDLY TO PROCEED WITH THE PROCESS.

TRUSTEE HERBERT APPRECIATED COUNCIL MEMBER GULLIFORD TAKING TIME TO COME TO THE BOARD MEETING AND REALIZING HOW CRITICAL THIS PENSION ISSUE IS. HE THANKED HIM FOR HIS LEADERSHIP.

TRUSTEE SCHMITT THANKED GULLIFORD FOR ATTENDING OUR MEETING. WE HAVE THE SAME GOALS TO GET TO THE SAME PLACE.

TRUSTEE GLOVER COMMENDED GULLIFORD AS WELL. WE NEED TO MAKE SURE WE HAVE AN APPEALING PACKAGE FOR OUR NEW MEMBERS.

COUNCIL MEMBER GULLIFORD APPRECIATED THE BOARD'S COMMENTS. WE STILL HAVE A FUNDING ISSUE. HE PROMISED IN THE NEXT FOUR YEARS TO GET THIS RESOLVED.
