NEW BUSINESS – ITEMS 2014-08-(1-10)

2014-08-1 Personnel Committee

JOHN KEANE REFERRED TO TRUSTEE HERBERT, PERSONNEL COMMITTEE, FOR DISCUSSION. TRUSTEE HERBERT ADVISED THAT THE EXECUTIVE DIRECTOR – ADMINISTRATOR 2014 EVALUATION FORMS WERE DISTRIBUTED TO THE BOARD OF TRUSTEES FOR COMPLETION. PLEASE NOTE THAT CHANGES WERE MADE TO THE FORM. THE PERSONNEL COMMITTEE ASKED JOHN TO CHECK WITH OTHER COUNTERPARTS AND INSTITUTIONS AROUND THE STATE TO SEE WHAT INSTRUMENTS THEY WERE USING. WE HAVE SINCE DISCOVERED THAT THEY ARE NOT DOING MUCH OF ANYTHING AT ALL.

THE NEW FORM WAS BROKEN DOWN INTO TWO PARTS. ONE PART CONSISTS OF THE CORE COMPETENCIES OF THE DAY TO DAY OPERATIONS AND THE SECOND PART FOCUSES MORE ON THE FINANCIAL MANAGEMENT. GREATER WEIGHT WAS GIVEN TO THE FINANCIAL ASPECTS OF THE INVESTMENT SIDE. THIS IS A WORK IN PROGRESS.

TRUSTEE HERBERT WOULD LIKE TO GET THE BOARD'S FEED BACK AS TO WHAT YOU THINK. THERE ARE STILL A FEW ITEMS TRUSTEE HERBERT WOULD LIKE TO SEE IN THE EVALUATION. TRUSTEE HERBERT WILL TAKE THE INFORMATION AND COMPILE THE RESULTS AND THEN REPORT BACK TO THE BOARD BY THE NEXT MEETING. ANY COMMENTS YOU MIGHT HAVE, TRUSTEE HERBERT WILL CONSOLIDATE THOSE IN THE RESULTS.

SECTION FOUR CONTAINS ALL OF THE GOALS, ALL OF THE ASSIGNMENTS THAT WERE SUBSTANTIVE THAT THE BOARD GAVE JOHN, AND WHAT WAS ACCOMPLISHED DURING THE YEAR.

ESTABLISH THE GOALS FOR NEXT YEAR IN THE LAST SECTION FOR WHICH HE WOULD BE HELD ACCOUNTABLE.

THE PENSION OFFICE WILL SEND SOMEONE TO PICKUP FROM EVERYONE SOMETIME NEXT WEEK.

TRUSTEE TUTEN SAID THERE HAS TO BE SOME PART LEFT OPEN BECAUSE SO MUCH OF THIS JOB TAKES THE EXECUTIVE DIRECTORS TIME AWAY FROM OUR OBJECTIVES SET FORTH. THIS SHOULD BE TAKEN INTO CONSIDERATION.

TRUSTEE HERBERT SAID THAT SOME OF THAT COULD BE CAPTURED IN THE CONTEXT OF SOME OF THE QUESTIONS WE ALREADY HAVE. COMMENTS ARE WELCOME AT EACH SECTION AND AT THE END, MORE COULD BE ADDED.

TRUSTEE HERBERT SAID AS PART OF THE EVALUATION PROCESS OF THE DIRECTOR, JOHN IS OBLIGATED TO CONDUCT EVALUATIONS FOR THE STAFF. THERE WERE SEVERAL DIFFERENT INSTRUMENTS USED IN THE EVALUATIONS DUE TO THE NATURE OF VARIOUS JOBS.

JOHN EXPLAINED THAT HE USED THE NINE CORE COMPETENCIES FOR THE EVALUATION OF ALL OF THE STAFF. THE TENTH COMPETENCY WAS USED FOR TROY SCHERBINSKI, BUILDING MANAGER, BECAUSE IT INCORPORATED SAFETY. THE THINGS THE PEOPLE DO, COMMUNICATION WITH OUR MEMBERS, THEIR INTERACTION WITH THE MEMBERS, AND ONGOING EFFORTS. EACH EMPLOYEE WAS RATED ON EACH SEGMENT OF THAT.

THE BIGGEST PROBLEM THAT TRUSTEE GLOVER FOUND WITH THE EVALUATION PROCESS WAS THAT THE EVALUATOR DID NOT KNOW WHAT THEY WERE DOING. AN OBJECTIVE EVALUATION IS MORE OF A CHALLENGE THAN YOU THINK IT IS.

TRUSTEE SCHMITT SAID CONSISTENCY IS IMPORTANT FOR HOW TO EVALUATE EMPLOYEES. WHAT IS IT WE ARE TRYING TO EVALUATE?

TRUSTEE HERBERT SAID FROM HIS PERSONAL PERSPECTIVE, THE IMPORTANT ASPECT OF THE EVALUATION IS THAT IT GIVES EMPLOYEES FEEDBACK OF HOW WELL THEY ARE DOING, ESPECIALLY IN CASES WHERE THERE ARE FINANCIAL REWARDS ASSOCIATED WITH THE EVALUATION. IT IS ESSENTIAL. WE ALL HAVE AN OBLIGATION TO HELP THEIR COLLEAGUES DO THE BEST THEY CAN. CHAIRMAN BUSSELLS SAID GENERAL COUNSEL TOLD THE BOARD WE HAVE FIDUCIARY RESPONSIBILITIES TO OUR MEMBERS AND BENEFICIARIES. A CENTRAL PART OF THAT IS INVESTMENT MANAGERS, CONSULTANTS, AND THE STAFF MUST PERFORM TO A CERTAIN LEVEL. AS FIDUCIARIES, YOU NEED TO HOLD THEM ACCOUNTABLE FOR PERFORMANCE. IF YOU DON'T, YOU ARE VIOLATING YOUR FIDUCIARY RESPONSIBILITY, AND NOT DOING OUR JOB.

TRUSTEE GLOVER SAID YOU ARE ALSO VIOLATING THE PERSON YOU ARE EVALUATING. IF YOU'RE NOT WILLING TO LOOK THEM IN THE EYE AND TELL THEM YOU NEED TO DO THIS A LITTLE BETTER, YOU'RE NOT HELPING. WHAT YOU'RE DOING IS MAINTINING YOUR POSITION OF CONFIDENCE. THAT'S SOMETIMES IS INCONSISTENT WITH YOUR FIDICIARY RESPONSIBILITY. IT'S AN INSTRUMENT TO HELP THE PERSON.

TRUSTEE HERBERT SAID THE SECOND SECTION WAS PREPARED EXCLUSIVELY TO FULFILL THE CORE RESPONSIBILITIES TO OUR MEMBERS, AND HOW WELL THIS ORGANIZATION IS BEING RUN IN THE PROCESS OF DOING THAT.

JOHN KEANE SAID THE MEMBERS VOTE ELECTRONICALLY BY VOTENET. THEY CERTIFIED THE ELECTION.

TRUSTEE SCHMITT SAID THAT THE SYSTEM WAS FANTASTIC. NO COMPLAINTS, NO HICCUPS. THE MEMBERS CAN VOTE WHILE THEY ARE WORKING, NO MATTER WHERE THEY ARE WORKING.

JOHN SAID THIS SAVED US A LOT OF MONEY. THE ELECTRONIC SYSTEM IS MUCH EASIER TO VOTE. NOT AS TAXING AS IN THE PAST WHEN WE DELIVERED THE BALLOTS TO STATIONS, COUNTING BALLOTS, ETC.

TRUSTEE GLOVER SAID WITH THE WHOLE ELECTION PROCESS DO WE WORRY ABOUT DIVERSITY? WOULD DIVERSITY BE SOMETHING WE SHOULD WORRY ABOUT? GENDER? SOMETHING WE CAN HOPE FOR? JUST RAISED THE QUESTION. I DON'T KNOW THAT THERE IS ANYTHING WE CAN DO ABOUT IT.

JOHN SAID THAT'S UP TO WHO WANTS RUNS. WHO WANTS TO BE INVOLVED. THERE'S PROBABLY ONLY A HAND FULL OF PEOPLE THAT WOULD WANT TO BE INVOLVED. MOST DO NOT WANT TO TAKE ON THIS RESPONSIBILITY.

RIGHT NOW, JOHN STATED THE ADVISORY COMMITTEE IS ALL MALE, ALL WHITE, AND YOUNGER MEMBERS. AT ONE TIME IT WAS THE OLDER MEMBERS.

CHAIRMAN BUSSELLS ASKED IF THE FLORIDA STATUS REQUIRES THE ADVISORY COMMITTEE TO BE SELECTED LIKE WE DO IT? JOHN CONFIRMED YES. ELECTED BY THE MEMBERS. CHAIRMAN BUSSELLS ASKED IF THERE HAS EVER BEEN A WOMAN? JOHN SAID NO.

2014-08-3 Letter to City Council President Clay Yarborough re Ordinance 2014-377 – *attachment*

CHAIRMAN BUSSELLS SAID WE RECEIVED AS INFORMATION THE LETTER TO CITY COUNCIL PRESIDENT.

CHAIRMAN BUSSELLS ASKED IF THIS WOULD BE A GOOD TIME TO DISCUSS THE CITY COUNCIL BUDGET HEARINGS CONCERNING TWO POINTS THAT CONTINUE TO

BE POINTS OF DISAGREEMENT BETWEEN OUR OUTSIDE COUNSEL, BOB KLAUSNER, AND THE CITY'S COUNSEL ON THE AUTHORITY AND CONTROL OF OUR BUDGET AND THE SR. STAFF RETIREMENT PLAN. APPARENTLY, COMMENTS WERE MADE BY SOME COUNCIL MEMBERS THAT WE ARE DOING THINGS THAT ARE ILLEGAL WITH REGARD TO THESE TWO POINTS. IT KEEPS COMING UP.

CHAIRMAN BUSSELLS SAID SINCE THE CONTROVERSY CONTINUES, MAYBE WE SHOULD SEND A LETTER TO THE CITY COUNCIL PRESIDENT AND MEMBERS AND RECOMMEND THAT WE WOULD CONSIDER PARTICIPATING JOINTLY WITH THEM TO GO TO THE ATTORNEY GENERAL TO GET AN OPINION TO PUT IT TO BED.

JOHN KEANE SAID WE COULD GO DIRECTLY TO THE ATTORNEY GENERAL AND SEND THE COUNCIL COPIES, OR CALL COUNCIL PRESIDENT YARBROUGH TO JOINTLY REQUEST AN OPINION ON THIS MATTER TO RESOLVE IT ONCE AND FOR ALL. IF THEY DON'T WANT TO JOIN US, MAYBE WE CAN ASK FOR THE ATTORNEY GENERAL'S OPINION.

TRUSTEE GLOVER ASKED IF WE WERE OVERACTING TO SEVERAL OF THE COUNCIL MEMBERS? HE GETS THE SERIOUSNESS OF THE ISSUE. WHAT HE HAS FOUND IS THAT SOMETIMES THE OTHERS WILL LISTEN TO SOMEONE THEY THINK THEY KNOW, AND OTHERS MAY FOLLOW. IF WE IDENTIFY SOME OF OUR CRITICS WHO ARE TOTALLY WRONG IN THEIR ASSESSMENT OF THE SITUATION, AND IT'S THAT CLEAR, WOULD THERE BE ANY VALUE IN GOING TO LAY OUT THE FACTS TO THEM IF THERE IS AN OPPORTUNITY TO DO SO. IF THE ANSWER TO THE QUESTION IS NO, THEN THAT'S FINE. SOMETIMES YOU CAN CHANGE THE PEOPLES MINDS WITH FACTS BECAUSE GENERALLY THEY ARE TRYING TO DO THE RIGHT THING TOO, AND THEY FEEL STRONGLY ABOUT IT, BUT IT MAY BE BASED ON INACCURACY. MAYBE NOT NOW, BUT MAYBE FOR THE FUTURE.

JOHN SAID WE ARE NOT OVERACTING AT ALL WHEN THEY STAND UP AT A PUBLIC MEETING AND SAY THE PENSION FUND IS DOING SOMETHING ILLEGAL. THE STATEMENT CAME FROM THE LOCAL CRITICS OF THE PENSION FUND. I STRONGLY RECOMMEND THAT WE FOLLOW THE CHAIRMAN'S SUGGESTION AND GET THE ATTORNEY GENERAL'S OPINION AND PUT THE QUESTION TO BED ONCE AND FOR ALL. UNDER THE CHARTER, EVEN THE CITY COUNCIL HAS TO GO BY THE ATTORNEY GENERALS OPINION.

CHAIRMAN BUSSELLS AGREED WITH WHAT TRUSTEE GLOVER SAID. WE ARE TAKING THIS SERIOUSLY. IT'S A SIGN OF RESPECT TO THEM TO BE SURE WE ARE DOING THE RIGHT THING BECAUSE WE ARE CONCERNED THAT WE MAY NOT BE. OUR ATTORNEY IS TELLING US THIS IS THE RIGHT THING, WE CAN'T GO AGAINST THAT. BUT WE RESPECT THEM ENOUGH TO GO TO SOMEBODY THAT WE CANNOT INFLUENCE OR CONTROL WHAT THEY SAY. IF IN FACT WE ARE WRONG, WE WILL CHANGE IT.

JOHN SAID WE WILL OFFER THIS TRANSMITTAL LETTER FIRST AND WE WILL INCORPORATE THE WORDS CHAIRMAN BUSSELLS SAID THAT OUT OF RESPECT TO THE MEMBERS OF THE CITY COUNCIL AS AN ELECTED OFFICIAL. IF THEY SAY NO, WE HAVE OUR ANSWER AND LET COUNCIL GO DO WHAT THEY WANT TO DO. THEN WE WILL SUBMIT OUR LETTER TO THE ATTORNEY GENERAL. NOT MUCH TIME LEFT.

TRUSTEE HERBERT SAID WE HAVE AN OBLIGATION TO OUR MEMBERS. AS WE GO FORWARD TO THE ATTORNEY GENERAL, WE NEED TO BE VERY SPECIFIC AS TO WHAT THE QUESTION IS. LET'S IDENTIFY THE TWO OR THREE ISSUES THAT ARE A PROBLEM. DOES THE COUNCIL PUT US BELOW THE LINE? DO WE HAVE THE AUTHORITY TO ESTABLISH OUR BUDGET, OR IS IT THE COUNCIL'S PEROGATIVE TO ESTABLISH OUR BUDGET. FOR ALL PRACTICAL PURPOSES, IF WE CAN'T DO OUR JOB AND SPEND THE MONEY FOR MANAGEMENT FEES, WE CAN'T FULFLE OUR FIDUCIARY RESPONSIBILITIES AND OUR HANDS ARE TIED. THOSE QUESTIONS HAVE TO BE ANSWERED.

JOHN SAID JUST TO NOTE TO THE CHAIRMAN AND THE TRUSTEES, THE ISSUE ON THE BUDGET HAS BEEN FESTERING FOR A LONG TIME. FORMER ATTORNEY GENERAL, BOB BUTTERWORTH, ALREADY RULED ON THIS. SO WE GET A FRESH OPINION FROM PAM BONDI. IT MAKES IT EASIER.

ONCE WE GET A RESPONSE BACK FROM COUNCIL PRESIDENT YARBROUGH, WE WILL HAVE A LETTER DRAFTED. WE WILL MAKE SURE WE HAVE THE CONCILATORY TONE FOR THE LETTER CORRECT. THE TWO ISSUES, THE ADMINISTRATION OF THE FUND AND THE BUDGET. WHAT'S THE AUTHORITY OF THE TRUSTEES? THE ATTORNEY GENERAL WILL ANSWER THE QUESTIONS. END OF STORY. WE HAVE THE DIRECTION, AND WE WILL MOVE FORWARD.

WE HAVE ONE CASE THAT'S BEEN APPEALED TO THE FLORIDA SUPREME COURT. A SECOND CASE APPEAL TO THE FIRST DISTRICT COURT OF APPEALS WAS FILED THIS WEEK. ON THE DENTON CASE, THIS CASE WAS FILED BY THE MEMBER PLAINTIFFS NOT BY THE BOARD.

REALIGNMENT OF OUR ASSETS, WE NOW HAVE OVER \$371 MILLION IN INDEX FUNDS WHICH IS A SUBSTANTIAL AMOUNT. THOSE ARE THE LOWEST POSSIBLE RATES YOU CAN GET.

WE ARE TALKING WITH MORE PEOPLE TO BE ON THE INVESTMENT ADVISORY COMMITTEE. CHAIRMAN BUSSELLS HAS ANOTHER NAME TO PASS ON FOR THE COMMITTEE.

TRUSTEE HERBERT ASKED WHAT ARE WE THINKING IN TERMS OF FINALIZING THAT PROCESS AND HAVING ALL THE CANDIDATES IDENTIFIED? JOHN SAID AS WE DISCUSSED LAST MONTH, WE WILL HAVE THEM OVER HERE FOR AN INFORMAL MEETING BEFORE THE BOARD WITH KLAUSNER HERE TO EXPLAIN WHAT THEIR DUTIES AND RESPONSIBILITIES ARE. IN THE EVENT THAT THERE ARE COMPLIANCE ISSUES, AND THEY HAVE TO PULL OUT, THEN WE WILL CONTINUE TO FIND POSSIBLY RETIRED CANDIDATES WHO ARE NO LONGER TIED TO THEIR COMPANY AND DON'T HAVE THOSE COMPLIANCE ISSUES, BUT STILL POSSESS THE EXPERTISE TO ASSIST US.
