NEW BUSINESS

2012-06-13 Finance Committee Chairman John Crescimbeni has asked to address the Board of Trustees regarding the 2012/2013 Budget. Attachment

City Council Finance Chairman John Crescimbeni told the Board of Trustees that the Finance Committee felt that the Police and Fire Pension Fund 2012/2013 budget was unreasonable, specifically in the areas of administrative and legal costs, and would like the Board of Trustees to review and present a revised budget. In the meantime, the City Council has put the \$650,000 below the line and reschedule when they have time or on 1 of the 2 contingency days they have scheduled. Chairman Deal told him that the Board of Trustees would review the budget. Chairman Crescimbeni said the City Council would welcome any dialogue.

Chairman Deal mentioned that the Fund had sent letters to the Mayors and City Councils for the last 10 years concerning the unfunded liability but had not had any action. Chairman Crescimbeni said there wasn't too much the City Council could due that it was an administration matter.

Chairman Crescimbeni then presented a legal opinion from the City's General Counsel that said the Senior Voluntary Retirement Pension was not legal.

Trustee Bussells asked that the budget review be on the agenda for Friday, August 17th.

Chairman Deal asked Bob Klausner to give the Board of Trustees a brief history of how the SVRP came about, which he did. He stated that the Charter 22.04 states that the Board of Trustees has sole authority to compensate its employees. He also stated that both the General Employee's Pension and the State Retirement system would not allow noncity employees to be members. Therefore, the Board spent a year researching and discussing the options available before creating the current system. It had not appeared on the budget as it does this year due to their being no payouts. However, Donna Walmsley retired August 2011 and Dick Cohee's widow started receiving payments January 2012. The only other member at this time is John Keane, who is eligible to retire.

There are State rules regarding reporting though not creating. Florida State Statutes 175/185 say the Board is an independent agency and may have their own counsel. Mr. Klausner said that the City was aware of the SVRP as they had consulted him in the past on the possibilities of creating one themselves.
