NORTHERN TRUST DOES NOT HAVE THE AUTHORITY TO HIRE AN ATTORNEY.

STU KAUFMAN STATED THE FUNDING AGENT IS WORKED OUT IN THE INVESTMENT MANAGER CONTRACT. THE POSITIVES OF HAVING A MANAGER TO REVIEW IS SO THAT THE FUND IS NOT INUNDATED WITH PAPERWORK REGARDING THE CLAIM.

NORTHERN TRUST NOTIFIES INVESTMENT MANAGERS. NOTIFICATIONS BEGIN WHEN THERE IS A SETTLEMENT AND DEPENDING ON THE TYPE OF LITIGATION.

STU KAUFMAN STATED OUR ATTORNEY MONITORS THE FIRM THEN GOES TO US. ATTORNEYS ARE REIMBURSED FOR OUT OF POCKET EXPENSES, NOT FOR TIME (HOURLY FEE).

STU KAUFMAN SAID THE FUND HAS THE FIDUCIARY RESPONSIBILITY TO LOOK AT EACH CLAIM AND TO PARTICIPATE. WHY WOULD YOU OPT OUT TO PURSUE PRIVATE LITIGATION.

RICH MCCONVILLE INTRODUCED ANTHONY PECCATIELO TO DISCUSS COMMISSION RECAPTURE. ANTHONY HAS BEEN WITH NORTHERN TRUST FOR FOUR YEARS.
