



- This skylight design imposes dead, thrusting and uplift loads upon the structural curbs, by others. Curbs must resist all loads imposed by the skylight to AAMA's standard of L/750.
- Five (5) year skylight materials warranty from manufacturer.
- Glass is warranted for five (5) years from date of manufacture by supplier.
- Installation is warranted for five (5) years from completion and acceptance of our work.
