Mr Keane

Our plan does not require an amendment. It provides a benefit to a "spouse." Following the recent U.S. Supreme Court decision in the Windsor case, and the IRS guidance on treatment of same gender spouses, we advised the Fund that it should honor a same gender marriage entered into in a state which recognizes such unions. Florida's same gender marriage prohibition has been declared invalid by three state circuit courts and one U.S. District Court.

If the plan is presented with a valid marriage certificate from a participant, then the Fund must treat that certificate as valid regardless of the gender of the parties.

For our next tax filing, it may be appropriate to add a provision to our operating rules and procedures stating as follows:

"The plan shall treat the surviving partner of any marriage, following the death of the member, which was lawfully formed in the jurisdiction in which it was entered as a surviving spouse. The surviving spouse must be married to and residing with the member at the time of the member's death."

I trust the foregoing answers your questions.
