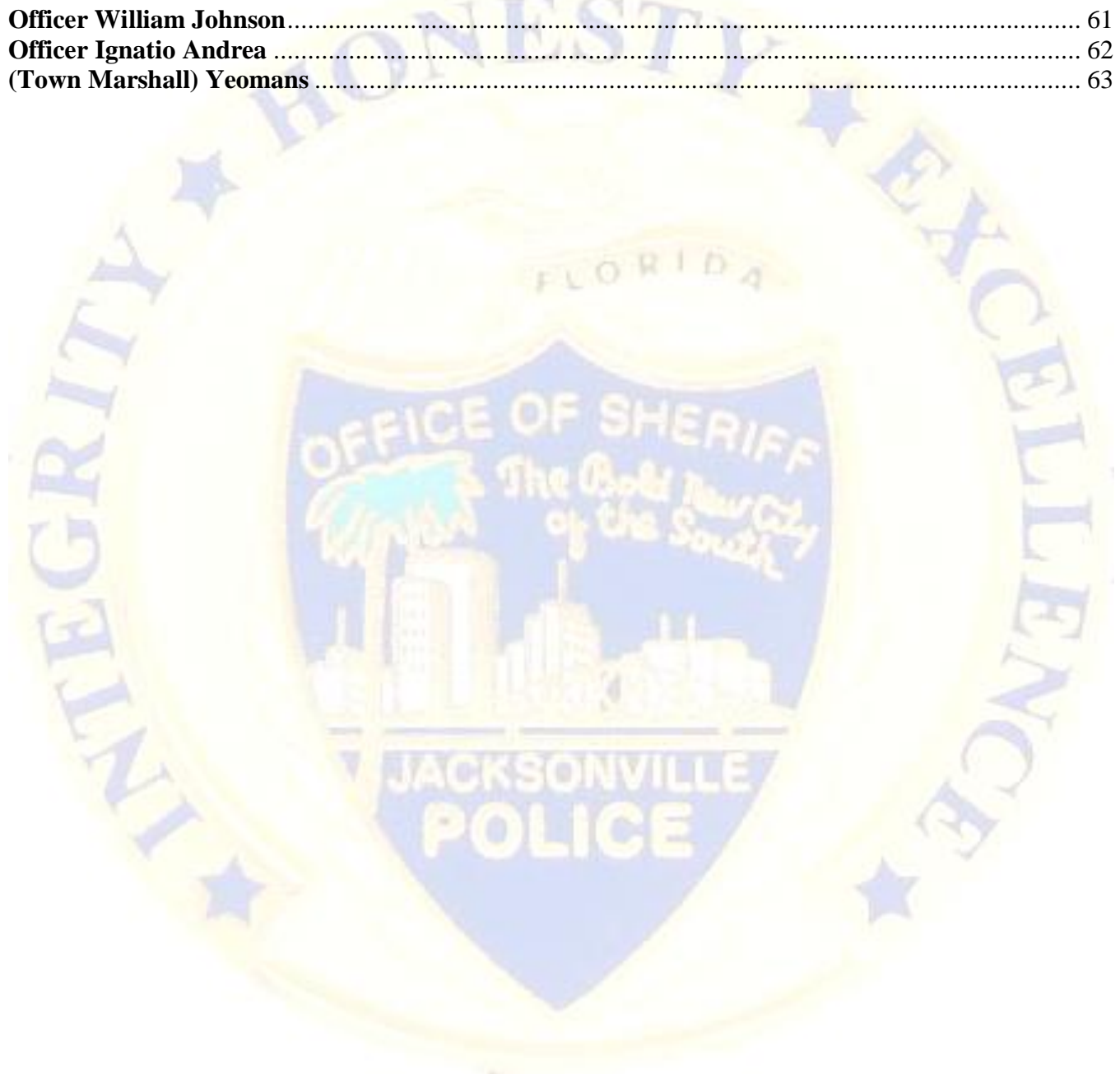

# Officer Christopher Michael Kane

Officer Christopher Kane was killed in an automobile accident in a construction zone on Route 9A.

He had finished speaking with an off duty officer working at the construction zone when his patrol car collided with the back of a semi that was carrying construction equipment.

Officer Kane had served with the Jacksonville Sheriff's Office for 12 years. He is survived by his wife and two children.

# Officer Scott Eric Bell

The officer was returning from a call on Heckscher Drive when a van traveling on New Berlin Road collided with his cruiser. Officer Bell's vehicle spun out of control and hit a power pole and burst into flames.

Officer Bell had served with the Jacksonville Sheriff's Office for 7 years. He is survived by his wife, mother, and brother.

## **Officer Wilbert Wiggins, Sr.**

Patrolman Wilbert Wiggins suffered a fatal heart attack while attempting to hook up a trailer to a police truck.

He and several officers were preparing to conduct a traffic operation on a local interstate, and Patrolman Wiggins was preparing some of the equipment. He collapsed as he was pulling a trailer towards the police truck. Other officers located him on the ground next to the truck after he failed to arrive at the location of the traffic operation. He was taken to a local hospital where he passed away the following day.

Patrolman Wiggins had been employed with the Jacksonville Sheriff's Office for 41 years, and is survived by his wife and three children.

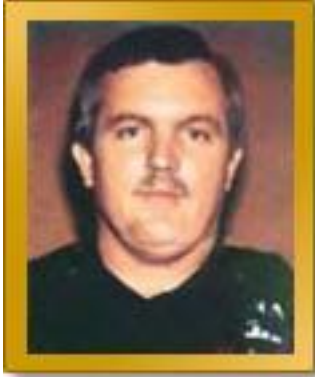

During the response he swerved to miss a dog and his cruiser then struck a tree on the driver's side. He was trapped inside for an hour before being freed and flown to a local hospital. Investigators estimated he was traveling at approximately 60 mph when the accident occurred. He is survived by his fiancée.

Officer Butler suffered the heart attack as he was in the process of rescuing a woman who had been pinned down between two cars by gunfire coming from the suspect. Officer Butler ran to her and gave her cover with his body as he returned her to a safe area.

The suspect was arrested later. Officer Butler is survived by his wife and children.

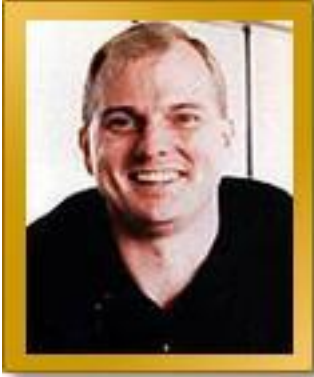
Officer Burtner was shot and killed after he had responded to a suicide call located at 7343 Ellwood Avenue. He was ambushed by the suspect with an AK-47. The suspect had left a suicide message as the greeting on his own answering machine and the police were notified after it was heard.

After efforts to contact the suspect failed, a decision was made to force entry. Officer Burtner breached the doorway of the house and was fatally shot. The suspect claimed self defense and stated that he thought his house was being burglarized. The suspect was convicted of manslaughter, four counts of attempted murder, and one count of armed robbery. He is eligible for parole in 2008.

Officer Burtner had served with the Jacksonville Sheriff's Office for 6 months. He is survived by his wife.

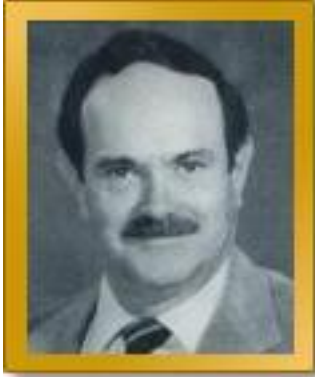

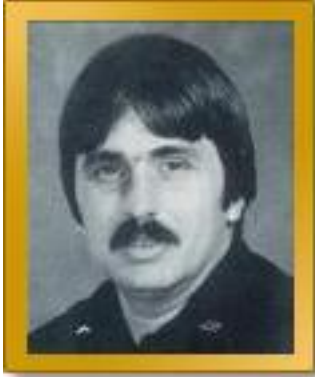

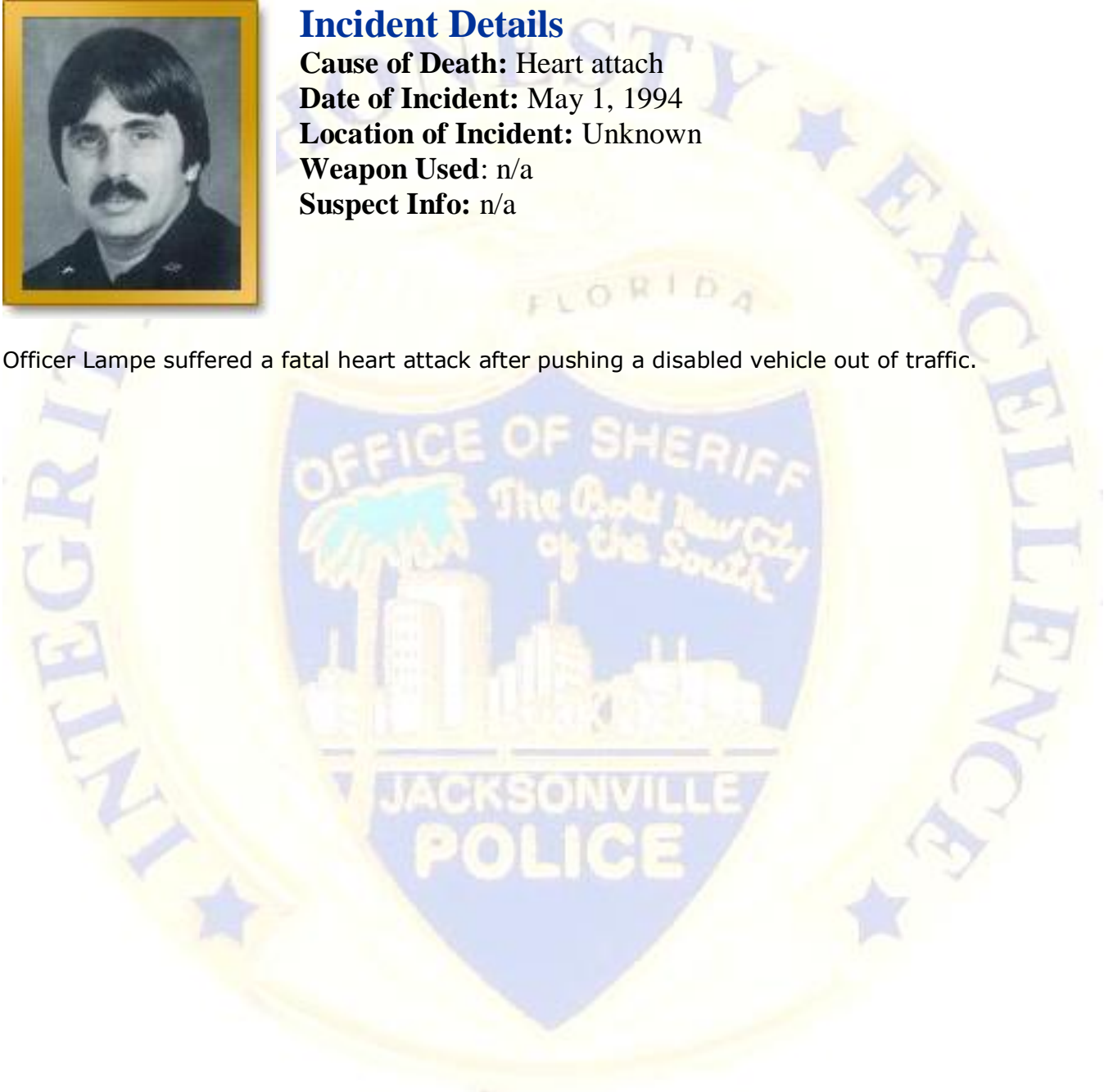

Officer Sanders was shot and killed while he and his partner were on an undercover assignment. Officer Sanders was sitting in a vehicle with another undercover officer when a subject pulled up next to them. The subject recognized the other officer as a police officer and began to flee. The other officer chased the suspect as Officer Sanders subdued the passenger in the suspect's vehicle.

After subduing the passenger Officer Sanders went to assist the other officer, who had chased the suspect into an apartment. As he entered the apartment he was caught in the crossfire of a shootout between the suspect and other officer. The other officer was shot several times, but survived. Officer Sanders was shot and mortally wounded.

The suspect turned himself in several days later and was sentenced to death for Officer Sander's murder.

Officer Sanders is survived by his wife.

# Officer Charles R. Shinholser, Jr.

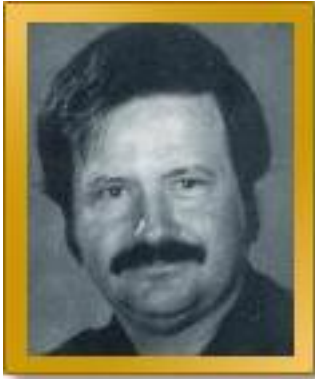

At the time of his death, Officer Shinholser was campaigning to raise money for a national memorial for officers killed in the line of duty. Officer Shinholser recorded a song to jump start his campaign.

Officer Shinholser had served with the Jacksonville Sheriff's Office for over 11 years. He was survived by his wife, two children and brother who is also a Jacksonville Police Officer.

Deputy Ritchey was blocking an intersection for the funeral procession. He then proceeded to ride to the front of the procession when a vehicle turned left in front of him out of the procession.

The suspect was sentenced to death in four separate trials, but each sentence was overturned by the Florida Supreme Court and her sentence was subsequently commuted to life in prison with the eligibility of parole. In February 2007, her parole request was denied.

Officer Stewart's death prompted a citizen campaign to donate money for the purchase of bullet proof vests.

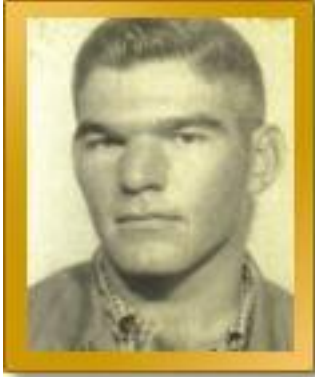

Officer Rainey had been employed with the Jacksonville Sheriff's Office for 17 years and was survived by his wife, daughter, son, two sisters, two brothers and mother.

# Officer Edward James Parker

## Jacksonville Sheriff's Office

**Date of Incident:** February 6, 1972

**Location of Incident:** W. 30<sup>th</sup> Street and Springrove Road

**Weapon Used:** Firearm

**Suspect Info:** Unknown, sentenced to life

Officer Parker observed a parked vehicle and pulled up behind it and exited his vehicle. He was checking on what he thought was an abandoned vehicle when the suspect jumped out and opened fire on him, striking him three times.

There were two females in the car with him that were being held hostage. The suspect had abducted them approximately thirty minutes prior to Officer Parker's arrival. The women were abducted from 5500 Soutel Drive. The suspect had already raped the woman in the front seat and was attempting to rape the second woman when Officer Parker pulled up behind them.

The suspect then stole an undetermined amount of money from Officer Parker's wallet, stole his service weapon, stole sixteen dollars from the two women and fled the scene. He was eventually apprehended and sentenced to life in prison.

Officer Parker had served with the agency for 9 years. He was survived by his wife and two daughters.

# Officer James Homer Moon

**Location of Incident:** Edison Avenue and Woodlawn Avenue

**Weapon Used:** Firearm, officer's handgun

**Suspect Info:** Calvin Wilbert, sentenced to life

Officer Moon was shot and killed with his own weapon as he and his partner questioned a mentally disturbed person. During the interview the suspect attacked the officer and gained control of Officer Moon's revolver and shot him in the head. He then shot and wounded the other officer. As Officer Moon lay in the street other citizens stole his hat and badge.

Officer Moon's murderer was sentenced to life in prison but was eligible for parole in 2003. On February 11, 2003, the parole commission and reviewed his case. The parole commission voted to suspend his parole at that time. The suspect will be eligible for another parole hearing in September of 2007.

Officer Moon had served with the Jacksonville Sheriff's Office for 2 years and was survived by his wife, son, parents, and two sisters.

## Officer David H. Reese

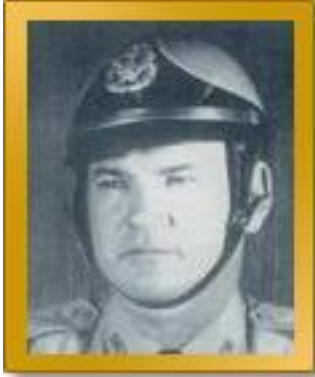

Officer Reese was killed in a motorcycle accident. Officer Reese was injured when his motorcycle collided with a tractor-trailer. Officer Reese was transported to a local hospital, where he succumbed to his injuries approximately an hour after the incident.

Officer Reese had been employed with the Jacksonville Sheriff's Office for nine years and was survived by his wife, son, parents, sister and two brothers.

# Officer Jake B. Edwards

Officer Edwards had been employed with the Jacksonville Police Department for 12 years and was survived by his wife, son and daughter.

## Sergeant W. L. Griffin

**Location of Incident:** 1905 River Road

**Weapon Used:** Firearm, rifle/shotgun

**Suspect Info:** Unknown

Sergeant Griffin was shot and killed during a burglary stakeout at 1905 River Road. Sergeant Griffin was assigned to the State Attorney's office as a special investigator. Due to frequent burglaries over a three year period, Sergeant Griffin, along with other officers, were assigned to a special stake out in the area of the burglaries. On the second night of the stake out, while police were inside a local residence, two suspects broke into the home. One suspect was armed with a shotgun, the other with a rifle. A gunfight ensued between the officers and suspects and Sergeant Griffin was struck in the crossfire by another officer. Sergeant Griffin succumbed to his gunshot wounds.

A total of eight arrests were made in connection with the burglaries Sergeant Griffin and other officers were investigating.

Sergeant Griffin was survived by his wife and daughter.

Officer Register had served with the Jacksonville Police Department for four years and was survived by his wife, parents and sister.

# Sergeant Charles Sea

**Suspect Info:** Unknown

Sergeant Sea was shot and killed after responding to a disturbance call located at N. Myrtle Avenue and Duval Street. Sergeant Sea succumbed to gunshot wounds he sustained while attempting to make an arrest. The suspect pulled a gun on the officer during the attempted arrest and fired several times striking Sergeant Sea.

# Officer Napoleon B. Harvey

Officer Harvey was killed in an automobile accident in the line of duty. Officer Harvey's patrol vehicle suffered a blowout causing it to go out of control. During the blowout, Officer Harvey was pursuing a speeding vehicle. The blowout caused Officer Harvey's vehicle to flip approximately 15 times, according to witnesses.

Officer Harvey had served with the Jacksonville Police Department for three years and was survived by his wife.

# Officer Thomas A. Robinson, Jr.

Officer Robinson was shot and killed by fugitives wanted by the FBI. One of the suspects was shot and killed while being taken into custody. The second suspect was convicted of Officer Robinson's murder and executed.

Officer Robinson had served with the agency for 3 years. He was survived by his wife and two sons.

# Officer Robert Quincy Tucker

## Jacksonville Police Department



### Incident Details

**Cause of Death:** Gunfire

**Date of Incident:** December 24, 1952

**Location of Incident:** 700 Liberty Street

**Weapon Used:** Firearm

**Suspect Info:** Unknown, executed in 1955

Officer Tucker was shot and killed while transporting a man to jail who was arrested for motor vehicle theft. The suspect suddenly produced a gun from beneath his shirt and shot the officer, killing him instantly. Another officer who was following Officer Tucker subdued the suspect when he fled from the patrol car and tried to get in another car that was stopped at a traffic light.

The suspect was convicted of both murders and executed in the electric chair on June 14, 1948.

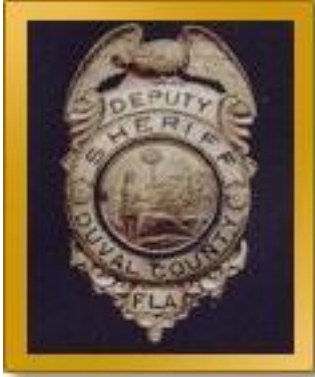

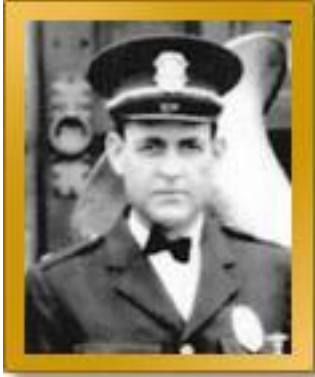

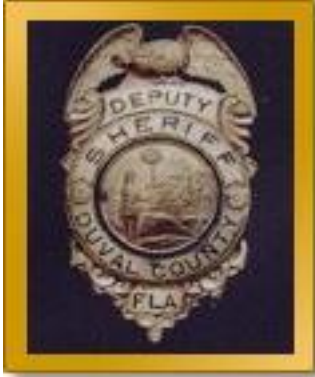

At about 3:15 pm Officer Kelly returned to a brothel on Cedar Street to make additional arrests after arresting a male and a female at the location. He had called for transportation from a nearby call box for the two he's arrested.

Upon returning to the house, he told the woman running the house to get ready to go downtown along with some men on the porch he was also arresting. As he stood in the doorway, he was shot by someone he hadn't seen from a back room. As he tried to exit, he was shot twice more. He flagged down a passing car and despite the gun battle, the two men in the car stopped and picked up Officer Kelly and took him to St. Luke's Hospital. Both men were also seriously wounded. Officer Kelly died from his wounds two days later at 10:00 am.

The shooter fled and was captured in New York City on May 7th, 1925. He was returned to Florida, tried, found guilty of first degree murder, and sentenced to be executed. No record exists of whether he was executed.

Officer Kelly was survived by his expectant wife, daughter, father, two brothers, and sister.

# Officer Henry A. Everett

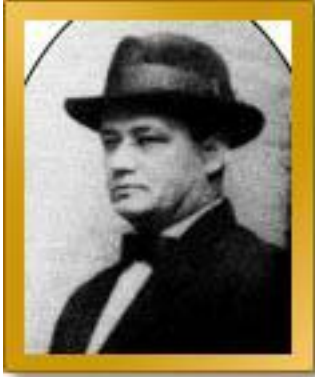

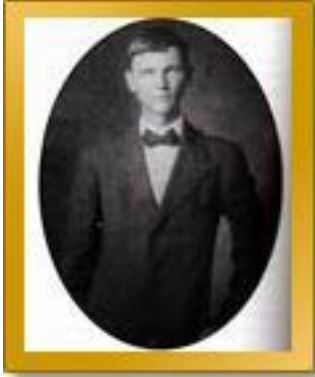
The suspect was arrested, convicted of Officer Hagan's murder, and hung in 1917.

Officer Henderson was taken to St. Luke's Hospital where he succumbed to his injuries two weeks later. The suspect was tried for Officer Henderson's murder but was acquitted.

Officer Henderson had only been with the agency for 2 weeks and was survived by his mother and seven brothers.

Officer Hires was a U.S. Army veteran and had been with the Jacksonville Police Department for 10 months. He was survived by his father, two brothers, and sister.

# Officer Henry H. Raley

The two deputies approached the man and each deputy grabbed one of his arms. The man pulled away from the two deputies, produced a gun, and shot Deputy Sadler in the heart. Although mortally wounded, Deputy Sadler was able to return fire as the suspect fled.

As Deputy Jenkins fired at the suspect, the man's brother came up from behind and shot him in the back. The second suspect then joined his brother in running from the scene. Deputy Jenkins succumbed to his wounds three weeks later.

An off duty Cincinnati, Ohio, police officer, who was on vacation, witnessed the shooting. The officer obtained a shotgun from his room and shot one of the suspects in the back of the head, wounding him. The officer turned the wounded suspect over to two deputies and then formed a posse in search of the other suspect.

Both suspects were convicted of murder and sentenced to death. One was hung on April 4, 1902, and the other was hung on August 7, 1903.

Deputy Sadler was survived by his wife, three daughters, and two sons.

As Deputy Jenkins fired at the suspect, the man's brother came up from behind and shot him in the back. The second suspect then joined his brother in running from the scene. Deputy Jenkins succumbed to his wounds three weeks later.

An off duty Cincinnati, Ohio, police officer, who was on vacation, witnessed the shooting. The officer obtained a shotgun from his room and shot one of the suspects in the back of the head, wounding him. It has been said that Officer Gruber was investigating a homicide at the time of his death. Additionally, due to his witness account that was forthcoming in court, he may have been killed by an individual involved in the homicide.

Officer Gruber's assailant was never found.

# Officer Ed Minor

He was able to walk out of the barn where he layed down and succumbed to the wound.

The suspect was arrested and hung three months later.

Officer Minor had been with the agency for 1 year and was survived by his mother, four brothers, and sister.

# Officer Carlton Lowe

Officer Lowe made the customer leave the store. The man left but turned around about one block away. He asked the officer what his badge number was. When Officer Lowe opened his coat to show him, the man took a step back, pulled out a handgun, and shot Officer Lowe in the chest. Officer Lowe struck the man in the head with his club and was then shot two more times.

Officer Lowe had been with the agency for 8 years and was survived by his wife and 5-month-old daughter.

# Officer Joe Nelson

**Location of Incident:** E. Bay Street near Hogan's Creek

**Weapon Used:** Firearm

**Suspect Info:** Ben Byrd, executed

On June 23, 1880, a labor disturbance broke out at Alsop & Clark's mill on East Bay Street near Hogan's creek, among the workers who demanded shorter hours of work. That night, five extra policemen were sworn in and sent to the mill to protect the property from firebugs, and on the 25<sup>th</sup>, two more were added. On the 26<sup>th</sup>, Joe Nelson, a policeman, was killed by Ben Byrd, one of the strikers, and the situation assumed a serious aspect. Following the shooting of Nelson, W.C. Cooper, captain of the city police, and John Keefe, a patrolman, went on duty at the mill. They remained all night. Early the next morning, a mob began to mass at the bridge farther up Bay Street. Keefe saw Captain Cooper advancing alone toward the mob and at once determined to share the danger with him. Upon the approach of the two officers, the mob fell back from the bridge and took shelter in the weeds behind the slab piles. The moment the officers reached the bridge, the mob opened fire upon the officers with pistols, rifles and shotguns. One of the mob had a Spencer rifle, but the man had his sights too high and the bullets went over the officer's heads. Keefe saw a man drop to one knee and let drive both barrels of a shotgun at him. Half a dozen buckshot struck his shirt aslant, made black dints in it and glanced off; however, two buckshot pellets penetrated the flesh and came out two or three inches beyond. The charge of buckshot spun Keefe around and burnt him like fire, but he charged on the man with the shotgun, knocked him down with his club and carried him to jail where he was sentenced to five years. The mob fled before the advancing officers. There was no more bloodshed and quiet was restored and the mob went back to work on June 30<sup>th</sup>.

Ben Byrd, who shot the officer, was hanged.

# Officer William Johnson

Officer Johnson had been with the agency for seven years and was survived by his wife.

# Officer Ignatio Andrea

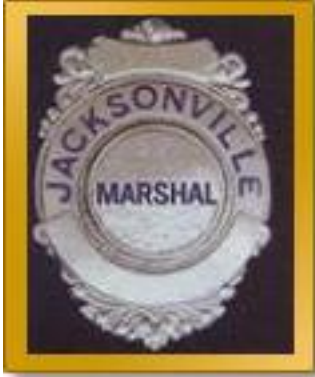

Jacksonville's first law enforcement officer to die in the line of duty was named Yeomans, whom it believed was the next to succeed Daniel Hart in the post of Town Marshal. His first names and the exact date of his death in 1841 have been lost in the mist of time, but details of the incident remain.

T. Frederick Davis gives this account, "Two men from Tallahassee came to Jacksonville to paint the town red. They put a beam under the market building and turned it over on its side, then started for a high time in general." Davis goes on to say that Town Marshall Yeomans armed himself and went in search of the two men, whose names were McMullen and Bryant.

Sadly for Marshal Yeomans, the two rowdies found him first, standing in the doorway of a billiard room, and shot him down with buckshot without warning. A courageous citizen named Huffman rushed to Yeomans aid and was also shot by the men. Yeomans died but Huffman recovered. Both suspect escaped, one by switching his clothes with his mother while awaiting trial in the jail in Tallahassee for the Jacksonville murder. Yeomans' killers went unpunished.
