## AMENDMENT NUMBER FOUR TO CONTRACT BETWEEN THE CITY OF JACKSONVILLE AND UNITED SERVICE CONNECTION, INC. FOR

COUNTYWIDE CONCRETE MAINTENANCE/CONSTRUCTION - SOUTH AREA

THIS AMENDMENT NUMBER FOUR to Agreement is made and entered into this \_\_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 2014 (hereinafter the "Effective Date"), by and between the CITY OF JACKSONVILLE, FLORIDA (hereinafter sometimes the "Owner" or the "City"), a municipal corporation in Duval County, Florida, and UNITED SERVICE CONNECTION, INC., a Florida profit corporation with offices located at 11250-15 Old St. Augustine Road, #376, Jacksonville, Florida 32257 (hereinafter the "Contractor"), for county-wide concrete maintenance and construction in the South Area (hereinafter the "Project").

## **RECITALS:**

WHEREAS, on November 10, 2011, City and Contractor made and entered into City of Jacksonville Contract No. 8877-10 (hereinafter the "Agreement"); and

WHEREAS, said Agreement has been amended three (3) times previously; and

WHEREAS, said Agreement should be amended by increasing the maximum indebtedness by \$100,000.00 to a new total amount not-to-exceed \$1,649,060.00, with all other provisions, terms, and conditions of said Agreement remaining unchanged; now therefore

IN CONSIDERATION of the Agreement and of the mutual covenants and promises hereinafter contained, the parties agree as follows:

- 1. The above-stated recitals are accurate, true, and correct and are incorporated herein and made a part hereof by this reference.
- 2. Section 2 of said Agreement is amended, in part, by increasing the maximum indebtedness by \$100,000.00 to a new total amount not-to-exceed \$1,649,060.00, and as amended shall read as follows:

"2. The Contractor will, at its own cost and expense, do the work required to be done on said Project and, if asked by the City, furnish the materials required to be furnished on said Project in accordance with plans and specifications prepared by the City of Jacksonville, Department of Public Works, Right-of-Way and Ground Maintenance Division, entitled SPECIFICATIONS FOR COUNTYWIDE CONCRETE MAINTENANCE AND CONSTRUCTION-SOUTH AREA, City of Jacksonville Bid Number JCF-0131-11, Bid Date August 24, 2011, and strictly in accordance with the advertisement calling for bids, plans, specifications, blueprints, addenda, requirements of the City of Jacksonville, proposal of the said Contractor, and award therefor, (hereinafter collectively called the "Contract Documents"), now on file in the Office of the Division Chief of the Procurement Division of the City of Jacksonville and attached hereto, all of which are hereby specifically made a part hereof and incorporated herein by this reference to the same extent as if fully set out herein, for a total amount not-to-exceed ONE MILLION SIX HUNDRED FORTY-NINE THOUSAND SIXTY AND 00/100 USD (\$1,649,060.00) (hereinafter referred to as the "Contract Price"), for the Project, at and for the prices and on the terms contained in the Contract Documents. The City does not guarantee how much work, if any, will be requested under this Contract. Therefore, the City's maximum indebtedness under this Contract shall be ZERO USD (\$0.00). The above specified Contract Price shall not be encumbered by this Contract. Any such encumbrance[s] shall be perfected by subsequent purchase order[s] referencing and incorporating the terms and conditions of this Contract, and such purchase order[s] shall be binding upon the parties hereto. All availability of funding checks will be made at the time such purchase order[s] are executed."

**SAVE AND EXCEPT** as expressly amended in this instrument, the provisions, terms, and conditions of said Agreement of November 10, 2011, as amended, shall remain unchanged and shall continue in full force and effect.
