FIRST AMENDMENT TO CONTRACT BETWEEN THE CITY OF JACKSONVILLE AND R.J. TRIPP d/b/a J.L. TRIPP BUILDERS FOR

PLAYGROUND RENOVATIONS AT JOHNNIE WALKER PARK

THIS FIRST AMENDMENT to Contract is executed as of this day of March, 2014, by and between the CITY OF JACKSONVILLE, a municipal corporation in Duval County, Florida with an address at 117 West Duval Street, Jacksonville, Florida 32202 (hereinafter the "City"), and R. J. TRIPP, INC. d/b/a J. L. Tripp Builders, a Florida corporation with its principal office at 2055 Edgewood Avenue West, Jacksonville, Florida 32208 (hereinafter the "Contractor").

WHEREAS, on July 25, 2013, City and Contractor made and entered into City of Jacksonville Contract No. 9586-08 (hereinafter the "Contract"); and

WHEREAS, said Contract has not been amended previously; and

WHEREAS, said Contract should be amended by providing an additional \$3,000.00 for the Johnnie Walker Park improvement project so as to increase the maximum indebtedness to the City to a not-to-exceed cumulative maximum indebtedness of \$57,750.00, with all other provisions, terms, and conditions of said Contract remaining unchanged; now therefore

IN CONSIDERATION of the Contract and of the mutual covenants hereinafter contained and for other good and valuable consideration admitted by the parties to be legally sufficient, the parties agree to amend said Contract as follows:

- 1. The above-stated recitals are accurate, true, and correct and are incorporated herein and made a part hereof by this reference.
- 2. Section 2 of said Contract is amended in part by providing an additional \$3,000.00 for the Johnnie Walker Park improvement project so as to increase the maximum indebtedness to the City to a not-to-exceed cumulative maximum indebtedness of \$57,750.00,

of which are hereby specifically made a part hereof by reference to the same extent as if

fully set out herein for the total base bid amount of FIFTY-SEVEN THOUSAND

SEVEN HUNDRED FIFTY AND 00/100 DOLLARS (\$57,750.00), at and for the prices

and on the terms contained in the Contract Documents."

SAVE AND EXCEPT as expressly amended in and by this instrument, the provisions,

terms, and conditions of said Contract of July 25, 2013, shall remain unchanged and shall

continue in full force and effect.
