# Inspector General Selection and Retention Committee Meeting Minutes June 24, 2019, 3:30 PM

*Call to Order:* The Honorable Aaron Bowman called the meeting to order at 3:32 PM.

**Pledge of Allegiance:** Bowman opened with the Pledge of Allegiance.

#### I. Old Business

## A. Approval of May 22, 2019 Meeting Minutes

Bowman asked the Inspector General Selection and Retention Committee (Committee) if there were any questions or corrections to the May 22, 2019 minutes. No corrections were noted.

Sam Mousa motioned to approve the May 22, 2019 meeting minutes as circulated. Joseph Rogan seconded. **Motion Carried.** 

#### II. New Business

#### A. Public comments on action items.

There were no public comments.

### **B.** Inspector General Performance Evaluation

IG Green explained the process for the evaluation. Rogan asked if the policies referenced in Core Competency 3 are internal policies. IG Green responded that we are in the process of updating internal policies to adhere to current accreditation standards. Julie Taylor asked about the reason for the accreditation extension listed under Core Competency 1, Measure 3, found on page 4 of the Inspector General Annual Performance Evaluation. IG Green responded that we are extending the time for accreditation due to the changes in the IG position. Taylor also asked about the overall number of complaints closed. IG Green explained that information regarding intakes and other data is included in the six-month update handout. In fiscal year 2019, as of March 31, 2019, the OIG received 46 complaints and closed 28 of those.

Bowman asked for any additional questions. There were none, so the Committee proceeded to complete the evaluation form. Bowman asked each member to state their name and read their total score:

Bowman commented that this is the first IG evaluation. He stated that he considers anything above 3 to be commendable. He personally thanked IG Green for her work. IG Green thanked the committee and emphasized her passion for the position.

Part 4 of the Performance Evaluation included a salary discussion, as the Committee recommends salary increases for the IG. Mousa asked IG Green if her contract states that she receives the same 4.5% general salary increase as all City of Jacksonville employees. IG Green stated it does. Mousa made a motion that the IG should receive the 4.5% salary increase, effective October 1, 2019. The motion was seconded by Rogan. **Motion Carried**.
