

## LAND CLASSIFICATIONS

**CLASS A:** Noise Sensitive areas:  
Churches, Doctor's Office,  
Schools, Hospitals, Libraries

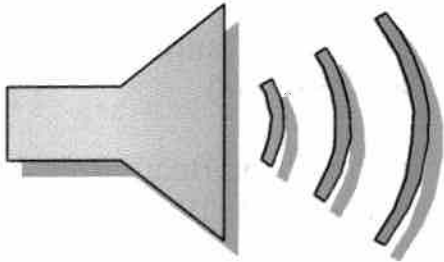
**CLASS B:** Any established living area:  
Residential, Townhouses

**CLASS C:** Commercial: Retail

**CLASS D:** Industrial Operations:  
Manufacturing, Processing

### **Rule 4.103 D states**

Noise measurements will be established on the property line of the complainant or at any public right of way or public land, but in no case shall the distance from the point of measurement to the actual source be less than ten (10) feet.



## GENERAL PROHIBITIONS

See **Rule 4** for complete standards, including Octave Band frequency standards.

### **Rule 4.202 through Rule 4.205 states:**

No person shall cause, allow, or permit the emission of sound from any property-line-noise-source which exceeds the level in the following table:

**Rule 4.207 A:** No operation of construction — maintenance equipment excluding generators, mudhogs, and well point pumps and golf course landscaping equipment during nighttime hours. Generators, mudhogs and well point pumps and golf course landscaping equipment used during nighttime hours shall not exceed 60 dB(A).

**Rule 4.207 B:** No construction or maintenance during daytime hours that emits a noise which exceeds 65 dB (A) when measured at complainant's Class A or Class B property line.

**Rule 4.208 A:** No person shall operate any alarm, siren or whistle for a period exceeding fifteen minutes or that exceeds 60 dB (A) at the complainant's property line

**Rule 4.208 C:** No motor driven boat operation that emits a sound at complainant's property that exceeds 75 dB (A) daytime hours, or 55 dB (A) during nighttime hours.

**Rule 4.208 D:** No person shall operate or permit the operation of powered model vehicles in a public or private space within 100 meters of Class A or Class B land.

**Rule 4.208 E:** No operation of motorized unit (i.e. lawn care equipment, chain saw, boat motor, etc.) in Class B areas between 9:00 P.M. and 7:00 A.M.

**Rule 4.209:** No operation of trash or refuse service using a mechanical device for unloading a bin or hopper into a truck between the hours of 10:00 P.M. and 7:00 A.M., with 200 meters of a Class A or Class B land area.

**Rule 4.211:** No person shall operate or permit the operation of any AC, air handling or refrigeration equipment that exceeds noise standards. (See Rule 4)

**Rule 4.213:** Operation of leaf or trash blowers between the hours of 9:00 P.M. and 7:00 A.M. is "prohibited".

JEPB Rule 4 Day / Nighttime Hours as follows:  
Daytime Hours: 7:00 A.M. - 10:00 P.M.  
Nighttime Hours: 10:00 P.M. - 7:00 A.M.
