
Beaver Street Veterans Villas Permanent Housing

\$426,507 was committed to improve a vacant, threestory historical building located at the Northwest corner of Beaver and Broad Streets.

These funds provided 16 permanent housing units for homeless veterans in addition to commercial and program space.











Jordan Park, City of Atlantic Beach

• \$118,760.020 CDBG Funds were used to purchase and install ADA accessible playground equipment which included a ramp, sun shade, and spinning play unit.







Foster Grandparent Program Parks, Recreation and Community Services Department

• \$31,000 in funds were used to pay stipends to 18 low and moderate income Foster Grandparents who function as tutors and mentors to 600 low/mod youth with academic and emotional difficulties.







Housing Opportunities for Persons With AIDS

The HOPWA grant assisted approximately 1,839 HIV/AIDS infected persons residing in the Jacksonville Metro area through case management, rent/mortgage, utility assistance and supportive services/counseling.

- <u>HOUSING ASSISTANCE</u> 1,687 persons received financial assistance for rent/mortgage and utility assistance through Catholic Charities, Lutheran Social Services and Northeast Florida AIDS Network.
- <u>SUPPORTIVE SERVICES/COUNSELING</u> 71 persons received mental health and substance abuse counseling through River Region Human Services and Gateway Community Services
- <u>CASE MANAGEMENT</u> 1,839 persons received case management services through the HOPWA program.

Emergency Solutions Grant

- ESG Assisted*
 - 51,207 shelter nights for 647 single men in the men's dorms
 - 23,471 shelter nights for 259 single women in the women's dorms
 - 41,126 shelter nights for 102 families with 118 adults and 309 children in the family dorms.
- A total of 561,212 meals were served
- A total of 15,005 primary care visits were provided for 3,833 patients
- A total of 4,996 visits were provided for 1,993 dental care patients
- A total of 3,477 mental health visits were provided for 833 patients
- Under case management, 310 residents obtained stable employment and 584 obtained stable housing
- The Salvation Army also served 82,964 meals to 1,604 unduplicated persons.
- Catholic Charities Bureau provided homeless prevention and rapid re-housing financial assistance to 96 persons.

Client Marcos' Story:

"I lost my wife...she was everything to me. In that same week I lost my apartment and my car. I didn't want to go on and ended up in the hospital. They found all of these other problems. When it was time to let me out, I had nowhere to go. So they got me into Respite at Sulzbacher and they did everything for me. They helped me get well...they cured my hepatitis C...I saw the psychiatrist and the counselor. They helped me file for my disability benefits. Sulzbacher, and all of the people that support them—all of those people—they're everything. They helped me get my apartment. I didn't think I'd ever feel good again. They did that. They did that for me. I could never thank them enough for everything they did."

Client Bobby's Story

The Sulzbacher Center provides clients with a holistic approach to care. Bobby was broke and battling cancer. In his own words, "The cancer was hard. But I think the rats were just as hard. I was unable to work because of my cancer. And because I didn't' have enough insurance, it wasn't long before I was broke...and living in a shed that was little more than a filthy, roach-infested, rat-filled lean-to. I hung my bread from the ceiling so the rats wouldn't get to it during the day while I was out. And I would cover myself with traps so they wouldn't get to me at night. It wasn't always like this. I used to earn about \$50,000 a year as a mechanic. But

It wasn't always like this. I used to earn about \$50,000 a year as a mechanic. But when I got esophageal cancer, everything went downhill fast. I couldn't eat much because I couldn't swallow. The radiation ruined my teeth, so I couldn't chew. My weight dropped from 160 pounds to about 90. I couldn't do the hard work of a mechanic any more. I lost everything. And I lived with rats and roaches. It got to the point where I didn't care if I lived or not.

Then I heard about Sulzbacher and its Medical Center, which offers services on a sliding fee discount and turns no one away. I don't know what I would've done without their help. I might have died. But I ended up living at Sulzbacher and getting all that care...and plenty of good food. I've put on 30 pounds, and I feel better than I have in years. My cancer is in remission, and I'm now planning to go out and live independently again. It's like when I got to Sulzbacher, all the right people were in the right place – the doctors, the staff, caseworker...I mean everything. And I'm so thankful. Thank you for making that happen!"
