Urban Core Citizens Planning Advisory Committee February 5, 2024, Meeting Summary

Prior to the start of the Urban Core CPAC meeting, Charles Garrison, Chair of the City of Jacksonville Planning Commission, introduced himself. He indicated that he plans to attend all the CPAC meetings. Mr. Garrison asked that when the CPAC registers opposition to a specific project, the effort be made to work with staff and the assigned planner, to offer "competent substantial evidence" for the opposition. He concluded his comments by commending the CPAC for the good work being done and reiterated that he just wants to make sure that the Planning Commission has the best information possible when making decisions. Meeting Summary

- **1. Call to Order/Verify Quorum**: Chair Shumaker called the meeting to order at 5:32 p.m. Edwina Henry verified a quorum was present.
- **2. Approval of Previous Meeting Summary:** CPAC Members approved the January 17, 2024, Meeting Summary.
- **3. Presenter:** Kathleen Collins, Capital Improvement Plan Administrator, City of Jacksonville Ms. Collins gave a brief overview of the Capital Improvement Plan (CIP) process. Pursuant to Section 122.604 of the City of Jacksonville's Municipal Code," input from each of the six (6) Citizen Planning Advisory Committees (CPACs) shall be requested and considered when developing the proposed Capital improvement Plan."

Basic components of the Capital Improvement Plan (CIP):

- The CIP is a five-year plan: FY2025-2029
- Projects must be feasible in nature
- Projects must have funding
- The CIP is approved as part of the mayor's proposed budget
- City Council approval is required each year
 - o To ensure funding is still available
 - Maintain priorities
 - Make adjustments as needed

CIP Requirements:

- Project must have a total cost of greater than \$100,000 and a useful life of more than ten years
- Project must be a one-time outlay non-recuring costs
- Project must enhance or add to the value of the city's physical assets
- Project must be a major equipment purchase, associated with a capital improvement plan

Ms. Collins also discussed the types of projects that would be excluded, such as operating costs. She also shared an electronic copy of the CIP Scoring Matrix to act as a guide for CPACs when developing their project lists. It was noted that the CPACs were involved in the CIP process much earlier this year. This will allow her office to respond quickly to CPACs about projects that may already be in the CIP or if a project needs to be revised and resubmitted.

City Council will receive a monthly report, starting in June for all CIP projects. Ms. Collins indicated that she could also make this information available to the CPAC. Final approvals are completed in September. To address one of the concerns raised by the CPAC, Ms. Collins stated that she will respond to each CPAC regarding their submissions, letting them know if they have been accepted or rolled into a larger project. CPAC members lamented that in the past they have not received any feedback on projects that were submitted.

Chair Shumaker thanked Ms. Collins for her very informative presentation and indicated that obtaining feedback on submitted projects will be most helpful. He also said that he looks forward to working together on the CIP.

- **4. Elected Officials Report:** The Honorable Darryl Willie, Schoolboard Member, Duval County Public Schools, gave the following report:
 - February is Black History Month, and the Duval County Public School District is one of 11 school
 districts that has exemplary status when it comes to supporting African American history and
 curriculum. He noted that the school district believes in exposing students to all cultures and
 the rich history in Jacksonville.
 - School Showcases were held over the past two weekends for elementary, middle, and high schools. The schools were opened to the community, and not just parents exploring school options for their children. The School Showcases resulted in an increase in the number of community members signing up to volunteer and support individual schools.
 - Mayor Deegan launched her River City Readers initiative which supports literacy, and the school board is fully supportive of this effort. Mr. Willie also gave kudos to the teachers for incorporating technology into the classroom.
 - Graduation rates are at a record high at 87.2 percent, over the past 10 years, which is up over 10 points. He took a moment to commend Dr. Kriznar, Interim Superintendent, along with the teachers and staff, for putting in the hard work each day.

- Dr. Kriznar is planning to retire, so the school board needs a long-term plan in place for filling the Superintendent's position. Having recently met with their consultant, the board will be announcing the new hiring timeline soon and wants the community to know that their input is needed.
- Duval County Public School District has seen a decline in student enrollment. Fewer students mean fewer dollars, and this is causing the district to re-examine the master facilities plan to ensure that funds are being used in the most efficient manner. The board will be providing the community with a status update on the master facilities plan.
- The school board is considering three (3) relocation options with respect to selling the school board building: (1) JTA has a building in LaVilla, near the new JTA facility; (2) Florida Blue has a building in Riverside that it could lease to the district; and (3) the school board could remain in its current location. Mr. Willie reminded everyone that the school board building was put out to bid before COVID, when it seemed very lucrative to move. However, post-COVID, the economics aren't very favorable. The school board must carefully weigh their options to ensure that taxpayer dollars are spent in the most efficient way. The board will try to decide by the end of February 2024, which option to take.
- **5. Chair's Report:** Chair Shumaker began his report with an update on December's outreach efforts to organizations within the Urban Core, District 1, to help build the CPAC membership and to be able to provide more feedback into the communities. Several of the new organizations have applied for CPAC Membership and were invited to introduce themselves:
 - Marilyn McGee, representing First United Methodist Church, 225 East Duval Street, 32202. Ms. McGee stated that the church wants to be a part of the community and indicated that their main concern is the blight around the church and how it affects the membership and activities. The church has donated one of its 100-year-old buildings to help relieve the problem of foster care children who "age out" and have no place to go. Working with other community partners, they hope to be able to send some of these young people to college and/or trade school. Their program is called the "Pillars Foundation." She invited the CPAC to come visit and take the tour.
 - Kelly Frazier, President of Northside Coalition of Jacksonville. Ms. Frazier stated that the coalition is a dynamic organization creating positive and lasting change. Since 2016, they have worked in concert with elected officials, law enforcement, business professionals, faith community and people from all walks of life. A very diverse group with the common focus of improving social, racial, and economic injustices. Attending the CPAC meetings will help her learn more about what's going on in the city and to help her learn ways to make a better impact. Ms. Frazier is the daughter of the late community activist, Ben Frazier.
 - Ariane Randolph, resident of the historic Eastside. Ms. Randolph advocates for the historic Eastside through several organizations and community groups. As a resident, she is interested in making her community better, which will ultimately make the city its best. She is looking forward to working with the other communities in the Urban Core, District 1.

Chair Shumaker recognized Council member Jimmy Peluso and invited him to address the CPAC.

- The Honorable Council member Jimmy Peluso, Council District 7, greeted everyone and thanked the Chair for the opportunity to speak. He announced that the new Planning and Development Director started today and there is also a new Neighborhoods Department Director. Both new hires will be going through the confirmation process with City Council.
- Jacksonville's Historic Eastside has been named to the state's Main Street Program. This
 designation brings with it federal and state dollars for local revitalization and historic

Chair Shumaker stated that the CPAC chairs were invited to the Jacksonville Transit Authority (JTA) to meet with the Chief Executive Officer, Nathaniel Ford. The Jacksonville Transit Authority (JTA) is working on long-term and short-term innovations to improve transit for the Jacksonville area. Chair Shumaker said that based on the presentation, he is looking forward to Jacksonville becoming a much better place, as it pertains to transit, especially the integration between the different types of transit, better sidewalks, bike lanes, etc.

6. Staff Reports:

JEA - Jennell Milton, Government Relations Coordinator, provided an update on two events that JEA will be hosting:

- The Riverview East's proposed Septic Tank Phase Out Project kick-off meeting is Thursday, February 15, 2024, at FSCJ North Campus in the auditorium, starting at 6:30 pm. While focused on Council members Pittman (Council District 10) and Gaffney, Jr.'s (Council district 8) districts, the meeting is an informational public meeting and will provide the opportunity to learn more about the proposed project, and to answer any questions or concerns property owners may have. MCCD – Chris Billings, Code Compliance Supervisor, gave the following report:

- 865 inspections were completed since January 17, 2024.
- On January 30, 2024, MCCD conducted a corridor inspection on Moncrief Road, and 29 individual locations were cited. There are two additional targeted systematic inspections scheduled:
 - o The Berkeley Neighborhood will begin February 13, 2024
 - o The 29th & Chase Neighborhood will begin March 5, 2024
- The goals of these projects are to ensure uniform enforcement and promote property values equally through the neighborhoods.
- MCCD has realigned its neighborhood boundaries with the actual Urban Core CPAC boundaries, so now neighborhoods in Southbank and Brentwood will come to Urban Core CPAC to have their problems addressed instead of going to separate CPACs.

- Marlo Zarka, Blue Zones Project February 19, 2024, is the grand opening of their headquarters, located at 232 East Eighth Street, from 5 pm until 7 pm. The location has office and community space and there are also plans for a community garden.
- **Ernest Smith, Visitor** For the record, Mr. Smith wants it to be known that for the last two Urban Core CPAC Meetings, there has not been a JSO Representative present. For emphasis, Mr. Smith stated that Executive Order 2014-03 obligates JSO to be in attendance to answer questions about crime and statistics in our community.
- **Kim Pryor, Preservation SOS** Ms. Pryor would like to request that the back doors be available for attendees to enter as well as exit. Currently, entry is only from the Laura Street doors, which means after the CPAC meeting is over, attendees have to walk around to the front of the building, in the dark to get to their cars.

- Council member Jimmy Peluso The Jacksonville City Council has created a special committee
 on Homelessness and has been charged with creating a Homeless Trust Fund. Jacksonville is
 looking to emulate the Miami Dade model, as they seem to be doing a really good job; however,
 the funding source remains the real issue where to find the money to put into the Trust. The
 legislation has been written to create the Trust and will continue to move through the legislative
 process.
 - Peluso stated that he has been in communication with the Springfield community and the Historical Preservation community and has been working on legislation to change the name from Confederate Street (of which no property actually has the name of Confederate Street as it's listed name) to Ben Frazier Street.
 - o He also noted that Confederate Park's name is also being changed to Ben Frazier Park.
