- 3. Elected Officials' Reports: Brooks Dame, Executive Assistant to Council Member Randy DeFoor, District 14, reported that the redistricting map is ongoing, and nothing has been finalized. The city is in litigation regarding a plaintiff's suggested council redistricting map. - 4. Presentation: Marlo Zarka, Blue Zones Jacksonville Public Policy Lead, presented on the Blue Zones Jacksonville Project. Blue Zones Project is a community well-being improvement initiative designed to change the way people experience the world around them. Because healthier environments naturally nudge people toward healthier choices, Blue Zones Project focuses on influencing the Life Radius® the area close to home in which people spend 90 percent of their lives. Blue Zones Project best practices use people, places, and policy as levers to transform those surroundings. Our communities have populations with greater well-being, improved health outcomes, reduced costs, and increased civic pride, all of which support healthy economic development. - Municipal Code Compliance Division (MCCD) Michael Hoffman, MCC Supervisor, reported that:
 - A total of 1,350 inspections were completed.
 - Blight signs are illegal, and MCC focuses its enforcement efforts of unlawful signs on identifying and penalizing individuals or businesses responsible for placing signs in public spaces and city right-of-way. Fines range from \$50 to \$500.
 - The Jacksonville Assistance and Relief Program (JAR) is still available for those who need abatement services due to disability or economic disadvantage. To determine if you qualify for the JAR program, visit MCC Jacksonville Assistance and Relief Program for more information.
 - It is required to provide a name and address when reporting an issue using the MyJax app or (904) 630-CITY (2489). Additional information that is helpful to the MCC officers is a contact number, email, a description of the violation, and where and when it is observable.

- Parks, Recreation, and Community Programming Dan Piastuck, Parks District Manager, provided an update on renovations included in the Parks, Recreation and Community Services Department's 2023 Plan.
 - The Murray Hill Playground and Community Club Park equipment replacements were completed early.

- In addition to the playground equipment being replaced at Argyle Forest Park and Crystal Springs Park, restroom improvements have been added to these projects.
- Boone Park's tennis complex has received a complete court renovation, which included 14 tennis courts and four new pickleball courts. Funding is available to renovate the building and add new bathrooms, a new lobby, and a new sitting area. The renovation will begin in late spring or early summer and should not impact programming.

 - Ordinance 2023-0224 Rezoning to a PUD –12250 Normandy Blvd.: The application seeks to rezone 15+/- acres of property from CCG-1 to PUD to permit 240 multi-family residential units.
