- Transportation Tom Martin reported for the August 7, 2019 North Florida TPO CAC meeting:
 - North Florida TPO CAC approved the CAC membership request for a member representing St.
 Johns County at large, and for a member representing Nassau County.
 - North Florida TPO CAC approved the Long Range Transportation Plan (LRTP) Performance
 Measures document titled: Path Forward 2045 Technical Report: Goals, Objectives, and Policies.
 The LRTP indicates the transportation improvements necessary for optimal movement of people
 and goods, based on the current needs and forecasted future growth. The recommended
 transportation improvement projects in the plan are guided by defined goals, objective and
 performance measures.
 - North Florida TPO CAC received a presentation by Wiley Page of Atkins on LRTP draft document titled: Needs Plan. This document includes proposed 2045 Roadway and Transit projects.
 - North Florida TPO CAC received a presentation on the Northeast Florida Regional Multi-use Trail
 Master Plan document. This presentation includes highlights from the plan, and the document will
 be included in the LRTP: Path Forward 2045.

 Contractors are allowing the grass to over grow along the road of the vacant home. The
 contractors are also pushing dirt into the retention ponds. He asked if MCCD will handle the
 problem with the grass and the dirt being pushed into a retention pond. Senior Code Compliance
 Officer Ernest Murphy said that MCCD can take care of or cite the contractors for the issue with
 the grass. Mr. Murphy asked to speak with Mr. Fonferek after the meeting regarding the dumping
 of dirt into the retention pond.
